NOTICE OF OPPOSITION

Kenzo (“Opposer”), through its attorneys, believing it will be damaged by registration of the mark CENZO for “leather travel bags; leather luggage; handbags; wallets; luggage; briefcases” as shown in Application Serial No. 77710178, opposes this application pursuant to 37 C.F.R. § 2.104(b).

As grounds for its opposition, Opposer alleges that, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

Opposer and Its KENZO Mark and Name

1. Opposer Kenzo is a corporation organized and existing under the laws of France and has a business address of 1 Rue du Pont Neuf, Paris, France.
2. Opposer owns the trademark and name KENZO for a wide variety of fashion goods including travel bags, handbags, luggage, wallets, and other leather

and imitation leather goods in Class 18; apparel, headwear and footwear in Class 25; jewelry in Class 14; and sunglasses in Class 9. Opposer has used its KENZO mark and name in commerce in connection with luggage, handbags, and other leather and non-leather goods and accessories since at least as early as 1973.

3. Opposer owns numerous valid and subsisting U.S. trademark registrations for its KENZO mark and name, including the registrations set forth below:

4. The foregoing registrations are valid and subsisting and constitute *prima facie* evidence of the validity of the marks and registrations, of Opposer's ownership and exclusive right to use the marks in commerce, and provide constructive notice of ownership thereof by Opposer.

5. Through its long use of the KENZO marks and names shown above (collectively, the "KENZO Marks"), and substantial advertising and promotion, Opposer has developed valuable goodwill in its KENZO Marks and these marks are strong and well-known.

Applicant and Its Mark

6. Upon information and belief, Floto Imports Inc. ("Applicant"), the listed owner of the subject application, is a New York corporation with an address at Suite 4, 345 West 12th Street, New York, New York 10014.

7. On April 8, 2009, Applicant filed Application Serial No. 77710178 for the mark CENZO for "leather travel bags; leather luggage; handbags; wallets; luggage; briefcases" in Class 18.

8. Applicant's CENZO application was filed on an intent-to-use basis.

Likelihood of Confusion, 15 U.S.C. § 1052(d)

9. Opposer repeats and realleges each and every allegation set forth in Paragraphs 1 through 8.

10. Opposer has used its KENZO Marks in commerce prior to the April 8, 2009 filing date of the subject application, or any first use date that could be alleged therein. Moreover, Opposer's various registrations for the KENZO mark issued well prior to Applicant's filing date.

11. The goods set forth in Applicant's CENZO application are identical and/or closely related to Opposer's products.

12. Applicant's CENZO mark so resembles Opposer's prior used and registered KENZO Marks in appearance and pronunciation as to be likely, when used in connection with Applicant's goods, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it is being and will be damaged, and will be damaged, by the registration of the mark shown in Application Serial No. 77710178, and requests that the opposition be sustained, and that registration to Applicant be refused.

The opposition filing fee has been submitted electronically. Any deficiency in the fee should be charged to Deposit Account No. 06-0916.
