ANSWER TO NOTICE OF OPPOSITION
AND COUNTERCLAIM TO CANCEL
OPPOSER'S PLEADED REGISTRATION

Arbank.com Limited ("Applicant") hereby answers the allegations in the Notice of Opposition as follows:

1. Applicant admits the allegations in paragraph 1 of the Notice of Opposition.
2. Applicant admits that Registration No. 3,600,184 for ARTBANC is for "financial investment in the field of fine art; financing relating to fine art" with an application date of March 7, 2005. Applicant does not have sufficient information to admit or deny the remaining allegation in paragraph 2 of the Notice of Opposition regarding Opposer's alleged ownership of Registration No. 3,600,184, and therefore denies the allegation.
3. Applicant does not have sufficient information to admit or deny the allegation in paragraph 3 of the Notice of Opposition, and therefore denies the allegations.
4. Applicant does not have sufficient information to admit or deny the allegation in paragraph 4 of the Notice of Opposition, and therefore denies the allegations.
5. Applicant does not have sufficient information to admit or deny the allegation in paragraph 5 of the Notice of Opposition, and therefore denies the allegations.

6. Applicant notes that paragraph 6 in the Notice of Opposition is misnumbered as paragraph "7." In any event, Applicant does not have sufficient information to admit or deny the allegation in paragraph 6 (misnumbered 7) of the Notice of Opposition, and therefore denies the allegations.

7. Applicant notes that paragraph 7 in the Notice of Opposition is misnumbered as paragraph "8." In any event, Applicant denies the allegations in paragraph 7 (misnumbered 8) of the Notice of Opposition.

Counterclaims

Count 1

1. Opposer was formed as a Texas limited partnership on November 12, 2002, as evidenced by the online records of the Texas Secretary of State enclosed as Exhibit 1.
2. Upon information and belief based upon the allegation in paragraph 3 of the Notice of Opposition, and without admitting the truth of the allegation in paragraph 3, Opposer's earliest possible date of use of ARTBANC in which it might claim rights in the United States is January 1, 2002.
3. Upon information and belief, Opposer was not using ARTBANC in any capacity prior to 1999, based upon the fact that Opposer was not formed until November 12, 2002, as evidenced by Exhibit 1.
4. The artbanc.net domain name was registered in 2004, as evidenced by the "Whois" domain name ownership record enclosed as Exhibit 2.
5. The filing date of Opposer's application which became Registration No. 3,600,184 is March 7, 2005.
6. The ARTBANK mark has been used in U.S. commerce for the sale of art since the 1990's, as evidenced by copies of invoices and purchase orders from various U.S. customers, all of which show use prior to March 7, 2005 including as early as 1998, enclosed as Exhibit 3.
7. The artbank.com domain name was registered in 1995, as evidenced by the "Whois" domain name ownership record enclosed as Exhibit 4.
8. The artbank.com website was operational since before Opposer's earliest possible use date of January 1, 2002, as evidenced by the promotional materials dated April, 2000 enclosed as Exhibit 5 and the excerpt from the Wayback Machine Internet archive search tool enclosed as Exhibit 6.

9. The artbank.com website offers art for sale and accepts payment in U.S. dollars, as evidenced by an excerpt of the website enclosed as Exhibit 7.
10. The artbank.com website attracts a substantial percentage of its visitors from the United States, as evidenced by the information from the Google Analytics website enclosed as Exhibit 8.
11. Applicant's U.S. common law rights in ARTBANK for the sale of art predates Opposer's rights in ARTBANC for any goods or services.
12. If there is a likelihood of confusion between ARTBANK and ARTBANC for the parties' respective services as alleged in the Notice of Opposition, Applicant has priority, and Opposer's ARTBANC Registration No. 3,600,184 should be cancelled.

Count 2

13. Section 45 of the Lanham Act provides that a service mark is "used" when the mark "is used or displayed in the sale or advertising of services *and the services are rendered*" in commerce. See, e.g., In re Kronholm, 230 USPQ 136, 137 (TTAB 1986) ("[i]t is clear that a service mark is not eligible for registration until it has been used or displayed in the sale or advertising of services and the services have been rendered in commerce . . . [T]he use of a mark in the announcement of a future service does not constitute use as a service mark. Rather, the use in advertising of a service must be advertising which relates to an existing service which has already been offered to the public"); The Greyhound Corporation, et al. v. Armour Life Insurance Co., 214 USPQ 473, 474 (TTAB 1982) ("it is well settled that advertising of a service, without performance of a service, will not support registration"). As evidenced by the current lack of services offered at the artbanc.net website and Opposer's "countdown" to providing services as demonstrated by a printout of the website enclosed as Exhibit 9, the lack of any proof of use of the ARTBANC mark for any services utilizing the Wayback Machine Internet archive search tool as demonstrated in Exhibit 10, and the fact that Opposer filed its Statement of Use just weeks before the final deadline, at the time Opposer filed its Statement of Use for what became Registration No. 3,600,184 Opposer was promoting but not actually rendering the services identified in Registration No. 3,600,184.
14. Opposer knowingly made a false, material misrepresentation of fact in procuring Registration No. 3,600,184 by signing a Statement of Use claiming use of the ARTBANC mark with the intent to defraud the U.S. Patent and Trademark Office into issuing a registration to which Opposer was not entitled, and Opposer's ARTBANC Registration No. 3,600,184 should be cancelled.

Count 3


15. Opposer is not currently using the ARTBANC mark for the services identified in Registration No. 3,600,184, as evidenced by the lack of any services being currently offered on its website as demonstrated by a printout of its website enclosed as Exhibit 9.

16. Opposer has abandoned use of its ARTBANC mark for the services identified in Registration No. 3,600,184, and Opposer's ARTBANC Registration No. 3,600,184 should be cancelled.

WHEREFORE, Applicant respectfully requests that Opposer's opposition be denied and that, pursuant to Section 14 of the Lanham Act, 15 U.S.C. § 1064, Opposer's Registration No. 3,600,184 be canceled.
