**APPLICANT’S COMBINED MOTION TO SUSPEND PENDING  
OUTCOME OF CIVIL ACTION AND MEMORANDUM IN SUPPORT**

---

Pursuant to 37 CFR § 2.117(a) and TBMP § 510, Applicant Cimarron Lumber and Supply Company (hereinafter "Applicant"), by and through its undersigned counsel, requests that the Board suspend the proceedings in the above-captioned matter pending the disposition of the matter of *Cimarron Lumber and Supply Company v. McLiney Lumber and Supply, LLC, Sutherland Building Material Centers, L.P., Sutherlands West Texas, Inc.; and Sutherland Centennial Lumber Co., LLC.*, Civil Action No. 2:12-CV-02240-JAR-KMH, currently pending before the United States District Court for the District of Kansas (hereinafter the “Civil Action”). Attached as Exhibit 1 is a copy of the Complaint in the Civil Action.

The Civil Action concerns the allegation of likelihood of confusion arising from Opposers’ use of Applicant’s family of SUTHERLANDS formative trademarks, such as SUTHERLAND

LUMBER COMPANY (the mark at issue in this opposition), SUTHERLANDS, SUTHERLANDS CENTRAL, SUTHERLANDS EXPRESS, SUTHERLANDS and SUTHERLANDS PRO and respective registrations therefore (the “Asserted Marks”). In the Civil Action, Applicant seeks both an injunction and an award of damages arising from Opposers’ use of Applicant’s Asserted Marks. As a result, it is highly likely that the Civil Action will be determinative of this opposition proceeding, as the decision of the Court would be binding on the Board. TBMP § 510.02(a). Accordingly, suspension of the above-captioned opposition proceeding pending the outcome of the Civil Action is appropriate. *New Orleans Louisiana Saints LLC v. Who Dat?, Inc.*, 99 U.S.P.Q.2d 1550 (TTAB 2011) (suspending opposition appropriate when decision by district court would have a bearing on opposition proceeding).

The parties have discussed this motion, and Opposer has indicated it does not consent so this motion.

**Complaint**

COMES NOW PLAINTIFF, Cimarron Lumber and Supply Company, for its Complaint against Defendants McLiney Lumber and Supply, LLC, Sutherland Building Material Centers, L.P., Sutherlands West Texas, Inc., and Sutherland Centennial Lumber Co., LLC, and alleges as follows:

**Parties**

1. Plaintiff Cimarron Lumber and Supply Company (“Cimarron” or “Sutherlands”) is a duly formed Missouri general partnership having its principal place of business located at 4000 Main Street, Kansas City, Missouri 64111.

2. Upon information and belief, Defendant McLiney Lumber and Supply, LLC (“McLiney Lumber”) is a Kansas limited liability company with a principal place of business at 5000 West 95<sup>th</sup> Street, Suite 250, Prairie Village, Kansas 66207.

3. Upon information and belief, Defendant Sutherland Building Material Centers, L.P., (“Sutherland Building”) is a Texas limited partnership with a principal place of business at 5000 West 95<sup>th</sup> Street, Suite 250, Prairie Village, Kansas 66207.

4. Upon information and belief, Defendant Sutherlands West Texas, Inc. (“Sutherlands West Texas”) is a Texas corporation with a principal place of business at 5000 West 95<sup>th</sup> Street, Suite 250, Prairie Village, Kansas 66207.

5. Upon information and belief, Defendant Sutherland Centennial Lumber Co., LLC (“Sutherland Centennial”) is a Missouri limited liability company with a principal place of business at 5000 West 95<sup>th</sup> Street, Suite 250, Prairie Village, Kansas 66207.

6. McLiney Lumber, Sutherland Building, Sutherlands West Texas, and Sutherland Centennial shall be collectively referred to herein as “McLiney.”

### **Jurisdiction and Venue**

7. This is an action for trademark infringement, false designation of origin, unfair competition, and cybersquatting arising under the Lanham Act, 15 U.S.C. § 1051 *et seq.*, and the laws of the State of Kansas.

8. This Court has jurisdiction over the subject matter of the complaint pursuant to 15 U.S.C. § 1121; 28 U.S.C. § 1331; 28 U.S.C. § 1338(a), and over the unfair competition cause of action under 28 U.S.C. § 1338(b) and 28 U.S.C. § 1367.

9. Upon information and belief, Defendants are headquartered in this judicial district. Thus, Defendants are subject to this Court’s specific and general personal jurisdiction.

10. Venue is proper in this district pursuant to 28 U.S.C. § 1391(b) and (c) because a substantial part of the events giving rise to the claims stated herein occurred in this judicial district and Defendants are subject to personal jurisdiction in this judicial district.

**Facts Common to All Counts**  
**Cimarron's Background and Trademarks**

11. Almost 100 years ago Robert R. Sutherland founded the first Sutherlands lumber yard operation ("Sutherlands"). Since the establishment of Sutherlands, and up until 2009 as more fully set forth below, the descendants of Robert R. Sutherland have harmoniously operated with each other in a common effort to grow the Kansas City, Missouri based business into one of the largest privately-owned home improvement center chains in the United States. Originally, the second generation of offspring consisting of four brothers and one sister, opened various semi-autonomous Sutherlands stores but operated them in close cooperation with each other. Sutherlands is now principally operated by third and fourth generation descendants of Robert R. Sutherland. Although the various Sutherland descendants have operated separate entities in association with Sutherlands, each has operated in concert to achieve a common end in such a way that they have collectively appeared to the consuming public as one entity. In this manner, each of the separate entities cooperatively directed the operations of what the public perceived as a single corporate entity so that the public would understand Sutherlands is a single entity having a unitary brand.

12. In part to facilitate the operations and maintenance of the single Sutherlands brand, Cimarron was formed in 1947 to be a centralized buyer for all Sutherlands stores. In the ensuing decades the functions of Cimarron in controlling operations of Sutherlands has greatly expanded. Today, Cimarron manages and enforces the Sutherlands brand by virtue of its operations, which include centralized primary sourcing of goods and primary direction of the marketing for the various family stores. In this manner, the various family stores and entities located in the central U.S. receive the same quality goods for ultimate sale to their respective customers and maintain a consistent public image, which has accrued substantial and favorable

goodwill. Thus, since its formation, Cimarron has, through its owners and management, acted as the owner of the Sutherlands brand. The various family stores and related entities have operated uniformly under Cimarron's common quality controls, standards, mandates, sourcing, and marketing with respect to the Sutherlands brand.

13. Each of the various Sutherlands families and related entities, including McLiney, knowingly operated under the quality controls, standards, mandates, sourcing, and marketing of Cimarron. In this manner, each of the various Sutherland families and related entities, including McLiney, acknowledged they were a licensed entity related to the Sutherlands brand, whose primary source of goods, marketing, standards, and quality controls emanated from Cimarron. Indeed, since Cimarron's formation, various trademarks and trademark registrations affiliated with the Sutherlands brand have each been assigned to, or registered in the name of, Cimarron without objection by any Sutherland family or related entity. In this manner, each of the various Sutherland families and related entities, including McLiney, were licensees of the Sutherlands brand, which was maintained, managed, and controlled by Cimarron, such that the substantial favorable goodwill developed in the Sutherlands brand inured to Cimarron's benefit.

14. Sutherlands presently includes 56 stores/lumberyards located throughout 13 states. As Sutherlands has grown, it has developed its brand under Cimarron and used a variety of SUTHERLAND-formative trademarks in association with the Sutherlands brand in relation to retail lumber, building supply, and home improvement goods and services, including, without limitation, SUTHERLANDS®, SUTHERLANDS CENTRAL®, SUTHERLANDS EXPRESS®, SUTHERLANDS PRO®, and SUTHERLAND LUMBER COMPANY™ (the "Sutherland Trademarks").

15. Cimarron owns the Sutherland Trademarks and presently provides centralized buying, distribution, advertising, and marketing services for each of the various licensed and authorized Sutherlands network of stores (“Authorized Stores”). Additionally, Cimarron provides certain management services, including without limitation tax, accounting, human resources, administrative and information technology services, to its Authorized Stores.

16. Cimarron has promoted each of the Authorized Stores’ home, garden, and building supply goods and services through a variety of media. Cimarron has spent substantial time, money, and effort promoting the Authorized Stores in association with the Sutherlands Trademarks in interstate commerce. Cimarron presently owns numerous trademarks that are also registered with the United States Patent and Trademark Office (“Registered Marks”) as summarized in the following table:

17. Each of Cimarron's Registered Marks is presently alive, in good standing, unrevoked, and uncanceled. Moreover, the registrations for SUTHERLANDS CENTRAL® and SUTHERLANDS EXPRESS® are incontestable. The certificates of registration attached as Exhibits A-D constitute prima facie evidence of Cimarron's ownership of each registration, the validity thereof, and Cimarron's exclusive right to use the marks shown therein in connection with the goods and services set forth in each certificate of registration. The Sutherland Trademarks and Registered Marks shall collectively be referred to herein as the "Sutherland Marks."

18. By virtue of sales, advertising, and promotion of the Sutherland Marks by and through the activities of the Authorized Stores, purchasers, potential purchasers, and members of the general public have come to associate the Sutherland Marks with a single source. In this manner the Sutherland Marks symbolize the affection, favorable recognition, and substantial goodwill that is associated therewith. The Sutherland Marks exclusively symbolize a single source and are associated in the general public mind with the valuable goodwill of that source by virtue of each Authorized Store's licensed use of Cimarron's Sutherland Marks. Cimarron, as the single source symbolized by the Sutherland Marks, has acquired extensive trademark rights in the Sutherland Marks throughout the United States, and each Authorized Store's licensed use of Sutherland Marks inures to the benefit of Cimarron.

19. The retail lumber, building supply, and home improvement goods and services provided under the direction and control of Cimarron by virtue of its selection and purchasing of goods and marketing for the various Authorized Stores are of the highest quality. Marketing the goods and services of the Authorized Stores constitutes a substantial and important part of Cimarron's business.

20. Cimarron directs the use of the Sutherland Marks such that the Sutherland Marks actively and prominently appear in each Authorized Stores' advertisements, including, but not limited to, signage, internet websites, print advertising, packaging, business telephone directories, and business cards.

### **Cimarron's Termination of Defendants**

21. The harmonious and cooperative operations of Sutherlands and related entities by the descendants of Robert R. Sutherland partially ended in 2009. In the mid 2000's through early 2007, certain members of one branch of Sutherland descendants, the McLineys, began discussions with certain members of the remaining Sutherland family and Cimarron about the McLiney family's desire to be bought out of or buy out the Sutherland family's interest in the family businesses. These businesses included certain banks and real property jointly owned by certain Sutherland family and/or non-retail Sutherland entities and control of some of the Sutherlands branded retail stores. The parties, however, could not agree on multiple valuation and control issues. In Spring 2008, the McLiney family began to implement their plan to separate. Joel McLiney, a descendant of Robert R. Sutherland, who on information and belief controls the actions of each Defendant, took action to have Cimarron copy and transfer day-to-day store operations information including purchase, sales, and accounts payable data for McLiney's retail stores to a separate office in Stilwell, KS. In Summer 2008, the McLiney family representatives met with Cimarron personnel about switching certain tax services from Cimarron to an outside individual. In early 2009, Joel McLiney, hired personnel for the McLiney's entities and began backing up and replacing certain services Cimarron previously provided for the McLiney's entities in an effort to operate separately. Joel McLiney also wanted complete ownership and control of the Defendants. In May 2009, Sutherland Building filed the

first lawsuit against a related Sutherland entity in Texas. The ongoing disputes led to numerous lawsuits and several years of litigation between McLiney's and Cimarron and/or Sutherland related entities that were only finally resolved by settlement in 2011. The settlement agreement by its express terms did not address the trademark dispute that is the subject of this Complaint.

22. Thus, in 2009 Cimarron terminated McLiney's affiliation with Sutherlands. By such termination McLiney's license to continue to operate under the Sutherlands brand, including its various Sutherland Trademarks, ended.

23. Indeed, in January 2010, representatives of Cimarron became aware that McLiney was trying to open an unauthorized Sutherlands branded store in Topeka, Kansas. Cimarron notified McLiney that Cimarron owned the Sutherlands brand, including the Sutherland Marks, and that McLiney was not authorized to open a Sutherlands branded store in Topeka, Kansas. Subsequently, McLiney did not open a Sutherlands branded store in Topeka, Kansas.

#### **McLiney's Infringing Conduct**

24. Upon information and belief, McLiney owns and/or operates a number of retail stores/lumberyards in Alexandria, Louisiana; Amarillo, Texas; Fort Worth, Texas; Lubbock, Texas; Mineral Wells, Texas; Moberly, Missouri; and Nevada, Missouri. Each of these stores shall be collectively referred to as "McLiney's Stores." McLiney's Stores are direct competitors to Authorized Stores.

25. Prior to 2009, McLiney's Stores were licensed to operate in association with the Sutherland Marks. However, as of 2009, Cimarron, the owner and licensor of the Sutherland Marks, terminated its relationship with McLiney and consequently terminated McLiney's right to use the Sutherland Marks including, but not limited to, in association with McLiney's Stores.

26. Notwithstanding Cimarron's termination of any license McLiney may have had to use the Sutherland Marks, McLiney has continued to use the Sutherland Marks in association with retail lumber, building supply, and home improvement store goods and services and in direct competition with Authorized Stores.

27. Upon information and belief, after receiving notice of termination of their rights by Cimarron, McLiney has continued to advertise McLiney's Stores in association with the Sutherland Marks. For instance, each of McLiney's Stores maintains large "Sutherland[s]" signage on the front of each store. Also, McLiney's Stores disseminate advertising and other marketing material in association with various SUTHERLAND-nominative phrases, including without limitation, SUTHERLANDS, SUTHERLANDS BUILDING MATERIALS WAREHOUSE, SUTHERLANDS THE HOME IMPROVEMENT STORE, SUTHERLANDS HOME IMPROVEMENT WAREHOUSE, MYSUTHERLANDS.COM, and SUTHERLANDS HOME (collectively the "Infringing Marks").

28. In addition, after receiving notice of termination of their rights by Cimarron, McLiney has undertaken various schemes to mislead customers and potential customers into believing McLiney's Stores are still affiliated with Cimarron and Cimarron's Authorized Stores.

29. For instance, following an ice storm that caused power outages in Chickasha, Oklahoma in late January 2010, thousands of Chickasha, Oklahoma residents were left without power for a number of days. Upon information and belief, following the ice storm, McLiney directed representatives of McLiney's Fort Worth, Texas store to Chickasha, Oklahoma to sell portable generators out of a truck bearing one or more Infringing Marks, at which numerous of McLiney's agents falsely represented to customers and potential customers in dire need of generators that they were affiliated with Sutherlands, the Authorized Stores, and Cimarron's

quality goods. After selling a number of generators to the unsuspecting and vulnerable public of Chickasha, Oklahoma, McLiney's agents then returned to Fort Worth, Texas, leaving Cimarron's closest Authorized Store in Lawton, Oklahoma to process one or more returns of McLiney's defective generators from one or more customers who had unknowingly purchased lower quality goods from McLiney. Upon information and belief, McLiney has conducted itself in this manner on a number of occasions following other devastating weather events and has conducted its business in a manner to capitalize on the goodwill associated with the Sutherland Marks.

30. Furthermore, notwithstanding Cimarron's termination of McLiney's rights, McLiney has only recently opened a new store located in Mineral Wells, Texas, which, upon information and belief, like each of the McLiney's Stores, maintains large "Sutherlands" signage and other various marketing information and materials that use various Infringing Marks.

31. In addition, upon information and belief, McLiney owns and/or operates a website accessible at [www.mysutherlands.com](http://www.mysutherlands.com) (the "Website"), which was created on or after June 15, 2010, after Cimarron terminated McLiney's license. A true and accurate printout of webpages from the Website is attached hereto as Exhibit E. The Website prominently uses the Infringing Marks in its domain name and throughout the content of the webpages accessible at the Website. The Website's description metatag broadly describes the Website as follows: "Sutherlands Home Improvement Centers carry everything you need for home repair, lawn & garden needs, storage, farm & ranch, generators and more."

32. Similarly, the Website's keyword metatag identifies the following goods and services for the website: "sutherlands, home, garden, center, store, specials, special, building, doors, windows, storage, roofing, lumber, supply [sic], flooring, tools, appliances, hardware, heating, cooling." The Website only advertises McLiney's Stores and is not affiliated with any

Authorized Stores or with Cimarron. McLiney is not authorized to use any Sutherland Marks in association with McLiney's Stores or the Website.

33. Further, the Website features a "Company Info" page that leads a customer or potential customer to believe McLiney's Stores are still affiliated with Cimarron and the Authorized Stores. Notably, the "Company Info" page on the Website details the history of the Sutherlands business. Nowhere does the "Company Info" page on the Website identify McLiney as no longer affiliated with Cimarron and the Authorized Store. Indeed, while there are only seven McLiney's Stores, the Website states McLiney is affiliated with 18 Sutherlands stores expressly suggesting to the public that they are affiliated with Authorized Stores. Thus, a customer or potential customer visiting the Website and reading the McLiney's "Company Info" page would wrongly believe Defendants are still affiliated with Cimarron and the Authorized Stores.

34. Additionally, upon information and belief, after receiving notice of termination of its rights by Cimarron, McLiney has registered, caused to be registered, and/or used the following domain names, which incorporate the Infringing Marks, or marks confusingly similar to the Sutherland Marks: sutherlandsexpress.com; sutherlands.co; sutherlands.net; buysutherlands.com; mysutherlands.com; sutherlandsinc.com; sutherlandsonline.com; sutherlandsstore.com; sutherlandhomeimprovement.com; sutherlandlbr.com; sutherlandsalexandria.com; sutherlandsamarillo.com; sutherlandsfortworth.com; sutherlandsclubbock.com; sutherlandsmoberly.com; sutherlandsnevada.com; sutherlumber.com; and suthlumber.com (collectively the "Domain Names"). McLiney is not authorized to use any Sutherland Marks in association with any domain name or the Domain Names.

35. Upon information and belief, after receiving notice of termination of its rights by Cimarron, McLiney established, caused to be established, owns and/or operates social media marketing outlets, such as, for instance, twitter and facebook accounts available at [www.twitter.com/mysutherlands](http://www.twitter.com/mysutherlands) and [www.facebook.com/mysutherlands](http://www.facebook.com/mysutherlands), respectively, which each use various Sutherland Marks, to advertise and market retail lumber, building supply, and home improvement store goods and services. McLiney is not authorized to use any Sutherland Marks in association with any social media outlets.

36. In addition, upon information and belief, immediately following the devastating tornado that struck Joplin, Missouri, McLiney undertook paid advertisements with search engines, such as Google, to capitalize on the substantial goodwill associated with Cimarron, the Authorized Stores, and the Sutherland Marks. Despite the fact that Cimarron's authorized Joplin store was only partially damaged by the tornado and open for business to service the immediate needs of the Joplin community, McLiney sought to direct web searches for those in need to their own distant stores. For instance, attached hereto as Exhibit F are true and accurate printouts of "sutherlands joplin" web searches conducted on Google on or about May 27, 2011, which shows paid advertising directing consumers who search for the phrase "sutherlands joplin" to McLiney's Website. Thus, again, although no longer affiliated with Cimarron or the Authorized Stores, McLiney attempted to capitalize on the substantial goodwill in the Sutherland Marks. As a result of McLiney's various internet activities set forth above, a search for Sutherlands on the search engine GOOGLE results in McLiney's Website, "mysutherlands.com" being presented as the second natural result to the query.

37. These actions by McLiney have caused actual confusion in the marketplace among both the consuming public and Cimarron's vendors. On a weekly basis, Cimarron

receives misdirected complaints and inquiries that were intended for McLiney's Stores. Since termination of Cimarron services to McLiney, approximately two hundred consumers have sent emails to Cimarron's website registering complaints about or seeking information regarding McLiney Stores. Furthermore, Cimarron routinely receives invoices from vendors for purchases made by McLiney Stores. These instances of actual confusion demonstrate the harm to Cimarron and consumers created by McLiney's continued use of the Infringing Marks.

**Count 1 – Trademark Infringement**  
**15 U.S.C. § 1114**

38. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

39. Cimarron owns the Registered Marks, which each Authorized Store has licensed and used continuously and consistently for an extended period of time to advertise goods and services relating to retail lumber, building supplies, and home improvement store goods and services. Each Authorized Stores' use of the Registered Marks in interstate commerce has indelibly impressed on the consuming public's minds the impression that the Registered Marks identify a single source as the source of their respective goods and service. Thus, the Registered Marks serve to identify a single source as the source of the goods and services bearing the Registered Marks because the relevant consumers have come to associate the Registered Marks with a single source by virtue of their use by the Authorized Stores, whose licensed use of the Registered Marks inures to Cimarron's benefit.

40. Following Cimarron's termination of McLiney's rights to use any Sutherland Marks, McLiney has continued to use SUTHERLAND-formative trademarks, including the Infringing Marks in direct competition with Authorized Stores, as shown on its storefronts, Website, the Domain Names, social media outlets, and other various marketing and advertising.

41. McLiney's continued use of SUTHERLAND-formative trademarks, including the Infringing Marks, to identify McLiney's goods and services constitutes use of a copy and colorable imitation of Cimarron's Registered Marks, has caused actual confusion, and is likely to continue to cause confusion, mistake, or to deceive the purchasing public into believing that the goods and services of McLiney emanate from the same source of the goods and services previously provided by Cimarron, or that there is some connection, sponsorship, or affiliation between the goods and services of Cimarron and McLiney, all of which are contrary to fact.

42. Cimarron has no control over the nature and quality of the goods and services of McLiney. Any failure, neglect, or default by McLiney in providing goods or services will reflect adversely on Cimarron and its Authorized Stores as the believed source or origin thereof, which will hinder Cimarron's effort to continue to protect the outstanding reputation in the industry associated with the Registered Marks and subject Cimarron to loss of sales and service and the considerable expense to promote its goods and services in association with the Registered Marks, all to the irreparable harm of Cimarron and the Authorized Stores.

43. McLiney's conduct constitutes an infringement of Cimarron's Registered Marks, and is actionable under the provisions of 15 U.S.C. § 1114.

44. Upon information and belief, McLiney has deliberately and willfully infringed the Registered Marks in violation of Section 32 of the Lanham Act, 15 U.S.C. § 1114 and Cimarron has been, and will continue to be, irreparably harmed by such infringement unless this Court enjoins McLiney from continuing infringement pursuant to 15 U.S.C. § 1116.

45. Upon information and belief, McLiney is willfully infringing the Registered Marks. As a result of McLiney's deliberate and willful infringement of Cimarron's Registered

Marks, Cimarron is entitled to damages, McLiney's profits, attorney's fees and costs, and any and all other relief authorized by 15 U.S.C. § 1117.

**Count 2 – Trademark Infringement**  
**15 U.S.C. § 1125**

46. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

47. Cimarron owns the Sutherland Marks, which each Authorized Store has licensed and used continuously and consistently for an extended period of time to advertise goods and services relating to retail lumber, building supplies, and home improvement store goods and services. Each Authorized Stores' use of the Sutherland Marks in interstate commerce has indelibly impressed on the consuming public's minds the impression that the Sutherland Marks identify a single source as the source of their respective goods and service. Thus, the Sutherland Marks serve to identify a single source as the source of the goods and services bearing the Sutherland Marks because the relevant consumers have come to associate the Sutherland Marks with a single source by virtue of their use by the Authorized Stores, whose licensed use of the Sutherland Marks inures to Cimarron's benefit.

48. Following Cimarron's termination of McLiney's rights to use any Sutherland Marks, McLiney has continued to use SUTHERLAND-formative trademarks, including the Infringing Marks in direct competition with Authorized Stores, as shown on its storefronts, Website, the Domain Names, social media outlets, and other various marketing and advertising.

49. McLiney's continued use of SUTHERLAND-formative trademarks, including the Infringing Marks, to identify McLiney's goods and services constitutes use of a copy and colorable imitation of Cimarron's Sutherland Marks, has caused actual confusion, and is likely to continue to cause confusion, mistake, or to deceive the purchasing public into believing that

the goods and services of McLiney emanate from the same source of the goods and services previously provided by Cimarron, or that there is some connection, sponsorship, or affiliation between the goods and services of Cimarron and McLiney, all of which are contrary to fact.

50. Cimarron has no control over the nature and quality of the goods and services of McLiney. Any failure, neglect, or default by McLiney in providing goods or services will reflect adversely on Cimarron and its Authorized Stores as the believed source or origin thereof, which will hinder Cimarron's effort to continue to protect the outstanding reputation in the industry associated with the Sutherland Marks and subject Cimarron to loss of sales and service and the considerable expense to promote its goods and services in association with the Sutherland Marks, all to the irreparable harm of Sutherlands and the Authorized Stores.

51. McLiney's conduct constitutes an infringement of Cimarron's Sutherland Marks, and is actionable under the provisions of 15 U.S.C. § 1125.

52. Upon information and belief, McLiney has deliberately and willfully infringed Cimarron's Sutherland Marks in violation of Section 43(a) of the Lanham Act, 15 U.S.C. § 1125(a) and Cimarron has been, and will continue to be, irreparably harmed by such infringement unless this Court enjoins McLiney from continuing infringement pursuant to 15 U.S.C. § 1116.

53. Upon information and belief, McLiney is willfully infringing Cimarron's Sutherland Marks. As a result of McLiney's deliberate and willful infringement of Cimarron's Sutherland Marks, Cimarron is entitled to damages, McLiney's profits, attorney's fees and costs, and any and all other relief authorized by 15 U.S.C. § 1117.

**Count 3 – False Designation of Origin**  
**15 U.S.C. § 1125**

54. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

55. McLiney's conduct as recited herein, including without limitation use of the Infringing Marks in direct competition with Authorized Stores on and in connection with its storefronts, goods and services, and associated Website, Domain Names, social media outlets, and other various marketing and advertising constitutes a false designation of origin in that the use of SUTHERLAND-formative phrases in connection with the services of Defendants, has caused actual confusion and is likely to continue to cause confusion, to cause mistake, or to deceive others as to the affiliation, connection, or association of McLiney with Cimarron and its Authorized Stores, or as to the origin, sponsorship, approval of its goods, services and commercial activities with Cimarron and its Authorized Stores and constitutes a violation of 15 U.S.C. § 1125(a).

56. Upon information and belief, McLiney's conduct is willful and intentional with the purpose of misleading the public into believing that the goods and services of McLiney is in some way sponsored by, affiliated with, or connected to the goods and services previously provided by Cimarron and its Authorized Stores under its Sutherland Marks, all of which are contrary to fact. Cimarron has been and will continue to be irreparably harmed by McLiney's conduct unless this Court enjoins McLiney from unlawful conduct pursuant to 15 U.S.C. § 1116.

57. As a result of McLiney's deliberate and willful conduct, Cimarron is entitled to damages, McLiney's profits, attorney's fees and costs, and any and all other relief authorized by 15 U.S.C. § 1117.

**Count 4 – Unfair Competition**  
**15 U.S.C. § 1125**

58. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

59. Cimarron uses its Sutherland Marks to identify it as the source of its goods and services relating to retail lumber, building supply, and home improvement goods and services.

60. As a result of the facts alleged above, Cimarron has developed its Sutherland Marks to be closely associated with, and are an indication of source of origin of, the goods and services rendered by Cimarron's Authorized Stores, which use inures to Cimarron's benefit. Cimarron's Sutherland Marks have acquired a substantial and favorable reputation and goodwill in connection with the goods and services provided by Cimarron's licensed Authorized Stores.

61. McLiney's continued and unauthorized use of the Sutherland Marks in direct competition with Authorized Stores in advertising is likely to, and upon information and belief is intended to, cause confusion or mistake or to deceive as to the affiliation, connection or association of McLiney with Cimarron and its Authorized Stores or the possible origin, sponsorship or approval of McLiney's goods and services by Cimarron and its Authorized Stores.

62. McLiney's use of the Sutherland Marks is a misrepresentation that McLiney is affiliated with Cimarron and its Authorized Stores, which constitutes unfair competition.

63. Upon information and belief, McLiney deliberately and willfully committed acts of unfair competition in violation of Section 43(a) of the Lanham Act, 15 U.S.C. § 1125. McLiney's conduct has, and continues to, irreparably harm Cimarron.

64. Unless McLiney is restrained and enjoined, Cimarron will suffer further and irreparable damage for which Cimarron has no full and adequate remedy at law. As a result of

McLiney's deliberate and willful conduct, Cimarron is entitled to damages, McLiney's profits, attorney's fees and costs, and any and all other relief authorized by law.

**Count 5 – Unfair Competition Under Kansas Common Law**

65. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

66. McLiney's acts have created, and unless restrained by this Court, will continue to create, a likelihood of confusion and deception of the consuming public, causing irreparable injury to Cimarron for which Cimarron has no adequate remedy at law.

67. McLiney's conduct constitutes unfair competition under the common law of Kansas by a deliberate course of conduct, all without authorization, license, privilege, or justification.

68. Upon information and belief, McLiney acted with full knowledge of Cimarron's rights and use of the Sutherland Marks and without regard to the likelihood of confusion and deception of the public created by those activities.

69. McLiney's conduct demonstrates an intentional, willful, and malicious intent to trade on the goodwill associated with Cimarron to the substantial and irreparable injury of Cimarron.

70. As a result of McLiney's acts, Cimarron has been damaged and will continue to be damaged in an amount not as yet determined or ascertainable. At a minimum, however, Cimarron is entitled to injunctive relief, an accounting of McLiney's profits, actual damages, punitive damages, attorney's fees, the costs of this action, and any and all other relief authorized by law.

**Count 6 – Cybersquatting**  
**15 U.S.C. § 1125(d)**

71. Cimarron incorporates by reference the allegations of each of the above paragraphs as if fully set forth herein.

72. McLiney has registered and/or is using the Domain Names, which are confusingly similar to Cimarron's Sutherland Marks. McLiney's Domain Names consist of or contain a mark that is owned by Cimarron and which was distinctive at the time of McLiney's registration and/or use of the Domain Names.

73. McLiney has unjustly obtained gains, profits, and advantages as a result of their wrongful acts of federal trademark cyberpiracy in amounts thus far not determined.

74. Upon information and belief, McLiney has a bad faith intent to profit from Cimarron's Sutherland Marks.

75. Upon information and belief, the foregoing acts were done willfully and deliberately and with an intent to engage in cyberpiracy at Cimarron's expense in violation of Section 43(d) of the Lanham Act, 15 U.S.C. § 1125(d).

76. McLiney's unlawful acts in violation of Section 1125(d) of the Lanham Act have caused, and unless enjoined by this Court, will continue to cause, irreparable harm and damage to Cimarron. Accordingly, Cimarron seeks permanent injunctive relief pursuant to 15 U.S.C. § 1116.

77. Cimarron has no adequate remedy at law and is suffering irreparable harm and damage as a result of McLiney's acts of federal trademark cyberpiracy in an amount thus far not determined, but within the jurisdiction of this Court, which amount should be trebled pursuant to 15 U.S.C. § 1117.

**Prayer for Relief**

WHEREFORE, Cimarron demands a judgment against McLiney and prays that this Court:

- a. Preliminarily and permanently enjoin McLiney and its agents, servants, employees, and attorneys and all persons in active concert or participation with it or acting for, with, by, through, or under it, from infringing Cimarron's Sutherland Marks; from unfair competition with Cimarron; from falsely designating the origin of goods and services; and from cyberpiracy;
- b. Order McLiney to deliver up for destruction to Cimarron all unauthorized products and/or advertisements in its possession or under its control bearing any of Cimarron's Sutherland Marks or any simulation, reproduction, counterfeit, copy, or colorable imitation thereof, pursuant to 15 U.S.C. § 1118;
- c. Grant to Cimarron, should Cimarron so elect, an award of statutory damages of up to \$100,000 per domain name as authorized under 15 U.S.C. §§ 1117(d) and 1125(d) as a result of McLiney's acts of cyberpiracy;
- d. Grant to Cimarron an award and accounting of McLiney's profits, any damages sustained by Cimarron, and that all profits or damages be trebled, the costs of this action, and Cimarron's attorney's fees, pursuant to 15 U.S.C. § 1117;
- e. Award Cimarron punitive damages for McLiney's acts of unfair competition;
- f. Order and direct McLiney to immediately transfer to Cimarron any domain names including the term SUTHERLAND in relation to retail lumber, building supplies, and home improvement store goods and services, including without limitation the following domain names: sutherlandsexpress.com; sutherlands.co; sutherlands.net; buysutherlands.com; mysutherlands.com; sutherlandsinc.com; sutherlandsonline.com;

- sutherlandsstore.com; sutherlandhomeimprovement.com; sutherlandlbr.com;  
sutherlandsalexandria.com; sutherlandsamarillo.com; sutherlandsfortworth.com;  
sutherlandslubbock.com; sutherlandsmoberly.com; sutherlandsnevada.com;  
sutherlumber.com; and suthlumber.com;
- g. Order and direct McLiney to immediately transfer any social media outlets incorporating any of the Sutherland Marks, including without limitation twitter.com/mysutherlands and facebook.com/mysutherlands, to Cimarron; and
- h. Grant to Cimarron such further relief as may be equitable and proper.

**Jury Demand**

Pursuant to Rule 38 of the Federal Rules of Civil Procedure, Cimarron Lumber and Supply Company hereby demands a trial by jury.

Sutherland Lumber Co.  
ESTABLISHED 1917

*My grandson, Bob Jr., asked me to write a short history of our business. I thought you would like to see it.*



As all 80 year olds, there is nothing that elicits my enthusiasm like an opportunity to tell about something that happened so many years ago that most people can't even imagine it.

In 1917 my grandfather, also named Robert Sutherland, died and left a small legacy in life insurance to my father. My mother had some money given to her by her father, with which she matched my father's inheritance. With that they formed a fifty-fifty partnership and built a lumber yard in Durant, Oklahoma.

World War I was just involving the United. Commodities were in great demand to support the war effort.

My parents decided that the developing farming communities in Southeast Oklahoma were prospering because the prices of cotton and food crops were stimulated by the war. New land was being claimed for farms.

They were right. That area had been backward, but was catching up with the rest of the country. Oklahoma had only been a state for eleven years, but was coming forward fast.

The partnership prospered and more yards were added. Hugo, Idabel, Ada, Norman, and Shawnee, Oklahoma all came to be added in a few short years as sites for new yards.

In about 1921 a big oil field was discovered very near to the town of Ada, where there was a Sutherland yard. The Company knew nothing about oil fields, oil rigs, or oil boom towns, but became very aware of the tremendous increase in Ada's business and the profits coming therefrom.

They learned about rig timers, cement by the trainload, corrugated iron by the carload, and many items they had never dreamed of in the house pattern yards they had formerly operated. The Oklahoma oil boom was on.
