NOTICE OF OPPOSITION

Opposer Canadelle Limited Partnership, a Canadian limited partnership having its principal place of business at 4405 Metropolitan Boulevard East, Montreal, Quebec, Canada (“Opposer”), believes it will be damaged by registration of the mark that is the subject of U.S. App. Ser. No. 77/757,184 (the “WONDERCHIC mark”), published in the Official Gazette on February 23, 2010, for “exercise headbands for women with a small zipper pocket on the front and metal bra-hook closures on the back” in International Class 25, and hereby opposes same. As grounds for the opposition, it is alleged that:

1. Opposer is now, and its predecessors in interest and licensees have been, engaged in the manufacture, distribution, and sale in interstate commerce of a variety of apparel items.
2. For many years, and long prior to Applicants’ filing date, Opposer, Opposer’s predecessors in interest, and Opposer’s licensees have used the inherently distinctive mark

WONDERBRA in interstate commerce throughout the United States in connection with the sale of intimate apparel.

3. In addition to the WONDERBRA trademark, Opposer, Opposer’s predecessors in interest, and Opposer’s licensees have, for many years, and prior to Applicants’ filing date, used other inherently distinctive marks which contain the component “WONDER” in interstate commerce in connection with the sale of apparel, thereby developing a family of “WONDER” marks (hereinafter collectively referred to as the “WONDER Marks”).

4. Ever since the adoption and use of the WONDER Marks as aforesaid, Opposer, Opposer’s predecessors in interest, and Opposer’s licensees have widely and extensively advertised and sold goods bearing said WONDER Marks. As a consequence of same, the consuming public and trade have come to recognize and do recognize the WONDER Marks as being used by Opposer or by a single source, and to associate and identify said marks with Opposer or with a single source, and Opposer derives substantial goodwill and value from the aforesaid identification by the consuming public and trade.

5. Opposer is the owner of the following federal registrations for the WONDER Marks:

(Copies of these registrations, as well as printouts from the electronic database records of the USPTO showing the current status and title of the registrations, are attached as Exhibit A.) The aforesaid registrations are valid and subsisting, unrevoked, and uncanceled, and Opposer is the owner of them and the marks shown thereby and all of the business and goodwill represented thereby. Registration Nos. 612,231, 1,415,063, 2,730,568, and 2,751,348 have become incontestable pursuant to 15 U.S.C. § 1065.

GROUND I – LIKELIHOOD OF CONFUSION

6. Opposer repeats and realleges each and every allegation above as if fully set forth herein.

7. By the application herein opposed, Applicants seek to register the WONDERCHIC mark for “exercise headbands for women with a small zipper pocket on the front and metal bra-hook closures on the back” in International Class 25. Such goods are closely related to the goods for which Opposer has registrations and upon which it uses the WONDER Marks.

8. Opposer’s WONDER Marks and Applicants’ WONDERCHIC mark are confusingly similar in sight, sound and commercial impression.

9. Applicants’ WONDERCHIC mark is likely, when applied to the goods identified in the subject application, to cause confusion and mistake and to deceive, with consequent injury to Opposer, the consuming public, and the trade.

10. Opposer will be damaged by the registration sought by Applicants because such registration will support and assist Applicants in the confusing and misleading use of Applicants' mark sought to be registered, and will give color and exclusive statutory right to Applicants in violation and derogation of prior and superior rights of Opposer.

GROUND II – DILUTION

11. Opposer repeats and realleges each and every allegation above as if fully set forth herein.

12. Opposer and its predecessors in interest have spent to date a substantial amount of money marketing, advertising and promoting the sale of intimate apparel under the WONDERBRA trademark, and have sold tens of millions of dollars worth of such products. The WONDERBRA trademark is extremely well known to both users and non-users of intimate apparel in the United States.

13. Because of the high degree of inherent and acquired distinctiveness of the WONDERBRA trademark, the length of time and extent to which Opposer has used the WONDERBRA trademark, the vast advertising and publicity the WONDERBRA trademark has received, the nationwide trading area in which the WONDERBRA trademark is used, and the high degree of consumer recognition of the WONDERBRA trademark, the WONDERBRA trademark is a famous trademark pursuant to 15 U.S.C. § 1125(c)(1).


14. Applicants' WONDERCHIC mark would lessen the capacity of Opposer's famous WONDERBRA trademark to identify and distinguish Opposer's goods sold thereunder and, as such, would dilute the WONDERBRA trademark in violation of 15 U.S.C. § 1125(c).

15. Opposer will be damaged by the registration sought by Applicants because such registration will support and assist Applicants in diluting the distinctive quality of Opposer's famous WONDERBRA trademark.

WHEREFORE, Opposer believes it will be damaged by registration of Applicants' mark and prays that registration be refused.


