Pursuant to TBMP § 510.03(b) and the Order of this Board dated December 7, 2010 (the “Suspension Order”), Opposer LinkedIn Corporation (“LinkedIn”) hereby respectfully requests that the suspension granted in the Suspension Order be terminated and that the proceedings herein resume forthwith.


On December 6, 2010, the parties originally requested suspension for the purpose of settlement negotiations. In its Suspension Order, the Board granted the parties’ request “subject to the right of either party to request resumption at any time by filing a written notice with the Board.” *See also* TBMP § 510.03(b) (“Each party has the right to request resumption at any time during the suspension period.”).

Despite numerous attempts by LinkedIn over several months, LinkedIn has been unable to obtain the cooperation of Applicant Torridred Inc. to engage in meaningful settlement negotiations. Settlement has not been reached and, therefore, LinkedIn has the right to have the proceedings resume. LinkedIn respectfully requests that the proceedings be resumed without delay.
