NOTICE OF OPPOSITION

The Opposer is :

SPORTING SUPPLIES INTERNATIONAL, INC., a California Corporation
which has its principal place of business at 1225 North Lance Lane, Anaheim,
California 92806.

The above-identified Opposer believes that it will be damaged by registration of
the mark shown in the above-identified application, and hereby opposes the
same.

The grounds for opposition are as follows:

1. Opposer filed an application to register the Trademark, Golden Tiger, on
October 19, 2009 , on the basis of an intent to use such Trademark, for the
following goods: “ammunition for pistols, rifles and shotguns for sport and
hunting”, under international class 13, and on May 18, 2010 a Notice of
Allowance was issued to Opposer. Opposer intends to file its Statement of
Use in a timely manner.
2. The above identified Applicant did not file its application to register the mark,
Golden Tiger, for the following goods: “ammunition, ammunition for
firearms, gun cartridges, and small arms ammunition”, under the same
international class 13, until a subsequent date, namely on November 23,
2009, and, therefore, the prior filed application of Opposer should prevail over
the subsequently filed application, since the registration and use of the mark ,
Golden Tiger, by the Applicant, would in all likelihood cause confusion, and,
resulting damage to Opposer.
