ANSWER TO NOTICE OF OPPOSITION

Star Vector Corporation, by its attorneys, hereby Answers the Notice of Opposition of Sporting Supplies International, Inc. and admits, denies and alleges as follows:

1. Applicant admits that Opposer filed an application to register the mark, Golden Tiger, on October 19, 2009 on the basis of an intent-to-use such mark for the goods as stated.  
Applicant lacks knowledge or information sufficient to form a belief as to the truth of the Opposer's assertion that Opposer intends to file a statement of use in a timely manner.
2. Applicant admits that it filed its application to register the mark, Golden Tiger, on the basis of use of such mark for the goods "ammunition, ammunition for firearms, gun cartridges, and small arms ammunition" on November 23, 2009 but denies that Opposer should prevail.

AFFIRMATIVE DEFENSES

1. Opposer has failed to state a claim upon which relief can be granted.

2. Applicant submits herewith Applicant's Motion to Dismiss for Failure to State a Claim where Opposer has failed to plead that Opposer has priority of use over Applicant's mark.

- B. Order that the Opposition be dismissed; and
- C. Grant Applicant such other and further relief as the Board may deem just and proper.
