review and execution. On April 28, 2014, Opposer's outside counsel received the execution copies of the agreement from Opposer's in-house counsel which had been executed by Opposer. However, Opposer's in-house counsel had made minor changes to the executed agreement. Accordingly, on April 29, 2014, Opposer's outside counsel sent the execution copies of the agreement back to Applicant's counsel so that Applicant could initial and thereby accept those changes, at which time the agreement will be fully executed. The additional time is thus requested so that the parties may complete the process of executing the settlement agreement. The agreement contemplates an amendment to the identification of Applicant's services. If approved by the Board, the matter will be settled without further proceeding.

If the Board grants this motion, the parties request that the expert disclosures deadline be reset for thirty (30) days after the matter comes out of suspense and that the remaining discovery and trial deadlines be reset accordingly.
