**MOTION TO SUSPEND PROCEEDINGS**

This motion is brought under 37 C.F.R. 2.117(c) by Opposer, LUBERSKI, INC., a California corporation and doing business as HIDDEN VILLA RANCH (“HVR”). Good cause exists to suspend the proceedings for 180 days, or for a certain time upon the Board’s discretion, as the parties are engaged in settlement negotiations.
