The calculated response interval range for individuals likely to use email and/or instant messaging who believe that Opposer FACEBOOK is the source, authorization/approval of, or business affiliation/connection of email and instant messaging services bearing the mark FACEMAIL is 36.20% +/-5.65% (i.e., if a census were taken, one would be 95% confident that the likelihood of confusion would be between 30.37% and 41.85% of the defined population).
