NOTICE OF OPPOSITION

In the matter of pending trademark application Serial No. 85113869, for the mark "NURU" in International Class 005 for "Personal lubricants" (hereinafter NURU Mark) filed by the applicant, Cariel Cohen, (hereinafter "Applicant"), published in the Trademark Official Gazette on October 26, 2010, Opposer, NURU (THAILAND) CO., LTD. (hereinafter "Opposer"), believes it will be damaged by the registration of the NURU Mark, and hereby opposes the same pursuant to 15 USC §1063 and 37 CFR §2.101

As grounds for opposition, the Opposer alleges that:

1. Opposer is a company organized under the laws of Thailand, REGISTRATION NO.: 0105553098962 with an address at business at 31/74 Soi Ladprao 23, Ratchadapisek Rd., Chandrakasem, Chatuchak, Bangkok 10900, Thailand.
2. Opposer has established the NURU Gel products distribution in Thailand since 2009 by persons and the company was registered in 2010.
3. Upon information and belief, Applicant is an individual who is a French citizen with an address at 1421 Ambassador Street, Apt. 315, Los Angeles, California 90035 USA.
4. Upon information and belief, Applicant is one of Opposer's U.S. customer who purchase the NURU GEL's products from Opposer and Opposer arranged the shipment to Applicant's address in U.S.A. five times and the first shipment take place after Applicant made a payment to Opposer on April 28, 2010 via PayPal.

Please see Exhibit 1 for the copy of all five PayPal payment details from Applicant to Opposer.

5. The Applicant filed with the United States Patent and Trademark Office ("USPTO") to register the NURU Mark application Serial No. 85113869 for "Personal lubricants" in International Class 005 on August 23, 2010 ("Opposed Goods") and alleged that the mark was first used in April 25, 2010 and in interstate commerce on April 25, 2010.

6. Opposer is timely filing this Notice of Opposition.

7. Opposer is now in the process of the NURU mark Thai trademark registration, serial number: 766756 for variety of personal care, personal wash and cosmetic products for the NURU mark which was filed with Thai Department of Intellectual Property, Thai Ministry of Commerce on May 11, 2010 before the filing date of the Applicant's NURU Mark.

After that, Opposer realize and accept that the NURU mark would not able to be filed with the United States Patent and Trademark Office ("USPTO") to register because "NURU" is the generic word in violation of Trademark Act section 23.

8. Opposer is a manufacturer and seller of NURU products such as, including but not limited to, massage gels, massage oils, massage chair and other of NURU massage accessories in Thailand and export to U.S.A. and to over 10 countries.

9. For interstate commerce in U.S.A, Opposer has started selling the NURU GEL products to U.S.A. on March 12, 2010, earlier than the Applicant's filing date of the NURU Mark at the USPTO and its alleged date of first use of the NURU mark in commerce.

Opposer's use of the NURU Mark in the U.S. interstate commerce predates the filing date of the Applicant's NURU Mark application and prior to any use that may be alleged by the Applicant.

Please see Exhibit 2 for the copy of the PayPal payment and the eBay message purchasing ID: 270541856115 which has been sent to Opposer on March 12, 2010 to inform that the NURU GEL product was sold to the buyer in U.S.A.

First Basis for Opposition – Fraud

Torres v. Cantine Torresella S.r.l. Fraud 808 F.2d 46, 1 USPQ2d 1483 (Fed. Cir. 1986)

10. On August 23, 2010, Applicant filed with the United States Patent and Trademark Office ("USPTO") a Combined Declaration of FIRST USE IN COMMERCE by Applicant.

11. Applicant declare that FIRST USE IN COMMERCE was, as of April 25, 2010, using the NURU mark "in commerce on or in connection with all goods listed in the above-identified registration," Upon information and belief, such statements were false at the time they were made.

12. Applicant claims that it began offering Personal lubricants under the mark NURU on April 25, 2010. Upon information and belief, Applicant is not currently offering Personal lubricants under the NURU trademark.

13. Upon information and belief, Applicant knew the issue above since the date of Application, not file in error with the United States Patent and Trademark Office ("USPTO").

Second Basis for Opposition - Genericness

Trademark Act section 23

14. The term "NURU" has been widely used by NURU products manufacturers, retailers, advertising, and consumers to refer to the products and services in connection with NURU Massage.

15. Many companies make NURU GEL by their mark, Pepee mark, a well-known Japanese manufacturer and seller of NURU GEL, including the Opposer who is going to file with the United States Patent and Trademark Office ("USPTO") to register a new Mark application, among others.

16. There are more than 500 website mention or contain "NURU Gel" word by www.google.com, www.yahoo.com and other of Internet search engine. Most of them indicate about the specific type of gel for NURU Massage, not specify only to the Applicant's Mark, products or services.

17. There are more than 400 website mention or contain "NURU Massage" word by www.google.com, www.yahoo.com and other of Internet search engine. Most of them indicate about a well-known specific type of massage, NURU Massage, not specify only to the Applicant's Mark, products or services.
For example, www.nurumassage.com, a well-known NURU Massage video's provider website which has thousands of visitor per day.

18. The term "NURU" and also "NURU GEL" have become generic in that the primary significance of the term to the relevant public are as the name to refer to the products and services in connection with NURU Massage, not by Applicant.
The word "NURU" originates from the Japanese language, which means slippery. A generic term is not capable of serving the essential trademark function of distinguishing the products or services of a business from the products or services of other businesses, and therefore cannot be afforded any legal protection.
"NURU" may generally be used by anyone—including other manufacturers—to refer to a product without using someone or some organization's proprietary trademark.

Third Basis for Opposition - Likelihood of confusion and damage to consumers

19. The NURU GEL products are currently used for NURU Massage, which is a sensual massage and NURU GEL products are not intended to use as personal lubricants. Consumers are likely to mistakenly believe that all other NURU GEL products from all other manufacturers can be used as Personal lubricants.

A person having "a general recollection" of the NURU GEL Mark would be likely, upon seeing and/or hearing all other NURU GEL products, to assume that all other NURU

GEL products can be used in the same directions and benefits of Personal lubricants which is a damage to consumers.

20. Upon information and belief, Applicant knew the issue above since the date of Application.

WHEREFORE, Opposer deems that it will be damaged by the registration of the NURU Mark, and opposes its registration in International Class 005 and pray that Applicant's NURU Mark may not be allowed to registration in International Class 005 pursuant to 15 USC §1063 and 37 CFR §2.101 because: (1) NURU has been continued via fraudulent representations to the USPTO by Applicant, (2) the word NURU has become the generic name for the products and services in connection with NURU Massage before the Application and not by the Applicant, and (3) because the Likelihood of confusion and damage to consumers. The opposition fee in the amount of \$300.00 for an opposition in 1 class is filed herewith via credit card electronically. If for any reason this amount is insufficient, please consider it as an innocent mistake with inexperience and please kindly inform Opposer to file the payment again correctly as Opposer has no reason at all to abandon the fee and the opposition. This paper is filed electronically.
