**REQUEST THE BOARD TO SEAL SOME OF DOCUMENTS
THAT DISCLOSED PERSONAL AND MEDICAL INFORMATION**

Amlin Health, LLC (“Applicant”) respectfully requests the Board to seal and mark it as confidential for some documents that disclosed the Applicant and his partner's personal and medical information improperly used by a company on the Internet although the case (Opposition No. 91199018) has been closed due to financial reason. Applicant was not aware of filing to the Board that he could have chosen and marked it as confidential in the first place. It has been brought to Applicant's attention recently that all of these documents are publicly accessible on-line at:www.plainsite.org, the affiliate with Think Computer Corporation for commercial purpose. (The case has deeply hurted Applicant's small minority business for years and it would still have negative impacts on the development of the business). The reasons to request the Board to seal some of these documents and mark it as confidential are as follows:

- 1----Applicant initially provided those data while fling the case was for evidence and reference to the Board only. However, it has been brought to Applicant's attention that someone improperly using the data (43 documents) from government databases for commercial purpose, Exhibit A1-2;
- 2—The company improperly using the data for commercial purpose is a web site www.plainsite.org,

the affiliate with Think Computer Corporation; they charge \$99 monthly subscription fee to users for profit purpose. The company is located at 1132 Boranda Avenue, Mountain View, CA 94040-3145, contact name is Aaron Greenspan, No phone number is available, Exhibit B 1-2;

3—there are nine (9) documents (numbers 38, 37, 35, 34, 32, 26, 25, 24 and 22) among 43 documents disclosed Applicant and his partner's personal and medical information included but not limited to name, phone number, home address, proscription drug/medication name and dosage, healthcare provider's name/phone number and personal signature and etc.. shown in the table below. Applicant requests the Board to seal and mark following documents as confidential.

4-----The Plainsite.org claims that all data got from government databases, they also particularly claims that their web site “contains information from the United States court system's PACER

database, various IRS, FEC and GPO databases and ThinkLink”, Exhibit C, that means these organizations/web sites also contain the case information, in fact, that is NOT true. It is common sense that IRS would never ever disclose anyone's information on-line such as above. Furthermore, Applicant conducted Internet search throughout the websites of PACER database, various IRS, FEC and GPO databases and ThinkLink using personal and business names as terms and found NO such information available at all, search results are shown in Exhibit D-H. In short, the Plainsite.org does not say the TRUTH;

5----Now, this company/Plainsite.org is trying harder for intensive marketing, Exhibit I;

6----Applicant spoke to the Board help line two weeks ago and explained his did not mark it as confidential in first place when he filed these documents because he was not aware of the option, he also explained his above concerns and was suggested to file the motion to the Board.

Based on above reasons, Applicant respectively request the Board to seal and mark it as confidential for above-mentioned documents and help healthy growth of the small minority business even though the case has been closed.






