Face paint(matte, liquid, creme, airbrush). Cosmetic accessories: blotting papers, makeup wipes, cosmetic tissue, wedge, cosmetic airbrush machine, sponge, brow thread, eyebrow/face razor, puff, mascara brushes, applicators, sharpner, brow scissors, stencils, bags, purses, and carrying cases. Empty cosmetic packaging: foundation bottles, compacts, jars, pumps, squeeze bottles. Make-up remover, skin care brush/sponge/puff/cotton pad, facial wax or

machine/sugar/depilatory, Face wash, face toner, face moisturizer, face mask, face oil, face serum, eye creme or treatment, face treatment, lash treatment, face treatment machine, and specifically excluding fragrances, perfume, eau de parfum, bath gel and body lotion.
