ANSWER TO NOTICE OF OPPOSITION AND COUNTERCLAIM

Applicant, Georgia Pellegrini Media Group, LLC (“Applicant”) respectfully submits its Answer to Notice of Opposition and Counterclaim to Opposer, Hunter Boot Limited (“Opposer”) as follows¹:

ANSWER

1. Admitted.
2. Denied.
3. Denied.
4. Denied. Opposer is confused as to Applicant’s mark. Opposer identifies Applicant’s mark as “HUNTER GIRL”. In fact, Applicant’s mark is “GIRL HUNTER”. Moreover, USPTO Serial No: 76/702,2199 clearly identifies itself as a GIRL HUNTER mark, not a HUNTER GIRL mark. Applicant cannot help but wonder if this opposition was filed as the result of a careless

mistake by Opposer? After all, the Examining Attorney who presumably did not make this mistake found no confusion between the marks GIRL HUNTER and HUNTER.

5. Denied. The record previously filed with the Examining Attorney demonstrates use of the GIRL HUNTER mark by applicant dating back to early 2009. This information was readily available to Opposer as a publicly available document.

6. Denied. Applicant's mark is actually GIRL HUNTER. As Opposer knows, or should know, the first word in a mark is considered its dominant element. *Palm Bay Imports Inc. v. Veuve Clicquot Ponsardin*, 73 U.S.P.Q.2d 1689 (2005). The first word in Applicant's mark is "GIRL". The first word in two of Opposer's marks is "HUNTER". The words GIRL and HUNTER do not sound nor look alike, nor do they have similar meanings. Opposer's remaining mark beings with the word "ROYAL". It is difficult to see how anybody could be confused between the words GIRL, HUNTER and ROYAL. Opposer's allegation of confusion has no merit.

7. Denied.

8. Denied.

9. Denied.

10. Denied. Additionally, the GIRL HUNTER mark/brand has received ample media coverage of a favorable nature.

11. Denied.

12. Denied.

FIRST AFFIRMATIVE DEFENSE

Mistake. Opposer does not realize that Applicant's mark is actually GIRL HUNTER as opposed to HUNTER GIRL. Accordingly, this opposition has been predicated upon a basic mistake of fact by Opposer. It should be dismissed.

SECOND AFFIRMATIVE DEFENSE

Abandonment. Opposer has constructively abandoned its claim to the word "HUNTER" in connection with International Class 025 goods by not opposing USPTO Serial No: 79/975,114; Registration No. 3956907 "HUNTER" stylized mark in International class 025 [Date of Registration May 10, 2011 – approximately 20 (twenty) days *after* Opposer filed its opposition in this action], namely: "Headbands; clothing, namely, shirts, polo shirts, tank tops, skirts, dresses, pullovers, vests, bathing suits, swim suits, jackets, sweaters, pants, belts, t-shirts, slacks, sweatshirts, jerseys, shorts, sweatpants, scarves, gloves, hosiery, neckties, rainwear, pajamas, robes, nightshirts, underwear and wristbands; headgear for wear, namely, headwear, hats, berets, caps and visors; riding boot accessories, namely, riding boots bag"

The word element of two of Opposer's three marks and USPTO Registration No: 3956907 is not merely "similar" or "confusingly similar" to Opposer's two marks, it is identical. Yet Opposer has no issue with HUNTER (USPTO Registration No: 3956907) competing with its HUNTER brands in the identical class of goods. In the alternative, Opposer has so diluted its own mark through its conduct, or lack of conduct, that it is now unable to seek broad protection for the word "HUNTER".

THIRD AFFIRMATIVE DEFENSE

Unclean hands and/or fraud. Opposer is the owner of USPTO Registration Nos. 3876340, 2740877 and 1550244. Opposer has executed affidavits or other sworn statements in connection with these marks. These sworn statements include the March 2009 application of the 3876340

mark. According to Opposer, its International Class 025 goods are used in commerce in connection with the registered 876340 mark the United States for the following goods:

Clothing, namely, skirts, culottes, pants, blouses; footwear; headgear, namely, hats and caps; boots; welts for boots and shoes; non-slipping devices for boots, namely, studs for boots, studs for shoes, over soles for boots and shoes; inner soles; heels and soles for footwear; insoles for boots and shoes; liners for boots and shoes; shaped bags and pouches adapted to carry boots and shoes, namely, bags for Wellington boots, bags for waterproof boots, bags for hiking boots and bags for hiking shoes; socks; hats; gloves; scarves; waterproof footwear; galoshes; garters; headbands; jackets; jerseys; jumpers; knitwear, namely, knitted gloves, jerseys, jumpers, sweaters, cardigans, pullovers, waistcoats and tank-tops; neck ties; outer clothing, namely, outer jackets, outer coats, raincoats, trenchcoats and outdoor gloves; aprons; overalls; overcoats; pajamas; pants; sandals; flip-flops; shirts; shoes; slippers; sun visors and caps; sweaters; swimsuits; T-shirts; top hats; top coats; trousers; undergarments; underpants and underwear; fishing vests; waistcoats; and waterproof clothing, namely, waterproof jackets, waterproof coats, waterproof raincoats and waterproof pants; sports clothing, namely, sports singlets, sports T-shirts, sports sweatshirts, sports sweat pants, sports tracksuits, sports jerseys; sports footwear, namely, rubber shoes, training shoes and athletic shoes; after-sports footwear; belts and money belts

In fact, this is nonsense. For even a cursory review of Opposer's online US store at usa.hunter-boot.com reveals that Opposer only markets the following types of goods or items: shoes, boots, boot accessories, handbags and socks. And that's it. Hence Opposer's sworn claim of use of the mark in commerce in connection its extensive list of items that appear in the indented paragraph immediately above is simply untrue.

Opposer should not seek to use the power of this adjudicative body to enforce its false claims.

COUNTERCLAIM

As set forth in Applicant's Third Affirmative Defense above, Opposer claims that it uses the HUNTER mark in commerce in connection with goods which it does not. Exhibit A, attached hereto, is a detailed itemized list of all goods Opposer makes available for sale in the US. This list was created with Opposer's very own "Product Search" tool. As a result, it is readily demonstrable that Opposer does not use the HUNTER mark in connection with most of the goods that it claims to in the US. See Exhibit A.

Despite Opposer's claims to market "belts and money belts", "pants" and "blouses" and "top hats" and "pajamas", Opposer markets none of these in connection with the HUNTER mark. That is because Opposer markets shoes and boots, boot accessories, handbags and socks only. Nothing else.

By purposeful design or otherwise, Opposer has misled or deceived the TTAB as to its use of the subject mark. Accordingly, Applicant respectfully submits that Opposer's mark USPTO Registration No. 3876340 should be cancelled pursuant to 15 U.S.C. § 1064.

WHEREFORE, Applicant prays that the Opposition be denied and Opposer's Registration No. 3876340 be deemed cancelled and/or abandoned.
