



NOTICE OF OPPOSITION

Bayer Aktiengesellschaft, an aktiengesellschaft organized under the laws of Germany and having a business address of Kaiser-Wilhelm-Allee, 51373 Leverkusen, Germany, believes that it will be damaged by the registration of the above-identified mark and, having been granted appropriate extensions of time to oppose this application, hereby opposes the same. The required fee for the filing this Notice of Opposition in one class is submitted herewith. If any additional fees are due, please debit Account No. 03-2775.

As grounds for this opposition, it is alleged that:

1. Bayer Aktiengesellschaft, including its related, affiliated, and/or predecessor companies, (collectively referred to as “Bayer” or “Opposer”) has been and now is engaged in the development, manufacture, distribution and sale of, *inter alia*, a variety of chemical and

agricultural products, including without limitation, chemicals used in agriculture, insecticides, pesticides, herbicides and fungicides.

2. Bayer is the owner of U.S. Trademark Registration No. 3,560,541 (the “541 Registration”), which issued on January 13, 2009, for the mark LUNA (“LUNA Mark”) for the goods “chemicals for use in agriculture; chemicals for use in forestry and horticulture, except fungicides, herbicides, insecticides and parasiticides; chemical preparations for use in agriculture, horticulture and forestry, namely, chemical preparations for the treatment of seeds; fertilizers,” in class 1; and “preparations for killing weeds and destroying vermin, namely, insecticides, herbicides, fungicides,” in class 5 (“Bayer Goods”). This registration is in full force and effect as evidenced by the printout from the electronic database records of the United States Patent and Trademark Office (“PTO”) attached at Exhibit A.

3. Bayer is the owner of U.S. Application Nos. 85/081,681 for LUNA SENSATION; 85/081,675 for LUNA TRANQUILITY; 85/081,666 for LUNA EXPERIENCE; and 85/081,664 for LUNA PRIVILEGE, which were all filed on July 9, 2010, for the goods “preparations for killing weeds and destroying vermin; insecticides, herbicides, fungicides” in class 5.

4. Shandong Luba Chemical Co., Ltd. (“Applicant”), a limited company organized under the laws of China and having a business address of No. 26 South Xizhou Road, Licheng District, Jinan City, Shandong Province 250100, China, filed an intent to use application on August 31, 2010 for the mark “LUBA” (“LUBA Mark”) for the goods, “antibacterial pharmaceuticals; biocides, germicides, bactericides, virucides, fungicides, insecticides, pesticides and herbicides; germicides; herbicides; insect repellents; insecticides; preparations for destroying

vermin; preparations for killing weeds; sterilising preparations; weed killers for agricultural use,” (“LUBA Goods”) in class 5, Application No. 85/120,389 (the “‘389 Application”).

5. On May 28, 2008, before the filing date of the ‘389 Application, Bayer filed the application that matured into the ‘541 Registration.

6. There is no issue of priority. Upon information and belief, Applicant acquired no rights in the LUBA Mark in the United States before Bayer acquired rights in the LUNA Mark.

7. Upon information and belief, Applicant acquired no rights in the LUBA Mark in the United States before August 31, 2010.

8. Applicant has applied to register LUBA for goods in class 5, the same class of goods in which the LUNA Mark is registered. Such goods are identical to, overlapping and/or closely related to the Bayer Goods. On information and belief, the LUBA Goods will be distributed to the same classes of consumers and through the same channels of trade as the Bayer Goods. As applied to such goods, Applicant’s LUBA Mark so resembles the LUNA Mark as to be likely to cause confusion, or to cause mistake, or to deceive as to the source of the goods.

9. Bayer will be damaged by Applicant’s registration of LUBA for the goods identified in the ‘389 Application as a result of the aforementioned confusion, mistake and deception.

WHEREFORE, Opposer prays that this Opposition be sustained, and the registration sought by Applicant be refused.
