

True and accurate print-outs of the aforesaid registrations from the TARR database are attached hereto as Exhibit B. Said registrations are valid, subsisting and Registration Nos. 2,290,570 and 2,484,122 are incontestable.

4. Opposer's use and registration of the above EXPRESS trademarks and service marks (herein the "EXPRESS Marks"), which rights date back to 1972 by assignment of U.S. Registration No. 1,120,073 (which issued to registration on June 12,

1979), pre-date Applicant's filing date of August 7, 2009. Therefore, Opposer's EXPRESS Marks have priority over Applicant's claim to the designation EXP.

5. Opposer has been and now is the owner and operator of a nationwide chain of 589 EXPRESS specialty retail stores located throughout the United States, which sell, *inter alia*, a wide range of both women's and men's high quality fashionable clothing and accessories, including, dresses, jumpsuits, tops, blouses, shirts, cardigans, sweaters, jackets, vests, intimates, outerwear, pants, leggings, shorts, jeans, shirts, polos, tees, knits, suits, track jackets, hoodies, underwear, ties, jewelry, handbags, and accessories under the above EXPRESS Marks (herein "Opposer's Goods"). In addition, Opposer is the owner and operator of the Internet website, www.express.com, which also sells Opposer's Goods under the EXPRESS Marks.

6. Opposer has been continuously and now is advertising, offering for sale and selling in interstate commerce throughout the United States Opposer's Goods, bearing the EXPRESS Marks, and offering throughout the United States the aforesaid services, under the EXPRESS Marks. The marketplace success and desirability of Opposer's Goods is evidenced by consumer purchases. Since at least as early as 1991, sales of Opposer's Goods bearing the EXPRESS Marks have exceeded \$1 billion annually, as set forth below, and since 1994 sales have been approximately \$2 billion per year.

7. Opposer has used and advertised its EXPRESS Marks continuously and extensively since 1983 in order to educate the public as to the origin of Opposer's Goods bearing the EXPRESS Marks and to identify those goods with Opposer and its EXPRESS stores. Such efforts include the use of print advertising, window displays and in-store signage, visual merchandising, direct mail, brochures and coupons, samples, public relations and customer affinity clubs, as well as advertising and promotion of Opposer's Goods on its Internet website located at www.express.com and sponsoring and participating in Model.live and the television show, *The Bachelor*. As evidence of Opposer's commitment to advertising and promotion of its brand during the past twenty-seven years, Opposer's annual expenditures have been as follows:

8. In addition, Opoposer has recently gone public. Opposer's Express shares now trade on the New York Stock Exchange under the ticker symbol EXPR.

9. Upon the introduction of Opposer's EXPRESS Marks into the market in connection with the aforesaid goods and services and continuous use thereafter, said EXPRESS Marks became and are now widely known and recognized

by the public and the trade as the means by which Opposer's Goods and/or services are distinguished, and their source and origin identified, and are an important and valuable asset of Opposer.

10. Applicant's adoption and use of the designation EXP is without license, permission or authorization of Opposer.

Count I - Likelihood of Confusion

11. Opposer repeats and reavers the averments set forth in paragraphs 1 through 10 inclusive of this Notice of Opposition as if more fully set forth herein again.

12. The designation EXP is an abbreviation of Opposer's mark EXPRESS. Opposer has used the mark EXP since 1986 and has over the years used the mark at various different times and was the owner of Registration No. 1,539,267 of the mark EXP and Design (the "EXP Mark"). A substantive Office Action was issued against the Applicant's application 77/286,020 citing Opposer's Registration No. 1,539,267 of the mark EXP and Design on the basis of likelihood of confusion. Registration No. 1,539,267 lapsed in 2009, and it was refiled under Application Serial No. 77/733,938. The Examining Attorney has suspended Opposer's Application Serial No. 77/733,938 of the mark EXP and Design pending disposition of the Applicant's Application Serial No. 77/286,020 which Opposer is also opposing on the grounds that, if and when the Applicant's application 77/286,020 matures to registration, it could become the basis of a citation against Opposer's Application Serial No. 77/733,938 and lead to the ultimate refusal to register Opposer's application on the basis of likelihood of

confusion.

13. There are no restrictions on Applicant's Goods and Services and/or the trade channels through which they may be sold. Applicant's Goods and Services are closely related to Opposer's Goods and Services, will be sold to the same class of purchasers and will be offered for sale through the same or similar channels of trade. Consumers in the marketplace are already familiar with the mark EXP in connection with Opposer's Goods and Services and EXPRESS Marks.

14. The designation Applicant seeks to register, namely, EXP, so resembles Opposer's EXPRESS Marks and EXP Mark, as to be likely, when applied to Applicant's Goods and Services, to cause confusion or mistake or to deceive persons by creating the erroneous impression that Applicant's Goods and Services originate with, or come from the same source as, Opposer's Goods and/or services, or are endorsed by, or are sponsored by, or are connected in some way with Opposer, and the registration thereof would be injurious to Opposer.

Count II - Dilution

15. Opposer repeats and reavers the averments set forth in paragraphs 1 through 10 inclusive of this Notice of Opposition as if more fully set forth herein again.

16. In addition to the substantial sales of and paid advertising and promotion of Opposer's Goods and Services under the EXPRESS Marks as set forth above, Express has also received extensive media coverage or "free publicity" in fashion magazines and the trade press. The success of Opposer's Goods and

Services bearing the EXPRESS Marks, its EXPRESS stores and brand has been frequently covered by major magazines and publications that are widely circulated throughout the world. Articles about Opposer, and Opposer's Goods and Services bearing the EXPRESS Marks have been featured in publications such as *The New York Times*, *The Los Angeles Times*, *USA Today*, *The Wall Street Journal*, *The New York Post*, *The New York Daily News*, *Fortune* and *Forbes*. Opposer's Goods bearing the EXPRESS Marks have recently been featured in the following magazines and publications, which have international circulation: *Allure*; *Cosmopolitan*; *Cargo*; *Elle*; *Family Circle*; *Glamour*; *Good Housekeeping*; *GQ*; *Harper's Bazaar*, *In Style*; *Jane*; *Lucky*; *Marie Claire*; *Maxim*; *Men's Health*; *The New York Times*; *Nylon*; *People*; *Self*; *Seventeen*; *Shop, Etc.*; *Vogue*; *YM*; *Details*; *Shape*; *People Style Watch*; *Us Weekly*; *Life & Style*; *In Touch*; *Star*; and *OK!*. Opposer's Goods and Services bearing the EXPRESS Marks have also been featured on numerous national and local television programs, including: *CBS Early Show*; *Good Morning America*; *The Today Show*; *The View*; *Access Hollywood*; *Extra*; and *E! News*.

17. As a result of the extensive sales, advertising and promotion of Opposer's Goods and Services bearing the EXPRESS Marks nationwide and because of the superior quality of such merchandise, the trademark, trade name and service mark EXPRESS has become a well-known and famous mark, representing goodwill of inestimable value to Opposer.

18. Applicant's proposed use and registration of the designation EXP is likely to, and will dilute, blur and erode the distinctiveness of Opposer's famous

EXPRESS mark, and/or damage the goodwill associated with the EXPRESS mark.

WHEREFORE, Opposer, Express, LLC, prays that said Application Serial No. 85/095,689 be rejected and registration of the designation EXP as a trademark to Applicant be refused and denied, and that its Opposition be sustained and/or that the Board grant to Opposer such other and/or further relief as the Board may deem just and proper under the circumstances.
