MOTION FOR DEFAULT JUDGMENT


Opposer, pursuant to 37 C.F.R. 2.106(a) and Trademark Trial and Appeal Board Manual of Procedure §§ 312 and 508, respectfully moves the Board to enter a default judgment refusing registration of the trademark application for the mark AUTO GLASS LEADER, Application Serial No. 85/172,598 (the "Application"). In further explanation and support, Opposer shows the Board as follows:

1. Opposer filed a Notice of Opposition regarding the Application on May 31, 2011. The deadline in the Board's Order was technically May 28, 2011, but because that date fell on a Saturday and Monday, May 30, 2011, was a federal holiday, Opposer had until May 31, 2011, to file a Notice of Opposition pursuant to 37 C.F.R. 2.196.
2. The Board, by letter dated May 31, 2011, set the deadline for the Applicant's Answer to the Notice of Opposition as July 10, 2011.
3. Trademark Rule 2.106(a) provides in pertinent part that if the Applicant does not file an Answer within the time set, a default judgment may be entered.

4. Applicant's deadline for filing an Answer has passed, but Applicant has neither filed an Answer to the Notice of Opposition, nor sought an extension of the deadline within which it was entitled to do so.

WHEREFORE, Opposer respectfully requests that the Board enter Default Judgment refusing registration of the trademark application for the mark AUTO GLASS LEADER, Application Serial No 85/172,598.


