NOTICE OF OPPOSITION

Lifetouch Inc., a Minnesota corporation located at 11000 Viking Drive, Suite 400, Eden Prairie, Minnesota 55344, believes that it will be damaged by registration of the mark LIVETOUCH shown in trademark application Serial No. 77/134,335, filed March 19, 2007, by Livetouch.net, Inc., and hereby opposes the same. The grounds for opposition are as follows:

1. By the application herein opposed, Applicant seeks to obtain under the provisions of the Trademark Act, registration on the Principal Register of the mark LIVETOUCH for “Electronic transmission of messages and data; Electronic voice messaging, namely, the recording and subsequent transmission of voice messages by telephone; Instant messaging services; Internet telephony services; Providing e-mail services; Telephone communication services; Telephone voice messaging services,” in International Class 38 and “Application service provider (ASP), namely, hosting computer software applications of others; Computer software development,” in International Class 42.

2. Applicant’s mark published for opposition on March 15, 2011. Opposer filed and the Board approved an extension of time to oppose Applicant’s mark until July 13, 2011. This Notice of Opposition is timely filed.

3. Since at least as early as 1984, Opposer has used the LIFETOUCH mark in connection with a broad offering of products and services relating to photography, including computer software and messaging services.

4. Opposer owns numerous registrations and applications for its well-known family of LIFETOUCH marks, including the following (collectively referred to herein as “Opposer’s LIFETOUCH marks”):

Current printouts of information from the electronic database records of the USPTO showing the current status and title of the registrations are attached hereto as Exhibit A.

5. The registrations listed in the above table have not been canceled, are valid, and are now in full force and effect.

6. The following registrations are incontestable under Section 15 of the Lanham Act, 15 U.S.C. § 1065: Registration Nos. 1,323,758; 1,631,112; 1,638,363; 1,647,707; 1,672,864; 2,514,462; 2,570,744 and 2,627,847. Consequently, these registrations are conclusive evidence of the validity of the registered marks and of the registration of the marks, of Opposer's ownership of the marks, and of Opposer's exclusive right to use the registered marks in commerce under Section 33 of the Lanham Act, 15 U.S.C. § 1115.

7. Opposer has advertised and promoted its LIFETOUCH marks extensively. Opposer has also made substantial sales of products and services under said marks. As a result of such use and promotion, Opposer's LIFETOUCH marks have developed and represent valuable goodwill inuring to the benefit of Opposer.

8. Opposer adopted and commenced use of the term LIFETOUCH as a trademark long before Applicant adopted the LIVETOUCH mark. Opposer's usage of the LIFETOUCH mark commenced at least as early as June 11, 1984, nearly twenty-three (23) years before Applicant's filing date of its application. Opposer therefore has priority over Applicant with respect to the marks at issue.

9. Upon information and belief, Applicant had not used Applicant's mark in commerce prior to Applicant's March 19, 2007, filing date. In addition, upon information and belief, Applicant has not used Applicant's mark in commerce.

10. Applicant's LIVETOUCH mark is confusingly and deceptively similar to Opposer's previously used and registered LIVETOUCH marks.

11. The goods and services provided by Opposer under its LIVETOUCH marks are closely related to the services listed in Applicant's application for registration of the LIVETOUCH mark. For example, Opposer provides software to customers which is closely related to Applicant's services of hosting computer software applications of others. In addition, Opposer provides a messaging service to some of its customers which is closely related to Applicant's messaging services.

12. Upon information and belief, Applicant had knowledge of the fact that Opposer used the term LIVETOUCH as a trademark before it adopted the LIVETOUCH mark.

13. Upon information and belief, Opposer's and Applicant's services are promoted and sold in the same channels of trade to the same consumers or class of consumers.

14. The parties' marks are nearly identical in sight, sound and commercial impression.

15. Due to the similarity between Applicant's claimed mark, LIVETOUCH, and Opposer's previously used and duly registered LIVETOUCH marks, the closely related nature of the services of the respective parties, customers and potential customers are likely to believe that Applicant's services originate from Opposer, resulting in a likelihood of confusion in the marketplace, and damage to Opposer.

16. The use and registration by Applicant of the mark LIVETOUCH for Applicant's services is likely to cause confusion or to cause mistake or deception in the trade, and among

purchasers and potential purchasers, with Opposer's previously used and duly registered LIFETOUCH marks, again resulting in damage to Opposer.

17. Because of the closely related nature of the services, and the similarity of the marks, use and registration of the term LIVETOUCH by Applicant is likely to cause confusion, mistake, or deception that Applicant's services are those of Opposer, or are otherwise endorsed, sponsored, or approved by Opposer for use with Opposer's services causing further damage to Opposer.

18. If Applicant is granted registration of the mark herein opposed, it would thereby obtain at least a *prima facie* exclusive right to the use of its alleged mark. Such registration would be a source of further damage and injury to Opposer.

19. Registration of the mark shown in Application Serial No. 77/134,335 will result in damage to Opposer under the provisions of Section 2 of the U.S. Trademark Act, 15 U.S.C. Section 1052, pursuant to the allegations stated above.

WHEREFORE, Opposer asks that its opposition to this application be sustained and that registration of the term LIVETOUCH for the services set forth therein be refused.
