Applicant Absolutely Natural, Inc. requests this Board to dismiss Opposer Bach Flower Remedies Limited's opposition pursuant to Rule 528 of the Trademark Rules of Practice and Rule 56 of the Federal Rules of Civil Procedure. Applicant is entitled to judgment as a matter of law because Opposer's mark is weak and entitled to only a narrow scope. Opposer also lacks a statutory ground required for opposition of Applicant's mark. No genuine issue of any material fact exists. Thus, this Board should grant summary judgment in Applicant's favor, dismissing Bach Flower's opposition.

I. BACKGROUND

On August 19, 2010, Applicant Absolutely Natural, Inc. filed application serial number 85/111,156 under Section 1(b) of the Trademark Act to register the mark SUNBURN RESCUE in connection with "sun care lotions, balms, gels, cremes, liquids and sprays" and "retail stores featuring sun care lotions, balms, gels, cremes, liquids and sprays" in International Class 3 and 35 respectively.

The Application was published for opposition on February 8, 2011. Opposer Bach Flower Remedies Limited filed the Notice of Opposition on June 8, 2011, on the grounds of priority and likelihood of confusion pursuant to the Trademark Act section 2(d). Opposer cited five marks as a basis for the opposition, including;

1. RESCUE, Application Serial Number 77/485,289, filed on May 28, 2008, in Classes 003, 005, 029, 030, 032, 033.
2. RESCUE REMEDY, registered on May 10, 1983, with the registration number 1,237,564 in Class 032.
3. RESCUE REMEDY, registered on February 22, 1994, with the registration number 1,822,260 in Class 005.

4. RESCUE, registered on December 11, 2001, with the registration number 2,517,685 in Classes 005 and 030.
5. RESCUE CREAM, registered on September 26, 2006, with the registration number 3,147,761 in Class 005.

Opposer stated that it adopted and began using in commerce the marks RESCUE, RESCUE REMEDY and RESCUE CREAM for *homeopathic pharmaceutical preparations made from flower extracts, including skin cream preparations*, “[l]ong prior to the filing date of Application Serial No. 85/111,156 on August 19, 2010...” (Notice of Opp. Pg. 2). In the Opposition, the Opposer also stated that on May 28, 2008, Opposer filed Application Serial No. 77/485,289 to register the mark RESCUE for a range of herbal preparations and related goods, including *skin creams and moisturizers, and skin cleansers and skin toners* in Class 3.

Opposer concluded that, “Applicant is not lawfully entitled to the registration which it seeks for the reason, *inter alia*, that the mark SUNBURN RESCUE as used or intended for use in connection with Applicant’s goods/services so resembles Opposer’s previously used and registered marks RESCUE, RESCUE REMEDY and RESCUE CREAM and its earlier-filed application to register the mark RESCUE as to be likely to cause confusion, to cause mistake or to deceive within the meaning of Section 2(d) of the Federal Trademark Act, thereby damaging Opposer.” (Notice of Opp. Pg. 5).

Discovery opened on August 17, 2011. On January 25, 2012, Opposer filed a motion to extend the time of discovery by 30 days and reset the other trial dates. Applicant opposed the time extension but withdrew its objection on February 8, 2012 and the Board granted the extension pursuant to Trademark Rule 2.127(a).

There are fifty-three (53) marks registered and active in Class 3 that contain the word

RESCUE. Forty-eight (48) are live Registered Trademarks, and five (5) are live applications for registrations. Copies of the registration certifications making use of the mark RESCUE are attached as Applicants Exhibit's 100-147. Examples of these registered marks using the word RESCUE in Class 3 include; CONTINUOUS RESCUE, SUPER RESCUE, BUMP RESCUE, DAY RESCUE, RIGHT RESCUE, AGE RESCUE, A LOTIONAL RESCUE, etc., the majority of which are used for skin creams, moisturizers and cleansers.

Furthermore, the declaration of James C. Wray of McLean, VA counsel for the applicant, states that on January 31, 2012 he conducted an Internet search using the Google search engine and found fifty-seven (57) Internet advertisement listings for skin lotion and cream products using inter alia the word RESCUE as shown in Applicant's Exhibit 1001-1057 attached. The declaration of Jessica Bouwsma of Melbourne, FL, states that on February 7, 2012, she used these advisements and compiled a lists to produce the compilations shown in Applicant's Exhibit 1001-1057 showing skin lotion and cream products available on the Internet.

The declaration of Charles Richards of Melbourne Fl, president of Absolutely Natural, Inc. states that he found additional advertised products and also used the lists in Applicants Exhibits 1001-1057 and ordered products using the brand names including RESCUE and that Applicant's Exhibits 1001-1057 are photographs of products using a brand name including RESCUE. The declaration of Lindsey Barber of Melbourne, FL, Vice-President of Absolutely Natural, Inc., declares that Absolutely Natural purchased products that use brand names including RESCUE and that Applicant's Exhibits 1062-1079 are photographs she took of the products on May 4, 2012.

The Trial period for the Opposition opens May 31, 2012 and the Applicant has filed this motion for summary judgment as a salutary method to dispose of this case before trial.

II. DISCUSSION

a. Standard of Review

A motion for summary judgment is a pretrial device to dispose of cases in which “the pleadings, the discovery and disclosure materials on file, and any affidavits show that there is no genuine issue as to any material fact and that the movant is entitled to judgment as a matter of law.” Fed. R. Civ. P. 56(c). *See, e.g., Celotex Corp. v. Catrett*, 477 U.S. 317 (1986); *Anderson v. Liberty Lobby, Inc.*, 477 U.S. 242 (1986); *T.A.B. Systems v. PacTel Teletrac*, 37 USPQ2d 1879, 1881 (Fed. Cir. 1996); *Flatley v. Trump*, 11 USPQ2d 1284 (TTAB 1989).

On motion for summary judgment, a court may not resolve an issue of fact, but rather must determine whether there is any genuine issue of material fact in dispute, and, if not, render judgment in accordance with the law as applied to the established facts, or, if so, deny the motion and allow the case to proceed to a trial of the disputed facts.

Flatley, 11 USPQ2d 1284, 9 (citing 6 Moore's Federal Practice Par. 56.11 [1.-0], at 56-197 (2d ed. 1984).

The party moving for summary judgment has the burden of showing the absence of any genuine issue of material fact, and that it is entitled to judgment as a matter of law. *See Corporate Document Services Inc. v. I.C.E.D. Management Inc.*, 48 USPQ2d 1477, 1479 (TTAB 1998). This burden can be met by showing that there is an absence of evidence to support the nonmoving party's case, rather than negating opponent's claims. *Celotex*, 477 U.S. 317; *see also Anderson*, 477 U.S. 242 (holding that while movant has burden to establish absence of material fact, nonmovant still has burden to produce evidence establishing a genuine issue of material fact); *Enbridge, Inc. v. Excelerate Energy Limited Partnership*, 92 USPQ2d 1537, 1540 (TTAB 2009) (nonmovant must proffer countering evidence to show existence of genuine factual dispute for trial). The moving party has the initial burden of establishing the absence of any genuine

issue of material fact. *Celotex*, 477 U.S. 317; *see also Anderson*, 477 U.S. 242. When this initial burden has been met the burden shifts to the nonmoving party to produce sufficient evidence to support the claim that a genuine factual issue exists. *Celotex*, 477 U.S. 317; *see also Anderson*, 477 U.S. 242.

A fact is material if it “may affect the decision, whereby the finding of that fact is relevant and necessary to the proceedings.” *Opryland USA Inc. v. The Great American Music Show Inc.*, 23 USPQ2d 1471, 1472 (Fed. Cir. 1992) (dispute is genuine if evidence could lead reasonable finder of fact to decide question in favor of nonmovant); *see also Institut National Des Appellations d'Origine v. Brown-Forman Corp.*, 47 USPQ2d 1875, 1879 (TTAB 1998) (fact is material when its resolution would affect the outcome of the case). All doubts as to whether or not particular factual issues are genuinely in dispute must be resolved against the moving party. *Celotex*, 477 U.S. 317; *see also Anderson*, 477 U.S. 242. Similarly, all inferences to be drawn from the undisputed facts must be viewed in the light most favorable to the nonmoving party. *Celotex*, 477 U.S. 317; *see also Anderson*, 477 U.S. 242. However, a dispute over a fact that would not alter the Board’s decision on the legal issue will not prevent the Board from entering summary judgment. *See Kellogg Co. v. Pack'Em Enterprises Inc.*, 14 USPQ2d 1545 (TTAB 1990), *aff'd*, 951 F.2d 330, 21 USPQ2d 1142 (Fed. Cir. 1991) (holding a single *du Pont* factor of dissimilarity of marks outweighed all others such that other factors, even if decided in nonmovant's favor, would not be material because they would not change the result).

b. The Existence of Similar Third-Party Marks on Similar Goods Shows that Bach Flower's Mark is Relatively Weak and Entitled to Only a Narrow Scope of Protection.

An opposer must prove a statutory ground for opposition. *See Young v. AGB Corp.*, 152 F.3d 1377, 47 USPQ2d 1752, 1755 (Fed. Cir. 1998). One available ground for opposition is Trademark Act § 2(d), 15 U.S.C. § 1052(d), where the applicant's mark so resembles a mark registered in the Office as to be likely, when used on or in connection with the goods or services of the applicant, to cause confusion. *See, e.g., Palm Bay Imports Inc. v. Veuve Clicquot Ponsardin Maison Fondée En 1772*, 396 F.3d 1369 (Fed. Cir. 2005); *Miss Universe L.P., v. Community Marketing, Inc.*, 82 USPQ2d 1562 (TTAB 2007). In *Miss Universe*, this Board stated that its "likelihood of confusion determination under Section 2(d) is based on an analysis of all of the facts in evidence that are relevant to the factors bearing on the likelihood of confusion issue (the *du Pont* factors)." *Id.*

In re E.I. du Pont de Nemours & Co., provides the evidentiary factors this Board considers in determining likelihood of confusion. 476 F.2d 1357 (CCPA 1973); *see also Palm Bay*, 73 USPQ2d at 1692 (to determine whether the marks are similar for purposes of assessing the likelihood of confusion, the Board will consider the appearance, sound, connotation and commercial impression of each mark); *Giersch v. Scripps Networks Inc.*, 90 USPQ2d 1020 (TTAB 2009) (no likelihood of confusion found upon consideration of relevant factors); *Tea Board of India v. Republic of Tea Inc.*, 80 USPQ2d 1881, 1897 (TTAB 2006) (test for determining likelihood of confusion with respect to certification mark based on comparison of the mark as applied to the goods of the certification mark users). These factors include the similarity of the marks, the relatedness of the goods and/or services, the channels of trade and classes of purchasers for the goods and/or services, the number and nature of similar marks in

use on similar goods, the nature and extent of any actual confusion, and the fame of the prior mark. *Palm Bay Imports Inc* 73 USPQ2d at 1692.

In *Palm Bay Imps*, the Federal Circuit discussed the sixth DuPont factor, which considers “the number and nature of similar marks in use on similar goods.” 396 F.3d at 1373 (citing *DuPont*, 467 F.2d at 1361). The *Palm Bay* court held that, “[e]vidence of third-party use of similar marks on similar goods is relevant to show that a mark is relatively weak and entitled to only a narrow scope of protection.” *Id.* at 1373 (citing *General Mills, Inc. v. Kellogg Co.*, 824 F.2d 622, 626-27 (8th Cir. 1987); J. Thomas McCarthy, 2 McCarthy on Trademarks and Unfair Competition § 11: 88 (4th ed. 2001)).

The relevance and weight to be given the various factors may differ from case to case, but a single *du Pont* factor may be dispositive in certain cases. See *Odom’s Tennessee Pride Sausage, Inc. v. FF Acquisition, LLC*, 93 USPQ2d 2030, 2032 (Fed. Cir. 2010); *Shen Manufacturing Co. v. Ritz Hotel Ltd.*, 393 F.3d 1238, 73 USPQ2d 1350, 1353 (Fed. Cir. 2004) (“Neither we nor the board, however, need consider every *du Pont* factor”); *Boston Red Sox Baseball Club LP v. Sherman*, 88 USPQ2d 1581 (TTAB 2008).

The Federal Circuit has held that is it an error is a lower court fails to consider evidence of third-party use of service marks *Lloyd’s Food Products, Inc. v. Eli’s, Inc.*, 987 F.2d 766, 768 (Fed. Cir. 1993) (discussing phone directories). In *Sun Banks of Florida, Inc. v. Sun Federal Sav. & Loan Asso.*, the Fifth Circuit found that widespread use of the work “Sun” in names of financial institutions weakened the mark “Sun Banks,” so that the public was unlikely to confuse it with opposer’s mark “Sun Federal.” 651 F.2d 311, 317 (5th Cir. 1981) (“widespread use of the term which militates against a finding of likelihood of confusion”).

Here, the Bach Flower has challenged Absolutely Natural’s mark SUNBURN RESCUE on

the statutory ground of Trademark Act § 2(d), 15 U.S.C. § 1052(d). Bach Flower's marks are used for a range of herbal preparations and related goods, including skin creams, moisturizers and cleansers. (See Opp. P. 2). Bach Flower claims SUNBURN RESCUE is not lawfully entitled to registration because it would be likely to cause confusion with its own class 3 marks, RESCUE, RESCUE REMEDY and RESCUE CREAM. (See Opp. P. 5).

However, there are fifty three (53) marks registered and active in Class 3 that contain the word RESCUE. Forty eight (48) are live Registered Trademarks and five (5) are live applications for registrations. Copies of the registration certifications making use of the mark RESCUE are attached as Applicant Exhibits 100-147. Examples of these registered marks using the word RESCUE in Class 3 include; CONTINUOUS RESCUE, SUPER RESCUE, BUMP RESCUE, DAY RESCUE, RIGHT RESCUE, AGE RESCUE, A LOTIONAL RESCUE, etc., the majority of which are used for skin creams, moisturizes and cleansers.

Furthermore, an Internet search using Google search engine found fifty-seven (57) Internet advertisement listings for skin lotion and cream products using inter alia the word RESCUE. (see Applicant's Exhibit 1001-1057). Examples of these products include well-known brand names, such as VASELINE INTENSIVE RESCUE CLINICAL THERAPY SKIN PROTECTANT BIDY LOTION, CLINIQUE SUPER RESXUE ANTIOXIDANT NIGHT MOISTURIZER, GARNIER MOISTURE RESCUE and CHRISTIAN DIOR CAPTURE TOTALE INSTANT RESCUE EYE TREATMENT. Some of these products are shown in the photographs taken by Lindsey Barber of Melbourne, FL, Vice-President of Absolutely Natural, Inc., on May 4, 2012. (see Applicant's Exhibits 1062-1079).

The number and nature of similar marks in use on similar goods to weaken Bach Flower's marks and drastically narrows their scope, as in *Lloyd's Food Products* and *Sun Banks of*

Florida. The weakening of Bach Flower's marks and the narrowing of their scope of protection, prevents any likelihood of confusion with Absolutely Natural's mark. Thus, Opposer's likelihood of confusion argument is frivolous and without merit.

c. Bach Flower Lacks Proper Standing Because it has Only Asserted a Frivolous Likelihood of Confusion Claim as its Statutory Ground for Opposition.

To have standing, an opposer must show "real interest" in the proceedings. *Herbko International Inc. v. Kappa Books, Inc.*, 64 USPQ2d 1375, 1377 (Fed. Cir. 2002); *Ritchie v. Simpson*, 50 USPQ2d 1023, 1026 (Fed. Cir. 1999). To plead a "real interest," opposer must show a "direct and personal stake" in the outcome of the proceeding. *Ritchie*, 50 USPQ2d at 1026; *see also Corporacion Habanos S.A. v. Anncas Inc.*, 88 USPQ2d 1785 (TTAB 2008). Further, opposer's belief of damage must have a reasonable basis in fact. *Ritchie*, 170 F.3d at 50 (finding that the belief of damage alleged by plaintiff must be more than a subjective belief). Opposer must have a real commercial interest in their own mark and a reasonable basis for belief that it would be harmed. *National ass'n of certified home inspectors, inc. v. American society of home inspectors, inc.* (Opposition no. 91166484).

There is no requirement that actual damage be plead or proved "beyond that of the general public" in order to establish standing. *See Ritchie*, 170 F.3d at 50 ("The crux of the matter is not how many others share one's belief that one will be damaged by the registration, but whether that belief is reasonable and reflects a real interest in the issue"). However, allegations in support of standing which may be sufficient for pleading purpose must later be affirmatively proved by the opposer on summary judgment. *Ritchie*, 170 F.3d at 50; *Demon International LC v. Lynch*, 86 USPQ2d 1058 (TTAB 2008) (failure to prove standing); *Boswell v. Mavety Media Group Ltd.*, 52 USPQ2d 1600, 1605 (TTAB 1999) (at final decision, inquiry is not whether pleading of

standing is sufficient but whether allegations have been proven).

A real interest in the proceeding and a reasonable belief of damage may be found, where opposer pleads a claim of likelihood of confusion, but only if it's not wholly without merit. *Barbara's Bakery Inc. v. Landesman*, 82 USPQ2d 1283, 1285 (TTAB 2007) (standing established by properly making pleaded registration of record and asserting non-frivolous likelihood of confusion claim). Opposer's mark must be based upon current ownership of a valid and substantial registration, *Sinclair Oil Corp. v. Kendrick*, 85 USPQ2d 1032, 1037 n.10 (TTAB 2007) (opposer's allegations of ownership of pleaded registrations insufficient to prove standing), or prior use of a confusing similar mark. *Nextel Communications Inc. v. Motorola Inc.*, 91 USPQ2d 1393, 1400 (TTAB 2009).


Here, Bach Flowers claims to have a real interest in opposition because of the likelihood of confusion between its own RESCUE marks and Absolutely Natural's SUNBURN RESCUE mark. However, there is no direct and personal stake for Bach Flower in opposing this registration, because Bach Flowers would inure no benefit from denial of the Absolutely Natural mark's registration. Preventing Applicant's mark still leaves Class 3 full of marks using the word RESCUE. This also indicates that Bach Flower lacks a reasonable basis for damage because of denial of applicant's mark will not result in any better protection for Bach Flower's RESCUE marks. Thus, Bach Flower has no standing to oppose Absolutely Natural's mark.

Even with all inferences drawn from the undisputed facts, viewed in the light most favorable to the Bach Flower, there is no genuine issue of material fact at issue and Absolutely Natural is entitled to judgment as a matter of law. Therefore, this Board should grant Applicant's motion for summary judgment.

CONCLUSION

For the previously stated reasons, Applicant's motion for summary judgment should be granted and the Board should accordingly dismiss the current opposition.
