NOTICE OF OPPOSITION

Opposer, Ultimate Nutrition, Inc., with an address of 21 Hyde Road, Farmington, Connecticut 06034 believes that it is or will be damaged by the registration of the trademark ULTIMATE OXY, Ser. No. 85226472, and hereby opposes same. As grounds therefor, Opposer, by and through its undersigned attorneys, alleges as follows:

1. Opposer Ultimate Nutrition, Inc. (“Ultimate Nutrition” or “Opposer”) is a Connecticut corporation with its principal place of business at 21 Hyde Road, Farmington, Connecticut 06034.
2. Upon information and belief, Applicant Delta Direct Marketing, LLC (“Delta” or “Applicant”) is a limited liability company organized under the laws of the State of Delaware with its principal places of business at 113 Adler Street, West Babylon, New York 11704.

OPPOSER AND ITS TRADEMARKS

3. Ultimate Nutrition was founded in 1979 by Victor H. Rubino ("Rubino"). At the time Rubino was one of the top amateur power lifters in the United States.
4. Rubino knew that supplements were the key to improving his performance through increased strength and faster recovery. Since he was not satisfied with the current supplements that were available to him, Rubino launched his own company called Ultimate Nutrition.
5. In the late 1970's and early 1980's, Ultimate Nutrition was among the first companies to sell Amino Acid tablets, protein powders, carbohydrate powders, and various types of fat burners. By the late 1980's and early 1990's Ultimate Nutrition launched several legendary products such as Sports Energizer, an electrolyte fueled ready to drink beverage. By the mid 1990's Ultimate Nutrition again was on the cutting edge as one of the first companies to sell Whey Protein powder in a bottle.
6. Today, Ultimate Nutrition continues to excel with a wide range of products including ISO MASS XTREME GAINER, PROSTAR WHEY, MUSCLE JUICE 2544, GLUTAPURE, PROTEIN ISOLATE, ISO SENSATION 93, AMINO 2000, ULTRA RIPPED, HORSE POWER and RED ZONE.
7. Opposer is the owner of the mark ULTIMATE NUTRITION®, Reg. No. 1,541,169, for vitamins and nutritional food supplements. Said registration was issued on May 30, 1989, claims a date of first use of November, 1985, and is in full force and effect and is incontestable. (Exhibit A). Opposer is also the owner of four trademarks which it also uses in connection with its products and which feature ULTIMATE NUTRITION:

- a. ULTIMATE NUTRITION THE FUTURE OF SPORTS NUTRITION®, Reg. No. 3,088,065, for nutritional products namely dietary supplements, dated May 2, 2006 (Exhibit B);
- b. ULTIMATE NUTRITION® (stylized), Reg. No. 3,377,646, for vitamins and nutritional food supplements, dated February 5, 2008 (Exhibit C);
- c. ULTIMATE NUTRITON THE FUTURE OF SPORTS NUTRITION® (stylized), Reg. No. 3,503,661, for vitamins and nutritional food supplements, dated September 23, 2008 (Exhibit D); and
- d. ULTIMATE NUTRITION and Globe logo ®, Reg. No. 3909232, for dietary supplements; nutritional supplements; food supplements; vitamins, dated January 18, 2011 (Exhibit E).

8. Opposer has used ULTIMATE NUTRITION as a trademark, service mark, corporate name and trade name throughout the nation for over twenty (25) years. ULTIMATE NUTRITION is used as Plaintiff's house mark on nearly every one of its products.

9. Through widespread and favorable public acceptance and recognition, ULTIMATE NUTRITION has become an asset of substantial value as a symbol of Opposer, its quality products and services and its good will.

10. The mark ULTIMATE NUTRITION has always been used on products of the highest quality, and has developed secondary meaning and significance in the minds of the purchasing public.

11. Opposer is the current title sponsor for the Joe Weider's Mr. Olympia competition, which is the premier event in bodybuilding.

12. Products bearing the mark ULTIMATE NUTRITION are well-known and are immediately identified by the purchasing public with Opposer not only in the United States but around the world.

APPLICANT'S ACTIONS

13. Upon information and belief, on January 26, 2011, Applicant, an advertising and marketing company, filed an Intention to Use application to register the trademark ULTIMATE OXY, Ser. No. 85226472, for vitamins, mineral supplements, nutritional supplements, dietary supplements, herbal supplements, meal replacement bars; meal replacement drink mix; meal replacement drinks, food supplements and dieting pills and powder preparations to promote fat burning; none of the above for skin care and acne care ("Applicant's Mark").

PRIORITY AND LIKELIHOOD OF CONFUSION

14. Opposer repeats and re-alleges each and every allegation contained in paragraphs 1 through 13 as if fully set forth herein.

15. Opposer acquired rights in ULTIMATE NUTRITION as a trademark/service mark, corporate name, and trade name prior to any date on which Applicant can rely in connection with its goods bearing Applicant's Mark.

16. Applicant's Mark is identical and/or nearly identical and/or confusingly similar to Opposer's pleaded marks, trade name, and corporate name, individually and collectively, in appearance, sound, connotation and commercial impression.

17. The goods and services of the respective parties are similar and/or related in some manner, and/or the conditions and activities surrounding the marketing of the goods/services are such that they would or could be encountered by the same persons under circumstances that could give rise to the mistaken belief that they originate from the same source.

18. Applicant's goods bearing Applicant's Mark are sold in the same channels of trade and to the same consumers as Plaintiff's ULTIMATE NUTRITION product line.

19. Applicant's Mark, when used in connection with vitamins, mineral supplements, nutritional supplements, dietary supplements, herbal supplements, meal replacement bars; meal replacement drink mix; meal replacement drinks, food supplements and dieting pills and powder preparations to promote fat burning, is likely to cause confusion or mistake or to deceive and mislead the trade and the purchasing public into believing that Applicant's goods are the goods of Opposer, or that Applicant or its goods are authorized, licensed or controlled by Opposer, or that Applicant is affiliated with or in some way related to Opposer.

APPLICANT DOES NOT HAVE AN INTENTION TO USE

20. Opposer repeats and re-alleges each and every allegation contained in paragraphs 1 through 19 as if fully set forth herein.

21. Upon information and belief, at the time of filing its application to register the mark ULTIMATE OXY, Ser. No. 85226472, Applicant did not have an intention to use

its trademark ULTIMATE OXY for any of the goods set forth in its application to register the same mark, Ser. No. 85226472.

22. Upon information and belief, at the time of filing its application to register the mark ULTIMATE OXY, Ser. No. 85226472, Applicant did not have an intention to use its trademark ULTIMATE OXY for all of the goods set forth in its application to register the same mark, Ser. No. 85226472.

23. By reason of the foregoing, Opposer is and will continue to be damaged by the registration of Applicant's Mark.

WHEREFORE, it is respectfully requested that this opposition be sustained and that the Board refuse to register Applicant's trademark ULTIMATE OXY, as reflected in Ser. No. 85226472.




