NOTICE OF OPPOSITION

In the matter of the application of Ariel Popoy (“Applicant”), for registration of the mark



COMPETITIVE EDGE APPAREL, application Serial No. 85/222,514, published in the Official Gazette on June 7, 2011, Nike Global Services Pte. Ltd. (“Opposer”), a corporation organized under the laws of Singapore, with its principal place of business at Block 1, Temasek Avenue, Millenia Tower, Singapore 039192, Singapore, believes that it will be damaged by registration of the mark shown in Serial No. 85/222,514 and hereby opposes registration.

The grounds for opposition are as follows:

1. Opposer is a corporation, doing business as Nike Global Services Pte. Ltd., organized under the laws of Singapore, with its principal place of business at Block 1, Temasek Avenue, Millenia Tower, Singapore 039192, Singapore. Hereinafter, in regards to statements regarding use of trademarks, the term “Opposer” may include Nike Global Services Pte. Ltd., Opposer’s predecessor in interest, and/or Opposer’s licensees and other authorized distributors, as appropriate.

2. Opposer has been and continues to be engaged in the business of designing, marketing and selling clothing, sports clothing, sporting goods, sports accessories, bags, and other related goods and services in the United States and abroad.

3. For over 40 years, Opposer has used in interstate commerce marks consisting solely of, or including, a diamond design (the “Umbro Marks”) to identify clothing, sports clothing, sporting goods, sports accessories, bags, and other related goods and services originating from the Opposer. For example,

as shown in U.S. Reg. No. 929,212 for  , Opposer first used a diamond design at least as early as 1931, and first used a diamond design in commerce in 1964. Further, Opposer has continuously used in interstate commerce marks consisting solely of, or including, a double diamond design, including but

not limited to  , to identify clothing, sports clothing, sporting goods, sports accessories, bags, and other related goods and services originating from the Opposer.

4. Opposer has common law rights and trademark registrations for the Umbro Marks, including the following United States trademark registrations for some of its Umbro Marks:

5. In addition to the Umbro Marks, Opposer has applied for or may have common law rights in additional marks, for use in connection with clothing, accessories and sporting goods items, and other

related goods and services, including but not limited to:  ,



6. Opposer has used and continues to use the Umbro Marks and the goods in connection therewith have been popular and the subject of significant advertising and promotional activities.

7. Opposer has promoted and sold its goods in interstate commerce under its Umbro Marks since prior to any alleged use by Applicant of the mark shown in the Application.

8. The use of Opposer's Umbro's Marks has been valid and continuous since the dates of first use and Opposer has not abandoned the Umbro Marks. Opposer's Umbro Marks are symbolic of extensive goodwill and consumer recognition built up by Opposer through substantial amounts of time and effort in advertising and promotion. Opposer's Umbro Marks identify and distinguish Opposer's goods from the goods of others, and identify the source and origin thereof to both the trade and the public.

9. Prior to Applicant's adoption of its mark, Opposer's Umbro Marks have been used and promoted in such a way as to create a public perception that a diamond design, and in particular a double diamond design, is an indication of source.

10. Opposer's Umbro Marks have become well known and famous.

11. Notwithstanding Opposer's rights in and to its Umbro Marks, Applicant, on January 20,



2011, filed an application for registration of the mark **COMPETITIVE EDGE APPAREL**. Applicant's application was given Serial No. 85/222,514 and was published for opposition in the Official Gazette on June 7, 2011.



12. The published application for the mark **COMPETITIVE EDGE APPAREL** includes the following goods and services:

Baseball caps; jerseys; shoes; sport shirts; sports caps and hats; sports jackets; sports jerseys; sports overuniforms; sport pants; sport shirts; sports shirts with short sleeves; uniforms in International Class 025.

13. Applicant does not claim a date of first use, and no statement of use has been filed with the USPTO.

14. Applicant's first use date will be subsequent to Opposer's first use of at least some of the Umbro Marks.

15. Applicant's filing date is subsequent to Opposer's filing date for each of the Umbro Marks.

16. Applicant's recited goods are closely related to the goods offered by Opposer for the Umbro Marks and consumers may be confused as to source of the goods.



17. Applicant's mark **COMPETITIVE EDGE APPAREL**, when used in connection with the goods set forth in its application, is confusingly similar to Opposer's use of its Umbro Marks. Registration of Applicant's mark and use by it for its goods in the U.S. is likely to cause confusion, mistake and deception among consumers. Registration of Applicant's mark may damage the goodwill and consumer recognition that Opposer has built up in its Umbro Marks.

18. Applicant's mark dilutes or is likely to dilute or will dilute Opposer's distinctive and famous Umbro Marks in violation of Section 43(c) of the Act.

19. Commercial use of the Applicant's mark will cause or is likely to cause dilution of the distinctive quality of Opposer's well known and famous Umbro Marks.

WHEREFORE, Opposer believes that it will be damaged by registration of Applicant's mark, and prays that registration be denied.

Opposer authorizes the Commissioner for Trademarks to charge the fee for filing this Notice of Opposition, or any other additional fees that may be due, to Deposit Account 504816.






