NOTICE OF OPPOSITION

Suzanne Collins (“Opposer”), by and through her attorneys, believing that she will be damaged by the registration of Application Serial No. 85/163,636 for the mark “KATNISS EVERDEEN,” hereby opposes this application pursuant to 37 CFR § 2.104(b). Allegations with respect to Opposer are based on actual knowledge. Allegations with respect to Applicant are based on information and belief. The grounds for opposition are as follows:

THE PARTIES

1. Opposer is an individual and is a world-renowned author residing in Sandy Hook, Connecticut, United States.
2. Applicant Wasp Enterprises, LLC (“Applicant”) is a limited liability company organized and existing under the laws of the State of Nevada with a business address of 1445 America Pacific Drive, No. 110-377, Henderson, NV 89074.

THE HUNGER GAMES TRILOGY AND “KATNISS EVERDEEN”

3. Opposer is the author of the vastly popular *The Hunger Games* trilogy (“the Trilogy”), which is a young-adult adventure science fiction series. The first book in the series was first published on October 1, 2008.

4. The Trilogy consists of three books: *The Hunger Games*, *Catching Fire*, and *Mockingjay*.

5. The Trilogy has achieved phenomenal success:

- a. The first two books were each *New York Times* best sellers, and *Mockingjay* topped all US bestseller lists upon its release.
- b. There are more than 9.6 million copies of all three books in print in the United States.
- c. The Trilogy has spent more than 130 consecutive weeks on *The New York Times* bestseller list since publication in September 2008, and has also appeared consistently on *USA Today* and *Publishers Weekly* bestseller lists.
- d. Foreign publishing rights for the Trilogy have been sold into forty-two (42) territories to date.

6. “KATNISS EVERDEEN” is the main character and heroine of the Trilogy.

7. The name “KATNISS EVERDEEN” first appeared in commerce in the first book of the Trilogy (*The Hunger Games*), which was published in October 2008.

8. Opposer is the owner of record of various word marks for “KATNISS EVERDEEN” (collectively, “the KATNISS EVERDEEN Marks”):

- a. Serial No. 85/278,813 filed March 28, 2011 in International Class 028 (United States classes 022, 023, 038, and 050) for “games and playthings, gymnastic

apparatus and sporting articles (except clothing), standing alone video game machines, hand-held computer games” (“the ’813 Mark”). A true and correct copy of information from TDR for the ’813 Mark is attached hereto as Exhibit A.

b. Serial No. 85/278,781 filed March 28, 2011 in International Class 025 (United States classes 022 and 039) for “clothing, footwear and headwear” (“the ’781 Mark”). A true and correct copy of information from TDR for the ’781 Mark is attached hereto as Exhibit B.

c. Serial No. 85/278,754 filed March 28, 2011 in International Class 016 (United States classes 002, 005, 022, 023, 029, 037, 038, and 050) for “paper and paper articles, cardboard and cardboard articles, printed matter, newspaper and periodicals, books, photographs, stationery; pens, pencils, pen and pencil cases; erasers; rubber stamps; iron-on transfers” (“the ’754 Mark”). A true and correct copy of information from TDR for the ’754 Mark is attached hereto as Exhibit C.

APPLICANT’S “KATNISS EVERDEEN” APPLICATION

9. Applicant filed an intent-to-use application for the mark “KATNISS EVERDEEN” on October 28, 2010 and assigned Serial No. 85/163,636 (“the Opposed Mark”). A true and correct copy of information from TDR for the Opposed Mark is attached hereto as Exhibit D. Applicant seeks registration of the Opposed Mark in four International Classes:

- a. 003 (United States classes 001, 004, 006, 050, 051, and 052);
- b. 009 (United States classes 021, 023, 026, 036, and 038);
- c. 016 (United States classes 002, 005, 022, 023, 029, 037, 038, 050); and

d. 025 (United States classes 022, 039).

10. Opposer began using the name “KATNISS EVERDEEN” at least as early as October 1, 2008, more than two years before Applicant filed its intent-to-use application for the Opposed Mark. Since its first appearance, Opposer has been continually using the KATNISS EVERDEEN name and mark in commerce in connection with the advertising, promotion, sale, and offering of the Trilogy in interstate commerce.

11. As a result of extensive use, advertising, and promotion of the name “KATNISS EVERDEEN” in interstate commerce, Opposer is the owner of significant common law rights in the KATNISS EVERDEEN name and mark.

12. As a result of extensive publicity, use, advertising, and promotion, the “KATNISS EVERDEEN” name and mark, have become well known to the general public and trade. *See, e.g.,* <http://thehungergames.wikia.com/wiki/Katniss>; http://en.wikipedia.org/wiki/Katniss_Everdeeen#Critical_reception; <http://www.facebook.com/pages/Katniss-Everdeen/234814003480>; <http://www.imdb.com/character/ch0244941/bio>.

13. Due to the vast popularity of the Trilogy, the term “KATNISS EVERDEEN” has acquired distinctiveness and secondary meaning. The term “KATNISS EVERDEEN” has come to signify a strong, fierce, feminine personality originating exclusively with Opposer, and has become a valuable symbol of Opposer’s good will.

14. In light of such good will and public association of the name “KATNISS EVERDEEN” with Opposer, Opposer is entitled to the exclusive right to use the “KATNISS EVERDEEN” name and mark and any confusingly similar mark, such as the Opposed Mark, should not be entitled to registration without the authorization of Opposer.

15. Upon information and belief, Applicant chose “KATNISS EVERDEEN” for the Opposed Mark with bad faith intent to appropriate for its own benefit the good will of Opposer generated from the popularity of the Trilogy, especially the heroine thereof. Specifically, Opposer believes that Applicant filed for the Opposed Mark based on the fact that, on March 18, 2009, it was announced that the Trilogy would appear in film. *See, e.g.*, <http://www.comingsoon.net/news/movienews.php?id=53788>.

16. The Opposed Mark is identical to and confusingly similar in sound, appearance, connotation and commercial impression to “KATNISS EVERDEEN,” a character in the Trilogy, as well as the KATNISS EVERDEEN Marks.

17. Specifically, the goods for which Applicant seeks to register the Opposed Mark are similar and/or related to the goods in connection with which Opposer has and intends to use the KATNISS EVERDEEN Marks, and are and/or will be sold and/or offered through the same and/or similar channels of trade, and/or to the same general class of purchasers, in and to which Opposer’s goods are or will be marketed and/or sold.

18. The Opposed Mark so resembles the character “KATNISS EVERDEEN” and the KATNISS EVERDEEN Marks as to (a) be deceptive within the meaning of Section 2(a) of the Lanham Act, 15 U.S.C. § 1052(a); (b) constitute a false suggestion of a connection with Opposer within the meaning of Section 2(a) of the Lanham Act, 15 U.S.C. § 1052(a); (c) likely cause confusion, mistake, or deception within the meaning of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d); and/or (d) constitute dilution by blurring within the meaning of Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).

19. Opposer will be injured and damaged by the registration of the Opposed Mark because the Opposed Mark, when used in connection with Applicant’s goods and services, is

likely (a) to cause confusion or to cause mistake, (b) to deceive as to some association between Applicant and Opposer and/or the goods provided by each; (c) to falsely suggest a connection or association with Opposer and/or Opposer's goods; (d) damage Opposer's valuable good will in "KATNISS EVERDEEN"; and (e) dilute the distinctive qualities of the KATNISS EVERDEEN Marks.

WHEREFORE, Opposer believes it will be damaged by the registration of the claimed trademark in Application Serial No. 85/163,636, and respectfully requests that such registration be denied.
