Applicant's consented motion (filed March 28, 2014) to suspend this proceeding for 90 days is granted. The parties are reminded that there is a continuing obligation to provide good cause in the form of progress reports for any further extension or suspension request.

Because the parties are negotiating for a possible settlement of this case, proceedings are suspended, subject to the right of either party to request resumption at any time. See Trademark Rules 2.117(c), and 2.127(a); and TBMP § 605.02.

In the event that there is no word from either party concerning the progress of their negotiations, upon conclusion of the suspension period, proceedings shall resume without further notice or order from the Board, upon the schedule set forth below.

Applicant is allowed until July 3, 2014 in which to answer the notice of opposition. Conferencing, disclosure, discovery and trial dates are reset as follows:

In each instance, a copy of the transcript of testimony together with copies of documentary exhibits, must be served on the adverse party within thirty days after completion of the taking of testimony. Trademark Rule 2.125.

Briefs shall be filed in accordance with Trademark Rules 2.128(a) and (b). An oral hearing will be set only upon request filed as provided by Trademark Rule 2.129.
