

The grounds for opposition are as follows:

1. Opposer markets, distributes, and sells, throughout the world and in commerce fashionable eyewear, including, but not limited to, sunglasses, spectacles (eyeglasses) and sport goggles, and parts and accessories therefore (referred to collectively as “Opposer’s Goods”), in connection with the trademark “CARRERA”.

2. As reflected in the records of the United States Patent and Trademark Office (USPTO), Opposer is the owner of the valid and subsisting registrations identified in the table below (hereinafter “Opposer’s Registrations”) and will rely on said registrations. All of the listed registrations are incontestable. Computer-generated copies of the following registrations printed from the USPTO’s TARR internet website pages at <http://tarr.uspto.gov/> are attached hereto collectively as Exhibit A.

Opposer’s “CARRERA” trademarks listed in the foregoing table above are collectively referred to as “Opposer’s Marks”.

3. Copies of the assignment information for Opposer’s Registrations printed from the USPTO “Assignments on the Web (AOTW)” website pages at <http://assignments.uspto.gov/assignments/q?db=tm> are attached hereto as Exhibit B.

4. Since prior to the filing date of the application opposed herein and for many years, Opposer has, and is now, engaged in the distribution and sale of Opposer’s Goods under Opposer’s Marks, in the United States and internationally. Opposer has used Opposer’s Marks in United States commerce in connection with Opposer’s Goods and to identify and designate same, and to distinguish those goods, and Opposer’s business, from those of others.

5. By virtue of the continuous offering and promotion of Opposer’s Goods under Opposer’s Marks and by virtue of maintenance of the high quality and standards

relating thereto, consumers and others have come to recognize Opposer's Marks as an indication of origin and source for various goods. Consequently, Opposer has established valuable goodwill and exclusive rights in Opposer's Marks as it pertains to Opposer's Goods.

6. Opposer's Goods include its fashionable sunglasses and eyewear, which can be seen, for example, at the website pages:

7. Through its efforts and expenditures, Opposer's Marks have acquired a good and valuable reputation, and have acquired a high degree of strength and acquired distinctiveness.

8. As reflected in the records of the USPTO, Applicant is the owner of Trademark Application No. 76/403,836, for "PILI CARRERA" filed by Applicant on May 6, 2002, in International Class 25 for Applicant's Goods, namely, "footwear, namely, boots, shoes and sandals; clothing, namely, belts, blazers, blouses, cardigans, jeans, over coats, sports coats, gloves, golf shirts, leather jackets, neckties, polo shirts, pullovers, socks, sweatshirts, skirts, t-shirts." A computer-generated copy of Trademark Application Serial No. 76/403,836 printed from the USPTO's TARR internet website pages at <http://tarr.uspto.gov/> is attached hereto as Exhibit C.

9. Applicant's Mark so resembles Opposer's Marks as to be likely, when used in connection with Applicant's Goods in International Class 25, to cause confusion, to cause mistake, or to deceive, with respect to the origin, authorization or sponsorship of

Opposer's Goods and Applicant's Goods.

10. A likelihood of confusion exists between Applicant's Mark and Opposer's Marks. Applicant's Mark and Opposer's Marks are likely to be confused by relevant consumers and members of the trade due to the close similar overall commercial impression created by Applicant's Mark and Opposer's Marks, including the shared identical portion "CARRERA".

11. Applicant's Goods are similar to, or related to, Opposer's Goods.

12. Applicant's Goods and Opposer's Goods are targeted to or would likely be targeted to or used by similar customers and/or purchasers.

13. Applicant's Goods are offered through or would likely be offered through channels of trade similar to the channels through which Opposer's Goods are offered.

14. A consumer familiar with the goods offered under Opposer's Marks, upon seeing Applicant's Marks used in connection with the goods for which Applicant seeks registration in International Class 25, would likely be confused that Applicant's goods are associated with, sponsored by, or licensed from Opposer, which they are not.

15. Any defect, objection or fault found with Applicant's Goods offered under Applicant's Mark would necessarily reflect upon and seriously injure the reputation Opposer has established for its goods marketed under Opposer's Marks.

16. If the Applicant is permitted to use and register Applicant's Mark for the goods specified in the Application in International Class 25, the resulting confusion will harm and damage Opposer and the goodwill established in Opposer's Marks.

17. If Applicant is granted the Registration herein opposed for the goods listed

in International Class 25, Applicant would thereby obtain at least a *prima facie* exclusive right of use of its mark and such Registration would be a source of damage and injury to Opposer.

18. For the foregoing reasons, Opposer would be damaged by the registration of Applicant's Mark in International Class 25, and respectfully requests that its opposition be granted.

WHEREFORE, Opposer prays that Application Serial Number 76/403,836 be rejected for the goods listed in International Class 25, that this opposition is sustained as to those goods in International Class 25, and that Applicant's Mark for the goods in International Class 25 be denied and refused.
