**STIPULATION REGARDING READING AND SIGNING  
OF MOTOHIRO FUJITA’S DEPOSITION TRANSCRIPT**

Applicant Honda Giken Kogyo Kabushiki Kaisha (“Honda”) and Opposers Briggs & Stratton Corporation (“Briggs”) and Kohler Co. (“Kohler”) (collectively, “Opposers”) (collectively, “Parties”), by and through their respective counsel of record, hereby stipulate and agree as follows:

1. On December 3, 2014, Opposers served a Notice of Continued Taking of Deposition of Honda pursuant to Federal Rule of Civil Procedure 30(b)(6) (“30(b)(6) Notice”).

2. Honda designated Mr. Motohiro Fujita, a resident of Japan and native Japanese speaker, to testify on behalf of Honda with respect to certain topics identified in the 30(b)(6) Notice.

3. On December 10, 2014, Mr. Fujita appeared for a discovery deposition pursuant to the 30(b)(6) Notice and testified through a translator.

4. On December 12, 2014, Honda served a Notice of Testimonial Deposition of Motohiro Fujita.

5. By agreement of the parties, and to obviate Mr. Fujita's need to return to the United States during Honda's trial period for a second deposition, Mr. Fujita gave trial testimony through a translator on December 12, 2014.

6. Opposers and Honda agree that the official discovery deposition transcript should be amended to reflect the following corrections:

- a. On page 55, line 13, "checks" should be "text" to correct a transcription error.
- b. On page 57, line 18, "numbers" should be "styles" to provide clarification.

7. Opposers and Honda further agree that the trial deposition transcript should be amended to reflect the following corrections:

- a. On page 2, line 21, "Opposers" should be replaced with "Applicant" to correct a transcription error.
- b. On page 9, line 13, "motor" should be replaced with "matter" to correct a transcription error.
- c. On page 105, line 3, "did not" should be inserted between "I" and "read" to provide clarification.

8. For the convenience of the Parties and Mr. Fujita, Opposers and Honda agree that Mr. Fujita did not request to read or sign the transcript of his discovery or trial depositions and that any requirement that he do so is hereby waived.
