


Exhibit B. Applicant's U.S. usage of POPNGO YOUR LIFE YOUR STYLE




Exhibit C. Third party usage of YOUR LIFE YOUR STYLE in various industries




Exhibit B. Applicant's U.S. usage of YOUR LIFE YOUR STYLE




Exhibit C. Third party usage of YOUR LIFE YOUR STYLE in various industries
