**NOTICE OF OPPOSITION**

Opposer, INFINITY STAFFING SOLUTIONS, LLC (“OPPOSER”), a Florida limited liability company whose principal place of business is located at 917 Fremont Avenue, Winter Park, Florida 32790, will be damaged by the registration of the mark shown in the above-identified application, and hereby opposes same.

The grounds for opposition are as follows:

1. Applicant, INFINITY STAFFING SOLUTIONS, LLC (“APPLICANT”), a New Jersey limited liability company, was organized as

a New Jersey limited liability company on March 26, 2010. Please see the attached document from the "State of New Jersey, Department of the Treasury, Short Form Standing," a true and correct copy of which is attached hereto as Exhibit "A."

2. At some time between March 26, 2010, and June 4, 2010, APPLICANT attempted to register to transact business in Florida under the name "Infinity Staffing Solutions, LLC." In response to APPLICANT'S attempt, the Florida Department of State, Division of Corporations issued a letter dated June 4, 2010 (a true and correct copy of which is attached hereto as Exhibit "B"), indicating that the name "Infinity Staffing Solutions, LLC" was not available in Florida.

3. Indeed, OPPOSER had been doing business as Infinity Staffing Solutions, LLC, a Florida limited liability company, since at least December, 2009. OPPOSER'S existence in Florida was the cause of the Florida Department of State, Division of Corporations' rejection of APPLICANT'S registration to transact business in Florida under the name, Infinity Staffing Solutions, LLC.

4. Unable to do business in Florida as Infinity Staffing Solutions, LLC, APPLICANT'S managing member, on September 21, 2010, executed a "Written Consent to Adopt Alternative Name for Use in the State of Florida" (a true and correct copy of which is attached hereto as Exhibit "C"), in which it agreed to transact business in Florida as "Infinity Staffing of NJ, LLC." On September 27, 2010, APPLICANT then filed as a Foreign Limited Liability Company in Florida under the name, Infinity Staffing of NJ, LLC.

5. Notwithstanding the Written Consent attached hereto as Exhibit "C," in which APPLICANT agreed to do business in Florida as "Infinity Staffing of NJ, LLC," APPLICANT and its agents misrepresented to third parties that APPLICANT was "Infinity Staffing Solutions, LLC," when dealing with potential customers in the Florida market, causing confusion between APPLICANT and OPPOSER.

6. On or about December 22, 2010, APPLICANT filed its Trademark/Service Mark Application, Principal Register, for the mark, INFINITY STAFFING SOLUTIONS (hereinafter, the "Mark"), Serial Number 85203774, using the USPTO's TEAS Plus Application. A true and correct copy of the above-referenced Application is attached hereto as

Exhibit "D." In its original application, APPLICANT responded to the following inquiries with the following responses:

**FIRST USE ANYWHERE DATE: At least as early as 05/12/2010.**

**FIRST USE IN COMMERCE DATE: At least as early as 05/12/2010.**

7. These dates are consistent with APPLICANT'S creation as a New Jersey limited liability company in March, 2010, and its attempt to register to do business in Florida between March, 2010, and June 4, 2010.

8. The Application states that the Mark's international class is IC 035, and its identification is "[e]mployment agency services, namely, filling the temporary and permanent staffing needs of businesses."

9. OPPOSER's is involved in the exact same business as APPLICANT, providing employment agents services, namely, filling temporary and permanent staffing needs of businesses.

10. APPLICANT'S mark, INFINITY STAFFING SOLUTIONS, is identical to OPPOSER'S name and common law mark, INFINITY STAFFING SOLUTIONS. As set forth herein, OPPOSER'S use of the name and common law mark, Infinity Staffing Solutions, predated APPLICANT'S use of the identical mark.

11. The Application contains an incorrect, false, misleading, and/or fraudulent Declaration regarding the Mark. Specifically, but without limitation, APPLICANT, through its former attorney, John J. O'Malley swore that "to the best of his/her knowledge and belief no other person, firm, corporation, or association has the right to use the mark in commerce, either in the identical form thereof or in such near resemblance thereto as to be likely, when used on or in connection with the goods/services of such other person, to cause confusion, or to cause mistake, or to deceive..." APPLICANT'S attorney also signed and agreed that "willful false statements and the like so made are punishable by fine or imprisonment, or both . . . and that such willful false statements, and the like, may jeopardize the validity of the application or any resulting registration . . ."

12. Specifically, but without limitation, as discussed in paragraph 2, above, at the time that APPLICANT filed its Application on December 22, 2010, it had actual knowledge that OPPOSER held the owned and held the mark and company name of "Infinity Staffing Solutions, LLC" in Florida, and had such knowledge for at least six months six (6) months before APPLICANT filed its application when the Florida Department of State, Division of Corporations, denied APPLICANT'S attempt to register under

the name “Infinity Staffing Solutions, LLC.” As such, the statements in the Application referenced in paragraph 11 herein are incorrect, false, misleading, and/or fraudulent because APPLICANT had actual knowledge of OPPOSER’S use of the common law mark, INFINITY STAFFING SOLUTIONS, when it was unable to register to do business in Florida using that name.

13. Further, OPPOSER has raised these issues with APPLICANT regarding APPLICANT’S use of “Infinity Staffing Solutions, LLC” in Florida and has had several conversations with Jim Radvaney, one of the principals of the APPLICANT regarding these issues. Jim Radvaney first contacted OPPOSER on or about January 11, 2011, regarding OPPOSER’S ownership and use of “Infinity Staffing Solutions” in Florida. Thereafter, OPPOSER and APPLICANT (through Jim Radvaney) had several other conversations over a period of several months wherein the parties negotiated in an attempt to resolve this dispute.

14. On or about May 17, 2011, the United States Patent and Trademark Office issued a Notice of Publication regarding APPLICANT’S application, stating that the mark INFINITY STAFFING SOLUTIONS was published on May 17, 2011, and any party who believes it will be damaged

by the registration of the mark may file a notice of opposition within thirty (30) days after the publication date. A true and correct copy of the Notice of Publication is attached hereto as Exhibit "E".

15. On June 16, 2011, OPPOSER filed its "First 90 Day Request for Extension of Time to Oppose for Good Cause." As shown by the June 16, 2011, correspondence attached hereto as Exhibit "F," the extension was granted until September 14, 2011.

16. OPPOSER'S rights regarding first use of the mark INFINITY STAFFING SOLUTIONS predates and are superior to APPLICANT'S rights for the reasons discussed herein.

17. APPLICANT is and has been primarily a company based and operating in the northeastern United States. APPLICANT'S own web site demonstrates (or showed as of June 15, 2011) that APPLICANT had offices mainly in New Jersey, New York, Pennsylvania, Massachusetts, Delaware, Connecticut, and the District of Columbia. It has (or had as of June 15, 2011) only three (3) offices in Florida – one (1) in St. Petersburg, one (1) in Jacksonville, and one (1) in Miami, Florida. A true and correct copy of a printout from APPLICANT'S web site detailing such information as of June 15, 2011, is attached hereto as Exhibit "G."

18. When APPLICANT registered to transact business in Florida on September 27, 2010, as Infinity Staffing of NJ, LLC, it had actual knowledge that OPPOSER already transacted business under the name "Infinity Staffing Solutions, LLC" in Florida.

— 19. Due to APPLICANT'S actions described herein, there has been confusion and will continue to be confusion regarding APPLICANT'S use of the Mark. APPLICANT'S registration of the mark will exacerbate and heighten the confusion regarding the parties' concurrent use of the Mark.

20. Concurrently with the submission of this Notice of Opposition, the OPPOSER, through its undersigned counsel, has submitted the requisite filing fee.

**WHEREFORE**, Opposer, INFINITY STAFFING SOLUTIONS, LLC, respectfully requests that this Trademark Trial and Appeal Board deny the Application submitted by Applicant, INFINITY STAFFING SOLUTIONS, LLC.






