CONSENT MOTION TO AMEND APPLICANT'S APPLICATION


In view of the settlement between the parties and pursuant to Trademark Rule 2.133(a), Opposer, JKL Partners LLC, and Applicant, Addriya Yoga, LLC, respectfully request that the description of goods and services set forth in Application Serial No. 85/078,567 for the mark ADDRIYA be amended as follows.

International Class 25 shall be deleted from the application in its entirety.


