RESPONSE TO BOARD’S ORDER

This paper responds to the TTAB’s order mailed April 18, 2012. On April 12, 2012 Applicant Alliance Armament, LLC (“Alliance”) withdrew its application Serial No. 85/053,918 with prejudice. Opposer, Olin Corporation, (“Olin”) gave its consent to this action by Alliance.

As of April 12, 2012 there was no pending application to be opposed. Nevertheless, the agreement of the parties, made through their counsel, required that Olin formally withdraw its opposition. Accordingly, on April 13, 2012, Olin withdrew its opposition against U.S. Trademark Application Serial No. 85/053,918 without prejudice. At that time, Alliance had provided Olin with written consent to the Withdrawal of the Opposition, but the written consent was not filed with the Board. Accordingly, in response to the Board’s April 18, 2012 Order, and pursuant to Trademark Rule 2.106(c), Olin reiterates its withdrawal of the opposition and attaches Applicant’s written consent hereto.

WHEREFORE, Olin, with the consent of Alliance, withdraws its opposition to Application Serial No. 85/053,918, without prejudice, each party to bear its own fees and costs.
