STIPULATION FOR SERVICE OF ADDITIONAL INTERROGATORIES

4) Petitioner agrees to supply responses to any Respondent interrogatories that are re-submitted from Respondent's withdrawn Second Set of Interrogatories within ten (10) business days after service.


By this Stipulation, neither party waives their respective rights and remedies with regard to the Interrogatories in any manner, and hereby expressly reserves them.
