2. The application which is the subject of this opposition was filed on August 29, 2011 on the basis of intent to use. Applicant claims no date earlier than August 29, 2011 for the purpose of priority.

3. Opposer is and has been engaged in the development, manufacture and sale of hair care preparations and hair styling preparations and has built a successful business in connection therewith.

4. Since at least as early as June 15, 1998, Opposer, itself and through its predecessor in interest, has used "SEXY" and "SEXY HAIR" as names and marks and as the dominant element of its names and marks for hair care preparations.

5. The nature and extent of Opposer's use of its "SEXY" and "SEXY HAIR" names and marks can be seen at its website, www.sexyhair.com.

6. Opposer has taken steps to protect its "SEXY" and "SEXY HAIR" marks and has secured U.S. Trademark Registration Nos. 2,403,396; 3,478,939; 3,539,680; and 3,927,766 for the marks for the hair care and hair styling preparations identified therein. Registration No. 2,403,396 is valid and subsisting and incontestable. A copy of the pertinent information about such registrations from the USPTO database showing status and title is attached as Exhibit A.

7. The BIGSEXYHAIR product line was the first of the SEXY HAIR-branded product lines, and the BIGSEXYHAIR mark has been in continuous use since at least as early as December 31, 1998.

8. The "SEXY" and "SEXY HAIR" names and marks, including the BIGSEXYHAIR mark, are inherently distinctive as applied to Opposer's hair care and hair styling preparations and have acquired distinctiveness by virtue of significant, continuous,

substantially exclusive use in commerce by virtue of and the recognition of the names and marks by the relevant public.

9. By virtue of Opposer's continuous use in commerce of its registered "SEXY" and "SEXY HAIR" trademarks, including "BIGSEXYHAIR" and its use of the Sexy and Sexy Hair names in connection with its goods and business, and the nature and extent of such use, such goods and business have become favorably known to the relevant trade and public under such marks and names and identify the goods and business of Opposer.

10. As Opposer is the owner of subsisting U.S. trademark registrations for its "SEXY" and "SEXY HAIR" marks, priority is not in issue.

11. In the application herein opposed, there are no restrictions on trade channels, so it must be presumed that the hair care and hair styling preparations identified in the application will travel through all trade channels appropriate for goods of that type.

12. Applicant's mark when used in connection with hair care and hair styling preparations is confusingly similar to Opposer's registered "SEXY" and "SEXY HAIR" trademarks and to Opposer's family of "SEXY" marks and to Opposer's "Sexy Hair" and "Sexy" names.

13. Each of Opposer's marks and names, and Applicant's mark, employ "SEXY" as the dominant or a dominant element. Applicant's mark substitutes the "BED" for the term "BIG" in Opposer's "BIGSEXYHAIR" mark, and substitutes the generic term "STYLE" (for styling preparations) for the generic term "HAIR".

14. The goods sold by Opposer and the hair care and hair styling preparations of Applicant identified in the application herein opposed are essentially identical.

15. Applicant's trademark "BED-SEXY STYLE" as applied to the hair care and hair styling preparations identified in the application herein opposed so resembles Opposer's registered "SEXY" "SEXY HAIR" and trademarks, including its "BIGSEXYHAIR" mark its "Sexy"

and “Sexy Hair” names as used in connection with Opposer’s goods and business, that it is likely to cause confusion, mistake, and/or deception as to the source of goods or sponsorship or affiliation with Opposer.

16. If Applicant is permitted to register “BED-SEXY STYLE” as a mark for the hair care and hair styling preparations identified in the application, confusion of the relevant trade and public is likely to result, which will damage and injure Opposer.

17. On seeing Applicant’s “BED-SEXY STYLE” mark used in connection with Applicant’s hair care and hair styling preparations, purchasers and potential purchasers are likely to believe in error that such goods are offered by or in association with Opposer or that Opposer and Applicant are affiliated.


18. Any defect, objection to, or fault found with Applicant’s hair care and hair styling preparations sold under the mark “BED-SEXY STYLE” would reflect on and injure the reputation that Opposer has established for its goods and business.

19. If Applicant is granted a registration for the mark herein opposed for the goods in International Class 3, it would obtain thereby at least a *prima facie* exclusive right to use the mark for such goods as identified in the registration. Such registration would be a source of damage and injury to Opposer.

WHEREFORE, Sexy Hair Concepts LLC prays that registration of the mark of Application Serial No. 85/409,907 be refused and that this opposition be sustained.


