WITH CONSENT**

Vincent Motors LLC and Eicher Motors Ltd (“Applicants/Respondents”) hereby move that the above-referenced proceeding be suspended by ninety (90) days, and that all dates be reset as follows:

Plaintiff Pretrial Disclosures:	08/14/2015
Plaintiff's 30-day Trial Period Ends:	09/28/2015
Defendant's Pretrial Disclosures:	10/13/2015
Defendant's 30-day Trial Period ends:	11/27/2015
Plaintiff's Rebuttal Disclosures:	12/12/2015
Plaintiff's 15-day Rebuttal Period Ends:	01/11/2016

On December 17, 2014, the Board granted Opposer/Petitioner David M. Holder’s petition to cancel Registration Nos. 4128588 and 4128589. Since then, the parties have been actively

engaged in ongoing settlement discussions to resolve their differences and have exchanged a written draft of an agreement. The parties communicate on a regular basis, as recently as May 1, 2015, and they are hopeful a final resolution might be reached within the next 90 days without the need for expenditure of the parties' and TTAB resources. The additional time is needed to continue the negotiations without facing impending litigation deadlines and to determine if a final settlement can be reached.

Opposer/Petitioner David M. Holder has consented to the granting of this suspension.

The parties have held the discovery conference as required under Trademark Rules 2.120(a)(1) and (a)(2).

Accordingly, the parties respectfully request that this Motion be granted.
