WITHDRAWAL OF OPPOSITION

Registrant and opposer Buffalo Wild Wings, Inc. (“Buffalo Wild Wings”), brought this opposition against Applicant Fuzion Food Group USA, Inc. (“Fuzion Food”), regarding registration of WILD WINDS, Ser. No. 85313027, based on the likelihood of confusion. Fuzion Food has not yet answered Buffalo Wild Wings opposition, but has successfully amended the recitation of services in the application from “restaurant and bar services” to “restaurant and bar services, excluding sports bar services and restaurant or bar services offering chicken wings and legs in a variety of sauces.”

Based on the amended recitation of services and the settlement agreement between the parties, Buffalo Wild Wings withdraws its opposition without prejudice to Applicant’s registration of the mark WILD WINDS.
