THIS PROCEDURE HAS NO LOGIC WHATSOEVER. ON JUNE 6<sup>TH</sup> 2011, I APPLIED FOR AND ON NOVEMBER 23, 2011 RECEIVED A NOTICE FROM THE UNITED STATES PATENT AND TRADEMARK OFFICE ENTILEMMENT TO REGISTRATION SERIAL NO. 85-339,356.

REFERENCE 68 PAGES, PARAGRAPH 9. OLYMPIC MARK 3,914,588 WAS REGISTERED IN THE YEAR 2010 AND PUT INTO COMMERCIAL USE JUNE 21, 2010. I HAVE PRODUCT BROCHURES WHICH WERE COPYRIGHTED IN 1999 & 2002.

I HAVE TO PAY THE UNITED STATES PATENT AND TRADEMARK OFFICE A \$300 FEE [THAT IS 15 TO 30 SALES OF HANDHELD SCOREKEEPERS. I USUALLY SELL 5 UNITS A MONTH] AND FILE AN ANSWER TO A 68 PAGE MEMO THAT DOES NOT ASK A QUESTION. FURTHERMORE, I HAVE A DEADLINE TO RESPOND TO WHOM?

I WOULD THINK A LOGICAL RESPONSE WOULD BE DIRECTED TO THE UNITED STATES PATENT AND TRADEMARK OFFICE PROVIDING A POSITION IN THIS MATTER.

I WAS TOLD BY THE USPTO THAT "THAT THE OLYMPIC COMMITTEE HAD 61 YEARS TO DO SOMETHING AND THEY DID NOT!" THUS THE MARK OF THE APPLICATION IDENTIFIED HAS ENTILEMMENT TO REGISTRATION.

#### BACKGROUND

IN 1984, I WAS VERY INVOLVED WITH THE OLYMPIC GAMES IN LOS ANGELES, CALIFORNIA. AFTER A LAW ENFORCEMENT COORDINATION MEETING WITH THE FBI, SECRET SERVICE, US MARSHALS, LIVERPOOL, LOS ANGELES POLICE, CHP, ETC. I WAS TOLD THAT I WAS CHOSEN AND NOMINATED [100% AGREEMENT] TO BE IN CHARGE OF INTERNATIONAL SECURITY FOR THE 1984 OLYMPIC GAMES.

THEY GAVE ME THE OLYMPIC MANUAL TO READ. THE NEXT DAY, I ASKED A MEMBER OF THE FBI AND US MARSHAL'S OFFICE A QUESTION. "WHAT WOULD STOP ME FROM RENTING SMALL AIRCRAFT AND BOMBING MULTIPLE VENUES PRIOR TO THE GAMES STARTING?" THEY SAID THAT THEY WOULD TAKE CARE OF THAT. THE NEXT DAY THE PRESS MEDIA ANNOUNCED "THERE WILL BE NO MORE FLYING OVER ANY OLYMPIC VENUES."

MY DRIVER FOR THE GAMES WAS PRESIDENT NIXON'S EXECUTIVE SECRETARY.

FOR THE FIRST TIME IN HISTORY, THE 1984 OLYMPIC GAMES PRODUCED A PROFIT [250 MILLION DOLLARS] AND THERE WERE NO DEATHS. I DID HAVE TO BRING THE BOMB SQUAD IN THE DAY THE GAMES BEGAN. WE DID HAVE A BAZAR INCIDENT WHICH WAS EVENTUALLY CLEARED.

IN 1996, MY WIFE AND I WERE HONORED TO HAVE BOTH OUR CHILDREN INVOLVED IN THE OLYMPIC TORCH RUN. MY DAUGHTER WAS ACTUALLY SELECTED TO

RUN WITH THE TORCH [WITH A THANK YOU GIFT FROM LAW ENFORCEMENT OF POLICE MOTOR CYCLES, CHP, GEORGIA STATE POLICE, BODY GUARDS, POLICE HELICOPTER, ETC. PROCESSION FOR ME].

#### ABUSE AND HARASSMENT




