On May 31, 2013, applicant/counterclaim petitioner filed a proposed amendment to its application Serial No. 79097186, with opposer's consent.

By the proposed amendment applicant/counterclaim petitioner seeks to change the identification of services in International Class 39 as follows:<sup>1</sup>

holiday travel reservation services, namely, reservation and booking of seats for travel; information services relating to travel, namely, provision of travel information; issuing of tickets for travel, namely, arranging for the emergency replacement of airline tickets; itinerary travel advice services; organization of travel, namely, travel route planning, travel planning for special occasions; provision of information relating to travel; provision of tourist travel information; provision of travel information; provision of travel services from customer loyalty and frequent buyer schemes, namely, online computer databases in the field of travel information services; provision of travel services from frequent flyer schemes, namely, air transportation services featuring a frequent flyer bonus program; reservation of seats for travel; reservation services for booking seats for travel; reservation services for travel, namely, reservation of seats for travel, travel and tour ticket reservation services; seat reservation services for travel; services for the arranging of travel, namely, arranging travel tours; services for the booking of travel; ticket booking services for travel, namely, booking of airline tickets; tourist agency services for travelers, namely, reservation and booking of seats for travel; tourist travel reservation services, namely, booking of airline tickets; transport of travelers; travel advisory services; travel agents services for arranging travel, namely, arranging travel tours, arranging cruises "

Inasmuch as the amendment is clearly limiting in nature as required by Trademark Rule 2.71(a), and because opposer/counterclaim defendant consents thereto, it is approved and entered. See Trademark Rule 2.133(a).

If this resolves the dispute herein, the parties are allowed until THIRTY DAYS from the mailing date of this order to withdraw the notice of opposition and counterclaim, failing

which the opposition will go forward on the application as amended.<sup>2</sup> See Trademark Rule 2.106(c).
