1 MARY BECKER, of lawful age, called for  
2 examination, as provided by the Ohio Rules of  
3 Civil Procedure, being by me first duly sworn,  
4 as hereinafter certified, deposed and said as  
5 follows:

6 EXAMINATION OF MARY BECKER

7 BY MR. JONES:

8 Q. Good morning. Would you state your  
9 full name for the record, please?

10 A. Mary Becker.

11 Q. And your home address, Ms. Becker?

12 A. 7609 Vinemont Court, Hudson, Ohio  
13 44236.

14 Q. Is Hudson, Ohio near Canton?

15 A. It's about 45 minutes north of  
16 here.

17 Q. Closer to Cleveland then?

18 A. About halfway.

19 Q. And you currently are associated  
20 with Shumacher Homes Operations, Inc.?

21 A. Yes.

22 Q. What is your current position with  
23 Shumacher Homes?

24 A. Vice president of sales and  
25 marketing.

1 Q. And how long have you held that  
2 position?

3 A. 15 years.

4 Q. And have you held any other  
5 positions with Shumacher Homes?

6 A. I was a sales consultant prior to  
7 that.

8 Q. And so how long altogether have you  
9 been with Shumacher Homes?

10 A. 18 years.

11 Q. And is your husband also associated  
12 with Shumacher Homes?

13 A. No. He's not.

14 Q. What is your husband's name?

15 A. William.

16 Q. And do you have any other family  
17 members -- do you have any family members that  
18 are associated with Shumacher Homes?

19 A. Yes. My brother, Paul, is CEO. My  
20 brother, Bill, is COO. My son is a new product  
21 manager, John Becker. My parents, Mary and  
22 John Shumacher are involved as well.

23 Q. Okay. I infer that this is a  
24 company that was started by your parents?

25 A. By my brother, Paul.

1 Q. By your brother?

2 A. Yes.

3 Q. And how long has Shumacher Homes  
4 been in business?

5 A. Since 1992.

6 Q. Congratulations.

7 A. Thank you.

8 Q. Is Shumacher Homes an Ohio  
9 corporation?

10 A. Yes.

11 Q. And other than Paul, the CEO, Bill,  
12 the COO, I believe you said --

13 A. COO.

14 Q. -- yourself, are there any other  
15 officers currently of the company?

16 A. Yes.

17 Q. How many others?

18 A. Officers meaning our leadership  
19 team or vice presidents?

20 Q. Vice presidents.

21 A. We have two other vice presidents.

22 Q. And who are they?

23 A. Chris Shishmian is vice president  
24 of administration and Rick Sanner is vice  
25 president of construction.

1 Q. And --

2 A. We also have a CFO.

3 Q. Who is that?

4 A. Chad Kane, K-A-N-E.

5 Q. Is Shumacher Homes a publicly  
6 traded corporation?

7 A. No. It is not.

8 Q. Has either Kerry Earnhardt or René  
9 Earnhardt ever been an officer or shareholder  
10 of Shumacher Homes?

11 A. No.

12 Q. Would you describe briefly what the  
13 business operations and activities are of  
14 Shumacher Homes?

15 A. We are a custom on-your-lot home  
16 builder. We build on the customer's home site  
17 and we operate in 14 states and have 21  
18 locations.

19 Q. So I take it you don't sell dirt?

20 A. No. We don't.

21 Q. Can you recite most, if not all, of  
22 the 14 states in which you operate?

23 A. Yes. Ohio, West Virginia, Indiana,  
24 Pennsylvania, North Carolina, South Carolina,  
25 Louisiana, Texas, Georgia, Mississippi. I'm

1 trying to think of my geography. I'm not sure  
2 how many that was.

3 Q. Is Florida one of them?

4 A. No. Florida is not. Georgia, did  
5 I say Georgia? Mississippi, Louisiana, Texas.

6 Q. Well, can we characterize it as  
7 generally the southeast and --

8 A. And the Midwest.

9 Q. -- the Midwest?

10 A. Yes.

11 Q. And when you say you have 21  
12 locations, are those primarily sales offices?

13 A. Yes. That would be a model home or  
14 design center location.

15 Q. Okay. So you have a headquarters  
16 here in central Ohio; correct?

17 A. Yes.

18 Q. That's one location.

19 Do you have a model home or sales  
20 center at that location also?

21 A. We have our operations -- our main  
22 corporate office is here in Canton. The  
23 closest model home location would be Akron,  
24 about 20 minutes north of here.

25 Q. And all these other 20 or so

1 locations, are they of the same type or are  
2 they all model home slash sales centers?

3 A. For the most part it is a model  
4 home. We can have either one model home or up  
5 to six model homes. Some are also a design  
6 studio in a retail center.

7 Q. Okay. And so people use your  
8 services to design and construct homes on  
9 property that these customers of yours already  
10 own or are in the process of buying; is that  
11 right?

12 A. Yeah. Starting with any of our  
13 plans they can customize from that and then we  
14 build on their land, that's correct.

15 Q. Are they obligated to start with  
16 your plans or can they bring independently  
17 created plans to you?

18 A. For the most part they come to us.  
19 They can come to us with a plan and they can  
20 look at ours and see that we have so many to  
21 offer that they would go with ours.

22 Q. And what is the general price range  
23 of the services that you provide in the design  
24 and construction of these homes?

25 A. It could be anything from the low

1 100s up to 450 or higher, but that would be the  
2 main area.

3 Q. And approximately how many homes  
4 did Shumacher Homes construct last year --  
5 well, let me ask you, are you on a calendar  
6 year or fiscal year?

7 A. Calendar year.

8 Q. So during calendar year 2013, how  
9 many homes did you close?

10 A. Right around a thousand.

11 Q. About a thousand?

12 A. Uh-huh.

13 Q. I have seen a reference to another  
14 company, 50 X 20 Holding Company, Inc.

15 Are you familiar with that entity?

16 A. Yes.

17 THE WITNESS: Not as much as I  
18 guess as you, Dave.

19 MR. BUTZ: Just do the best you  
20 can.

21 Q. Tell me what you know about it and  
22 its relationship, if any, to the operations of  
23 Shumacher Homes.

24 A. I guess it's a --

25 THE WITNESS: I'm looking to you.

1 MR. BUTZ: Yeah. If you don't  
2 know, just tell him you don't know.

3 A. Yeah. I'm not involved in the  
4 specifics of that, more Shumacher Homes  
5 operations.

6 Q. Okay. Do you know whether 50 X 20  
7 Holding Company has used the trademark  
8 Earnhardt Collection in conducting any  
9 business?

10 A. I don't believe so.

11 Q. Not that you know of?

12 A. Not that I'm aware of.

13 Q. Other than Shumacher Homes, and I'm  
14 using that as a shorthand for Shumacher Homes  
15 Operations, Inc., other than Shumacher Homes,  
16 are you aware of any other entity which has  
17 used either under license from the Earnhardts  
18 or from yourself the Earnhardt Collection mark?

19 A. Yes. We have Shumacher Homes of  
20 North Carolina, of South Carolina, Louisiana  
21 and those are all under the umbrella of  
22 Shumacher Homes.

23 Q. Okay. So we'll get to this license  
24 a little bit more later. So the license that  
25 you have from Kerry and René Earnhardt, you

1 have then sublicensed that to other members of  
2 the Shumacher Homes corporate family; is that  
3 correct?

4 A. I don't know if the term would be  
5 to sublicense. Those entities do because those  
6 are our offices within North Carolina, South  
7 Carolina.

8 Q. And I understand that you are the  
9 sole designee appearing today on behalf of  
10 Shumacher Homes in response to a deposition  
11 subpoena; is that correct?

12 A. That is correct.

13 Q. What did you do to prepare for this  
14 deposition?

15 A. I reviewed the materials that were  
16 submitted, and I also read René Earnhardt's  
17 deposition.

18 Q. When you say reviewed the materials  
19 that were submitted, are you talking about the  
20 documents that Shumacher Homes previously  
21 produced to us?

22 A. Yes, yes.

23 Q. Okay. And you read René  
24 Earnhardt's deposition transcript?

25 A. Yes.

1           Q.       There are two trademark  
2 applications at issue in this proceeding. Each  
3 of them pertains to the trademark Earnhardt  
4 Collection. One of the applications relates to  
5 the use of Earnhardt Collection in conjunction  
6 with furniture, and one relates to the use of  
7 Earnhardt Collection in conjunction with custom  
8 homes or custom home services.

9                    You're aware of that; aren't you?

10          A.       Yes.

11          Q.       Now for whatever reason the first  
12 of the two applications to be filed related to  
13 Earnhardt Collection furniture and to get us  
14 into the right context, that application was  
15 filed July 28, 2011. Then the custom homes  
16 application was filed about a week later on  
17 August 6, 2011. So the applications were filed  
18 at the very end of July or early August 2011.

19                   Now, with that in mind, I want to  
20 ask you some questions about the decision to  
21 use Earnhardt Collection. Who made the  
22 decision to use Earnhardt Collection as a  
23 service mark for custom home services?

24          A.       It was really an evolution of the  
25 creative process. As we look at the documents

1 there were, you know, there were different  
2 names, and I can't specifically say that one  
3 day we said it was Earnhardt Collection. It  
4 was more that it was shortened because it made  
5 sense to that, but Kerry and René had indicated  
6 that it would be permissive to use that. We  
7 did not determine that on our own. But it was  
8 an evolution really of the creative process of  
9 the naming.

10 Q. Was there a moment or an event that  
11 finalized that decision?

12 A. I don't recall anything specific in  
13 relation to that.

14 Q. But it apparently happened before  
15 the late -- well, in or before late July 2011;  
16 correct?

17 A. I'm assuming so with looking at the  
18 emails.

19 Q. Now, when you say it was an  
20 evolution, I assume you were involved in the  
21 process?

22 A. Yes.

23 Q. And René and Kerry Earnhardt were  
24 involved in the process. Who else was involved  
25 in the process or deliberations or the

1 discussions of the name that would be given of  
2 this portfolio of home designs?

3 A. We at the time had an ad agency and  
4 there was discussion when we met talking about  
5 the name and the evolution of that name.

6 Q. And who was the ad agency?

7 A. Loomis.

8 Q. L-O-O-M-I-S?

9 A. M-I-S, yes.

10 Q. And was there a particular  
11 individual at Loomis that was involved?

12 A. Probably Michael Tuggle,  
13 T-U-G-G-L-E.

14 Q. Now, was Loomis already working as  
15 an ad agency for Shumacher Homes before the  
16 Earnhardt Collection project became active?

17 A. Yes.

18 Q. Okay. Had Shumacher Homes ever  
19 been involved in a previous deal or negotiation  
20 of a deal for anyone else's sponsorship or  
21 endorsement of homes or home designs for  
22 Shumacher Homes or were the Earnhardts the  
23 first to ever interact with Shumacher Homes?

24 A. The Earnhardts were the first.

25 Q. Have you been engaged in

1 discussions with any others since mid 2011 to  
2 sponsor or endorse a line of homes or home  
3 designs?

4 A. Not any other personalities no.

5 Q. Ms. Becker, there have been a  
6 number of documents marked as exhibits in  
7 previous depositions, and I'm going to hand you  
8 a copy of one of those, it's Exhibit 2, and if  
9 you will just take a moment to look through  
10 that understanding the context and I'll ask you  
11 some questions about it.

12 All right. The first email in this  
13 series of two emails, it appears to be an email  
14 from you sent on Thursday, April the 7th, 2011  
15 at 12:04 p.m., the subject of which is  
16 marketing plan.

17 Do you see that?

18 A. Yes.

19 Q. And it was sent to  
20 REarnhardt2@aol.com. I understand that's René  
21 Earnhardt; correct?

22 A. Yes.

23 Q. And it was also sent to  
24 SteveMoberly@mccammish.com. What is McCammish  
25 and who is Steve Moberly?

1           A.       Steve Moberly was the initial  
2 contact at Wild Sports Marketing, who  
3 introduced us to Kerry and René Earnhardt.  
4 There was a time when he transitioned the name  
5 of his company, he had a partner, and so this  
6 was I believe his -- I don't know if it was his  
7 home email, but that was the difference in the  
8 email address from Wild Sports Marketing.

9           Q.       And at this time, April 7th 2011,  
10 you sent to Ms. Earnhardt, Mr. Earnhardt and  
11 Mr. Moberly a what you called an initial rough  
12 draft of the marketing plan; right?

13          A.       Yes.

14          Q.       And you referred to it as a  
15 marketing plan for the "Kerry and René  
16 Earnhardt Outdoor Collection" at that time;  
17 didn't you?

18          A.       Yes.

19          Q.       Where did that designation come  
20 from?

21          A.       That was kind of a working title at  
22 the beginning. It was very -- became very  
23 cumbersome to say all those words, but that was  
24 one of the original working titles.

25          Q.       Why did you use the term collection

1 in that working title?

2 A. Because that was referring to the  
3 custom homes. That was referring to the brand.

4 Q. Were you referring to a portfolio,  
5 a potential portfolio or group of custom homes?

6 A. The custom homes that they would be  
7 designing with us.

8 Q. Is that a yes?

9 A. Yes.

10 Q. You're shaking your head?

11 A. Okay. I'm sorry.

12 Q. So in using the term Collection  
13 within the designation Kerry and René Earnhardt  
14 Outdoor Collection, you were using that term  
15 Collection to refer to a group or portfolio of  
16 potential home designs; correct?

17 A. The homes that they would be  
18 designing with us.

19 Q. Yes?

20 A. Yes.

21 Q. Okay. All right. And then in the  
22 second paragraph of that email you say we will  
23 send images of some early stage development  
24 plans for The with a capital T Collection with  
25 a capital C, in a separate email.

1 Do you see that?

2 A. Yes.

3 Q. So you were shortening that phrase  
4 to just the collection at that point; is that  
5 what you were doing?

6 A. Yes.

7 Q. So I gather that at this point in  
8 time there certainly had not been any decision  
9 made as to what the collection would be called;  
10 is that correct?

11 A. Not a final decision.

12 Q. Do you recall whether you were  
13 considering any other designations to be used  
14 at this time to identify the collection?

15 A. I don't recall any other specific  
16 name.

17 Q. I've handed you what was marked in  
18 a previous deposition as Opposer's Exhibit 3,  
19 and I recall that in Exhibit 2 you had said  
20 that you were sending to the recipients on  
21 April 7th the initial rough draft of the  
22 marketing plan for the collection.

23 Is Opposer's Exhibit 3 the initial  
24 rough draft of the marketing plan for the  
25 collection?

1 A. Yes, it is.

2 Q. Did you prepare this or did someone  
3 else prepare this?

4 A. Paul Shumacher and I mainly  
5 prepared this document, yes.

6 Q. If you look at the second page of  
7 Opposer's Exhibit 3, in green there is a  
8 section entitled next steps.

9 Do you see that?

10 MR. SANDERS: There's not any green  
11 on the exhibit that I have.

12 MR. JONES: I'm sorry. Okay.

13 Q. There is a section entitled next  
14 steps.

15 Do you see that?

16 A. Yes.

17 Q. And there is some bullet points  
18 below there, and the second circular bullet  
19 point says agenda for design Charette, the  
20 venture begins.

21 Do you see that?

22 A. Yes.

23 Q. And then the next bullet point says  
24 determine number of plans in the collection.

25 Do you see that?

1 A. Yes.

2 Q. Were you and Paul using the term  
3 collection there in its generic sense to  
4 connote a group or portfolio of home designs?

5 MR. SANDERS: Objection to the  
6 form.

7 Q. You may answer.

8 A. We were referring to the brand, the  
9 brand of the homes that we were designing in  
10 conjunction with Kerry and René Earnhardt.

11 Q. You were attempting to brand the  
12 group of homes by the term collection?

13 A. The Earnhardt Collection, not just  
14 collection, but the Earnhardt Collection with  
15 their name attached, yes.

16 Q. But you didn't say the Earnhardt  
17 Collection, you called it the collection there;  
18 correct?

19 A. I think that was a general  
20 conversational comment.

21 Q. If you look at the next page of  
22 Exhibit 3 there is some reference in the very  
23 last segment of that page, it's bearing Control  
24 No. KEI01192 and you talk about the target  
25 market of the collection there.

1 Do you see that, very last line?

2 A. Yes.

3 Q. What has been the target market of  
4 the collection?

5 A. It's really people who enjoy  
6 outdoor living, casual, comfortable lifestyle.

7 Q. Would that be a fairly broad cross  
8 section of people insofar as income and  
9 economics?

10 A. Yes.

11 Q. If you will turn to the next page  
12 bearing Control No. KEI01193, the section  
13 entitled -- under Section 3 says Overview:  
14 Then I'll read "The message that we set forth  
15 is that we are an affordable custom homebuilder  
16 and are going to offer a unique collection that  
17 is attainable to the majority of the market  
18 from 800 square feet to 3,500 plus square  
19 feet."

20 So the Earnhardt Collection was  
21 anticipated at this time to be a unique  
22 collection of custom home designs; wasn't it?

23 A. Yes; designed by them in  
24 conjunction with us.

25 Q. And when you say that it -- this

1 collection was to be attainable "to the  
2 majority of the market", are you again  
3 referring to the fact that you intended for  
4 this to be generally available to the  
5 population, that is at least medium income and  
6 high income people, too?

7 A. Yes.

8 Q. In the next sentence it reads "If  
9 they start with a Kerry and René Earnhardt home  
10 we are able to customize any way possible to  
11 deliver the customer an end product that is  
12 still in the collection, but incorporates their  
13 design and modification needs".

14 When you say that the end product  
15 would still be in the collections, you're  
16 talking about the fact that the collection can  
17 include some modifications of your pre-existing  
18 designs; am I understanding that correctly?

19 A. Yeah. That is one of the unique  
20 things about us is that we will customize for  
21 each of our customers. Many builders don't do  
22 that, but we customize in our plans.

23 Q. And you still consider the modified  
24 or customized version of your plan to be within  
25 the umbrella of that collection generally;

1 correct?

2 A. The Earnhardt Collection.

3 Q. Turning to the next page bearing  
4 Control No. KEI01194, the first sentence asks  
5 the question what is the overall look and feel  
6 of the brand? And then the answer is -- after  
7 that says "The Kerry and René Earnhardt Outdoor  
8 Collection will have a unique look and feel  
9 separate from but complementary to the  
10 Shumacher Homes brand".

11 Now, at that time you were still at  
12 least considering the brand as possibly being  
13 the Kerry and René Earnhardt Outdoor  
14 Collection; is that correct?

15 A. Yes.

16 Q. And this is in April of 2011?

17 A. Yes. That was describing the  
18 homes.

19 Q. Okay. And you're talking about the  
20 development of a website to promote this  
21 collection on that same page, and if you look  
22 at Paragraph No. 2 under home page slash  
23 landing page for Kerry and René Earnhardt  
24 Outdoor Collection; do you see that?

25 A. Yes.

1           Q.       It says "Provide rich media in the  
2 form of a video introduction by Kerry and René  
3 Earnhardt to explain the collection and truly  
4 bring it to life".

5                    Did you ever put together and use  
6 for promotional purposes a video to explain the  
7 collection?

8           A.       Yes.

9           Q.       Turning the page to the page  
10 bearing Control No. KEI01195, I infer from  
11 looking at the top of this document that you  
12 were also thinking at that time about how to  
13 promote the collection through optimizing  
14 search engine results; is that correct?

15          A.       Yes.

16          Q.       And Paragraph No. 1 at the top of  
17 that page in referring to this potential  
18 strategy says, "Rank high on the search engine  
19 results page (SERP) for as many keyword phrases  
20 (e.g. "custom home builders", "outdoor home  
21 collection") relevant to our business (and  
22 related businesses) as possible.

23                    Do you see that?

24          A.       Yes.

25          Q.       So you thought that using the

1 generic phrase custom home builders would  
2 perhaps be beneficial to the promotion of your  
3 business and this collection if you had that as  
4 a keyword; is that correct?

5 MR. SANDERS: Objection to the  
6 form.

7 A. We -- this is an example of some of  
8 the words that we use in search engine  
9 optimization and aid search to rank as a custom  
10 home builder.

11 Q. Because you think that people would  
12 use commonly used term to look for businesses  
13 of a certain type. In other words, you think  
14 that if people are looking for custom home  
15 builders in the Canton or Akron area, they  
16 might be apt to use as search terms custom home  
17 builders, Canton or Akron; is that --

18 A. People can use many different terms  
19 in a Google search.

20 Q. Yeah, but you thought custom home  
21 builders was an apt, descriptive phrase for  
22 your business; didn't you?

23 MR. SANDERS: Objection to form.

24 A. We are a custom home builder.

25 Q. And you also thought that the

1 phrase outdoor home collection was an apt,  
2 descriptive phrase to be used as a search term;  
3 didn't you?

4 MR. SANDERS: Objection to the  
5 form.

6 A. Again, those -- it's looking at  
7 words that someone would use in a Google  
8 search.

9 Q. And outdoor home collection is the  
10 -- a phrase that you believe people would use  
11 in a Google search to find collections of  
12 outdoor homes?

13 A. That would be one example of many?

14 Q. Yes. I don't mean it's the only  
15 apt phrase.

16 A. Yes.

17 Q. But it is an apt phrase; isn't it?

18 A. It could be.

19 Q. Ms. Becker, I have now placed  
20 before you what was marked in a previous  
21 deposition as Opposer's Exhibit 4, and take a  
22 moment and I'm going to ask you a couple of  
23 questions about this. It appears to be a  
24 series of emails from April 12 through April  
25 14. Let me know once you've had a chance to

1 review it.

2 A. Okay.

3 Q. Okay. And as I look at this  
4 simultaneously with you, looking at it, you're  
5 not included in this email string anywhere; are  
6 you?

7 A. No.

8 Q. Steve Moberly, whom we talked about  
9 briefly previously, is though, I believe, and  
10 at this point he is identified as being  
11 associated with Brooking Industries; isn't he?

12 A. Uh-huh.

13 Q. So is that part of that transition  
14 you were talking about where he went from Wild  
15 West to whatever?

16 A. I believe so, yes.

17 Q. Looking at the second email  
18 chronologically, which is the next-to-last one  
19 in the document, the one at the top of the  
20 second page, he writes to René Earnhardt the  
21 projections are based solely on the "Kerry and  
22 René outdoors line of homes".

23 Did you ever hear anybody refer to  
24 this collection as the Kerry and René outdoors  
25 line of homes?

1 A. Not other than right here.

2 Q. Okay. In the -- on the first page  
3 the email of April 13 from Mr. Moberly to René  
4 Earnhardt, the second paragraph talks about  
5 taking the Kerry and René Earnhardt brand to  
6 new heights.

7 Do you recall during this period of  
8 time any discussion about calling the  
9 collection the Kerry and René Earnhardt brand?

10 A. The Kerry and René Earnhardt brand?

11 Q. Yeah.

12 A. I guess in general terms it is the  
13 Kerry and René Earnhardt brand.

14 Q. Did you ever think of adopting and  
15 using as a trademark Kerry and René Earnhardt  
16 homes or something to that effect?

17 A. We've always referred to it as we  
18 know it's the homes that Kerry and René  
19 Earnhardt have developed with us, which is the  
20 Earnhardt brand, the Earnhardt Collection, so  
21 that's always been intertwined for us.

22 Q. You're talking about internally  
23 anyway, internally at Shumacher; correct?

24 A. Yes.

25 Q. Just a matter of curiosity, at the

1 top of Exhibit 4, the subject is KE slash PSH,  
2 and I realize you were not a recipient or  
3 sender of this string of emails does PSH stand  
4 for Paul Shumacher Homes?

5 A. I think that's what he's referring  
6 to.

7 Q. Okay. Ms. Becker, if you'll look  
8 at what was marked in a previous deposition as  
9 Opposer's Exhibit 5, it appears to be a couple  
10 of emails, the oldest being one from you to  
11 René Earnhardt on May 6 and the newer of the  
12 two being a responsive email from René  
13 Earnhardt to you.

14 Do you recall these emails?

15 A. Yes.

16 Q. And in that May 6 email that you  
17 sent to Ms. Earnhardt, the lower of the two  
18 emails on this page, you state in the second  
19 paragraph "We will remember this day as the  
20 beginning of a journey to one of the most  
21 successful brands in the world, the Kerry and  
22 René Earnhardt Outdoor Collection".

23 Now what was momentous about that  
24 day? I mean, why did you say that that day was  
25 going to be memorable?

1           A.       I don't recall what was specific to  
2 that day. I don't recall.

3           Q.       And, again, as much as a matter of  
4 curiosity as anything else, you also close with  
5 we hear the fishing is mighty good in the blue  
6 ocean.

7                       What on earth does that mean?

8           A.       Blue Ocean is a business book.  
9 It's a strategy about creating new market  
10 space, so we had referred to that in our  
11 conversation with them as a new business  
12 opportunity.

13          Q.       Okay. So you were expressing  
14 optimism?

15          A.       Yes.

16          Q.       Okay. But least on this date, the  
17 brand that you thought was most likely to be  
18 the chosen brand was the Kerry and René  
19 Earnhardt Outdoor Collection; correct?

20          A.       It was descriptive, referring to  
21 the Earnhardt Collection homes, yes, that we  
22 were designing in conjunction with them.

23          Q.       I have handed you Opposer's Exhibit  
24 6, which was identified in a previous  
25 deposition as the license agreement between

1 Kerry Earnhardt, Inc. and Kerry Earnhardt, the  
2 individual, and René Earnhardt, the individual,  
3 on the one hand and Shumacher Homes Operations,  
4 Inc. on the other hand.

5 Have you seen this document before?

6 A. Yes.

7 Q. Okay. Now, somewhere in here it  
8 speaks to the terms. Yeah, Page 6 Paragraph  
9 5.1 says this agreement shall continue in force  
10 and effect for three years or 36 months from  
11 the effective date. And on the first page it  
12 says that the effective date is June 1, 2011.

13 So this provision is saying that  
14 the agreement stays in force and effect until  
15 June 1, 2014, unless sooner terminated as  
16 provided for herein. And that the term of the  
17 agreement may be extended by mutual agreement  
18 of the parties in writing.

19 So what is the status of the  
20 agreement? Has it been terminated or has it  
21 been extended?

22 A. It's been extended.

23 Q. Was there a separate writing  
24 expressing that extension?

25 A. Yes.

1 Q. Were any of the substantive terms  
2 of the agreement changed?

3 A. I don't believe so, but I have not  
4 looked at all the details of that particular  
5 extension.

6 Q. And for how long was the extension?

7 A. I need to get a copy of it to see.

8 Q. You don't know?

9 A. Yeah.

10 Q. At least a year?

11 A. At least, yes.

12 Q. Okay. Now in Paragraph 1.1 of the  
13 license agreement it indicates that Kerry  
14 Earnhardt, Inc. and Mr. and Mrs. Earnhardt  
15 grant to Shumacher a license to use the Marks  
16 with a capital M.

17 Do you see that?

18 A. Yes.

19 Q. And the marks are shown in exhibit  
20 -- or schedule B in the back of -- the very  
21 last page. And if you look at the listing of  
22 the license marks there are ten items, and the  
23 first five all refer to Kerry Earnhardt the  
24 individual.

25 Do you see that?

1 A. Yes.

2 Q. And the last five all refer to René  
3 Earnhardt, the individual.

4 Do you see that?

5 A. Yes.

6 Q. So none of the licensed marks are  
7 associated with the term Earnhardt alone; isn't  
8 that true?

9 A. Well, it is their last name.

10 Q. Yeah, it is. It is. It's also  
11 other people's last name.

12 A. Uh-huh.

13 Q. Opposer's Exhibit 8 is another  
14 document that was identified in a previous  
15 deposition, and do you recognize this document?

16 A. Yes.

17 Q. And I seem to recall that there was  
18 an email from René Earnhardt in late June of  
19 2011 that referred to a discussion guide for an  
20 upcoming meeting. Is this, in fact, a  
21 discussion guide that you prepared for use in a  
22 meeting to be had with the Earnhardts?

23 A. This, to my best knowledge, was  
24 prepared by our ad agency.

25 Q. Did you have any input in the

1 preparation of it?

2 A. Some, but predominantly it was the  
3 agency.

4 Q. Was it prepared so that -- that  
5 would be Loomis; right?

6 A. Yes.

7 Q. Was it prepared for use in  
8 facilitating discussions at a meeting between  
9 and you the Earnhardts?

10 A. Yes.

11 Q. Okay. And were Kerry and René  
12 Earnhardt both present at that meeting?

13 A. Yes, they were.

14 Q. And where was the meeting?

15 A. In Canton, Ohio.

16 Q. And about when? Would it be on or  
17 about June 29th? That's the date at the top.

18 A. As best I can recall.

19 Q. And did anybody else attend with or  
20 on behalf of the Earnhardts?

21 A. Joe Hedrick.

22 Q. And did you attend on behalf of  
23 Shumacher Homes?

24 A. Yes.

25 Q. And whom else attended on behalf of

1 Shumacher Homes?

2 A. Paul Shumacher.

3 Q. Anybody else?

4 A. Not that I can recall.

5 Q. And did the meeting occur at your  
6 offices, at your home, various places or where?

7 A. At our offices.

8 Q. Is this like a one-day meeting?

9 A. This I believe is referring to a  
10 two-day meeting.

11 Q. Okay. And was the general purpose  
12 of this to kind of nail down in greater detail  
13 the plan for proceeding?

14 A. It was to talk about the homes, the  
15 design of the homes, the feel of the brand, and  
16 really to delve more into the look and feel of  
17 the homes and what was important to them in a  
18 home, so it really expressed their style, since  
19 they're the focal point of the Earnhardt  
20 Collection.

21 Q. Yeah. And this meeting occurred  
22 within a few weeks after both sides had  
23 executed the license agreement of Exhibit 6;  
24 correct?

25 A. Yes.

1 Q. So you had a deal in place already?

2 A. Yes.

3 Q. Okay. So, now in my copy I've got  
4 some red printed portions and some black  
5 printed portions, because that's the way the  
6 originals were. I apologize, some of you guys  
7 may only have black.

8 MR. SANDERS: Yeah, we only have  
9 black.

10 MR. JONES: Okay. I should have  
11 thought ahead, but I will tell you, for  
12 instance, on the first page under discussion,  
13 do you see that?

14 A. Yes.

15 Q. The question is typed out. "Who do  
16 we believe the customer is for the Kerry and  
17 René Earnhardt outdoor living collection"?

18 And then in the original of the  
19 document the apparent response is in red, and  
20 it says auto enthusiast, outdoor enthusiast,  
21 family, mature generation with the knowledge  
22 and recognition of the Earnhardt brand through  
23 successes of Earnhardt family.

24 Do you see that? So somebody -- it  
25 appears that somebody took the document as

1 originally prepared and then embedded some  
2 answers in red. Does that ring a bell, and did  
3 you participate in the responses or do you  
4 remember?

5 A. I don't recall that I participated  
6 in these responses.

7 Q. Okay. The very first statement in  
8 this discussion guide under the section  
9 entitled purpose says "As we begin the first  
10 stage of collaboration on the concept for this  
11 exciting new collection of Shumacher Homes, the  
12 team will focus on answering the questions  
13 below".

14 Now, that reference to a new  
15 collection of Shumacher Homes is meant to focus  
16 the attention of the readers on this particular  
17 collection and not any other collection of  
18 homes that Shumacher Homes sells; is that  
19 correct?

20 A. Yes. The Earnhardt Collection.

21 Q. What do you call -- or do you have  
22 any names for other collections of homes that  
23 Shumacher sells?

24 A. No.

25 Q. You don't?

1 A. No.

2 Q. So this is the first time you have  
3 used a name or designation to identify a  
4 particular collection?

5 A. Yes.

6 Q. Then just below there there's a  
7 section that starts off note colon.

8 A. Uh-huh.

9 Q. It says we are using Kerry and René  
10 Earnhardt outdoor living collection as a  
11 working name for this series of Shumacher  
12 Homes. That is open to further discussion at  
13 this meeting.

14 Now, having seen that, does that  
15 refresh your memory about whether there was a  
16 discussion in particular about the name to call  
17 this collection of homes during this meeting on  
18 or about June 29, 2011?

19 A. We had a conversation about it.  
20 This is just a very long and cumbersome name,  
21 and so we were trying to identify the name of  
22 the collection at that time.

23 Q. Okay. And somehow out of that  
24 process Earnhardt Collection was the result;  
25 correct?

1           A.       Ultimately.

2           Q.       Okay.  We're making progress.  
3       We've got the license agreement executed around  
4       June 1, 2011.  Then you've got the discussion  
5       meeting or the confab, whatever late June,  
6       around June 29.  Now we see a document marked  
7       as Opposer's Exhibit No. 9 -- and I seem to  
8       have lost my copy, got it -- dated August 2,  
9       2011, and there are two emails here, but the  
10      larger one is from you to René Earnhardt on  
11      August 2, 2011; correct?

12          A.       Yes.

13          Q.       And the fifth paragraph starts off  
14      with this, "Tomorrow we should see an Earnhardt  
15      Collection ad from Loomis".

16                 Now, I infer from that, that  
17      following this meeting up until August 2,  
18      something was done to actually go forward, make  
19      plans to use Earnhardt Collection as the name  
20      of the collection, and you were settled on it  
21      by August 2; is that correct?

22          A.       I don't remember the exact date but  
23      it looks -- it was referenced in this email.

24          Q.       By then you were settled on it;  
25      right?

1           A.       It looks -- it appears that way,  
2       yes.

3                   MR. JONES:   Okay.   Let's take a  
4       short break.

5                   (Recess taken 10:35 a.m.)

6                   - - - - -

7                   (Deposition resumed 10:48 a.m.)

8           Q.       Ms. Becker, in the calendar year  
9       2013, about how many homes did Shumacher Homes  
10      sell in the Earnhardt Collection?

11          A.       2013, I would say approximately 90.

12          Q.       And for 2012, would it have been  
13      approximately the same number?

14          A.       I would have to have the records of  
15      that specifically, but I would say it was  
16      higher in 2013.

17          Q.       Okay.   And the program began in  
18      2011?

19          A.       2011, yes.

20          Q.       Okay.   Would you agree with me that  
21      anyone in the home building industry should be  
22      able to use the term collection to refer to a  
23      group or portfolio of homes or home designs  
24      that they sell?

25          A.       As far as builders?

1 MR. SANDERS: Objection to the  
2 extent you're asking for a legal conclusion.

3 A. People can use any term.

4 Q. Well, isn't it true that people in  
5 the housing industry often use the term  
6 collection to refer to a group or a portfolio  
7 of homes or home designs?

8 A. I suppose they could. I mean, I  
9 can't think of anyone in particular.

10 Q. Have you ever seen it done?

11 A. I have seen the word collection. I  
12 wouldn't say it's pervasive.

13 Q. Would you say it's common?

14 A. I don't know that I would say it's  
15 common.

16 - - - - -

17 (Thereupon, Deposition Exhibit 17,  
18 Documents, were marked for purposes  
19 of identification.)

20 - - - - -

21 Q. I've handed you a collection of  
22 documents marked as Opposer's Exhibit 17. If  
23 you look at the first page, and I will  
24 represent to you that it is a printout from a  
25 website of Epoch, E-P-O-C-H, Homes, and it

1 purports to be a modular home builder in the  
2 New England area. And you'll see down the  
3 left-hand column, about two-thirds of the way  
4 down, that web page has a link or links to what  
5 it says are pre hyphened designed  
6 "collections".

7 Have you ever seen the term  
8 collections used by any home builder?

9 A. Yes.

10 Q. Would it be appropriate for any  
11 home builder to use a reference to its  
12 collections or its collection to identify a  
13 group or portfolio of homes?

14 MR. SANDERS: Objection to the  
15 extent the question asks for a legal  
16 conclusion.

17 A. I can respond to how we use the  
18 word collection. It's with Earnhardt  
19 Collection, the specific homes that we design  
20 with Kerry and René Earnhardt. I can only  
21 speak to the way we at Shumacher Homes use it.

22 Q. But you do see advertising and  
23 promotional material that is distributed by  
24 other companies in the home building industry  
25 don't you?

1           A.       I see right here, yes, uh-huh.

2                   MR. SANDERS:   For the record, I  
3 just want to object to the exhibit just to the  
4 authenticity.  We might be able to cover that  
5 later, but just for the sake of the record I'll  
6 object.

7                   MR. JONES:   Carter will.

8           Q.       Do you also see on that same page a  
9 reference to a particular collection which this  
10 publisher identifies as its echo collection in  
11 the -- towards the upper left corner?

12          A.       Yes.

13          Q.       Turning to the next page, have you  
14 ever heard of Wayne Homes?

15          A.       Yes.

16          Q.       Are they a fairly substantial home  
17 builder?

18          A.       Yes.

19          Q.       Have you ever heard of Epoch Homes?

20          A.       No.

21          Q.       The second page is a printout of a  
22 web page from the WayneHomes.com website and  
23 I'll read to you the first portion of the text  
24 below the header.  "Make it your own.  Ask  
25 about our unique personalization program which

1 gives you all sorts of ways to express  
2 yourself. Download our lifestyle collection  
3 included features. Download our signature  
4 collection included features.

5 Now, isn't it true that Wayne Homes  
6 appears to be using lifestyle collection and  
7 signature collection to identify two particular  
8 groups or portfolios of home designs that it  
9 offers?

10 MR. BUTZ: Objection.

11 A. It defines their included features.  
12 That's how they use it here.

13 Q. They talk about their lifestyle  
14 collection having certain features and their  
15 signature collection having certain features;  
16 don't they?

17 A. It's dictated by their features,  
18 yes.

19 Q. And likewise your Earnhardt  
20 Collection has certain features; doesn't it?

21 A. It's more the architectural style.

22 Q. But it's still a collection; isn't  
23 it?

24 A. The Earnhardt Collection, yes.

25 Q. Turn to the third page of this

1 exhibit please, and it is a web page from the  
2 website of -- are you throwing things at me?

3 A. My aim wasn't very good. I hit  
4 myself.

5 Q. This is a web page from the website  
6 of newbeginningcustomhomes.com and do you see  
7 it's reference to the palmetto collection?

8 A. Yes.

9 Q. Are you familiar with New  
10 Beginnings Custom Homes?

11 A. No.

12 Q. Turning to the next page it's a  
13 printout of a web page from  
14 westchestermodular.com.

15 Do you see the reference to that  
16 entity's coastal collection of homes?

17 A. Yes.

18 Q. Also on that same page looking down  
19 the left-hand side you'll see that it lists  
20 some other collections, too; do you see that?

21 A. Yes.

1 the housing industry the term collection is

8 Kerry or René Earnhardt or anybody acting on

12 MR. JONES: No further questions.

13 MR. SANDERS: I would like to ask  
14 just a couple.

15 EXAMINATION OF MARY BECKER

16 BY MR. SANDERS:

17 Q. Ms. Becker, in terms of branding,  
18 does Shumacher ever separate the word Earnhardt  
19 from the word collection?

20 A. No. We see that as the brand.

21 Q. When I used the term Earnhardt  
22 family, what does Earnhardt family mean to you  
23 as a representative of Shumacher?

24 A. When I think of the Earnhardt  
25 family I think of Kerry, René, Jeffrey, Bobby

1 Dale, Kayla and Blade. That's the Earnhardt  
2 family that we know in the center of the  
3 Earnhardt Collection.

4 Q. Why did Shumacher Homes decide to  
5 do business with Kerry and René Earnhardt?

6 A. We wanted to design homes that were  
7 casual, comfortable living and we wanted a  
8 couple to represent that to really be the  
9 essence of that brand. And Kerry and René  
10 really have embodied that, their love of the  
11 outdoors, and you'll see that the homes are  
12 very open, very family focused and very  
13 reflective of their -- again, their love of the  
14 outdoors.

15 MR. SANDERS: Thank you. That's  
16 all I have right now.

17 MR. JONES: Don't shut down, but  
18 this is off the record.

19 (Whereupon, the deposition was  
20 concluded at 11:00 a.m. this date.)
