STIPULATED MOTION FOR AN EXTENSION OF TIME TO SERVE OBJECTIONS
AND CROSS QUESTIONS TO OPPOSER’S WRITTEN DEPOSITIONS

With the consent of Opposer Baba Slings Pty Ltd, Applicant Babaslings Limited requests that the deadline to serve objections and cross questions to Opposer’s written testimonial depositions in this proceeding be extended by 10 days to **January 9, 2015**, to accommodate the intervening holiday and the travel plans of Applicant.

Opposer served on Applicant the written testimonial depositions of Shanti McIvor and Denis Lalor on December 5, 2014. Pursuant to 37 CFR §2.124(d)(1), Applicant has 25 days total (including an extra 5 days for service by mail, *see* TBMP §113.05) from the date of service of the depositions to respond with objections and cross questions. 37 C.F.R. §2.124(d)(1) (“Within twenty days from the date of service of the notice, any adverse party may serve cross questions upon the party who proposes to take the deposition). Twenty-five days from December 5 is December 30, 2014.

Due to the intervening holidays and the parties' travel plans, Applicant has requested, and Opposer has agreed to a 10 day extension of the December 30 deadline to January 9, 2015. Absent the extension, compliance will not be reasonably possible without interrupting existing travel plans and commitments, and Opposer has consented to this request. Good cause for the instant request is shown, and this extension is permissible under TBMP §703.02(g), which states: "[o]n motion for good cause filed by any party, or on its own initiative, the Board may extend any of the time periods specified in 37 CFR §2.124(d)(1), that is, the time periods for serving cross questions, redirect questions, recross questions, objections, and substitute questions."

Applicant Babaslings Limited therefore respectfully requests that the deadline to serve objections and cross questions to Opposer's written testimonial depositions in this proceeding be extended until **January 9, 2015**, with all other deadlines regarding further objections and questions regarding Opposer's depositions to run from this January 9, 2015 service date.

As an aside, the testimony period of Opposer is presently set for December 28, 2014. Opposer has requested a suspension pending completion of these written depositions pursuant to TBMP §510.03(a), which Applicant does not oppose. This motion, and the schedule proposed, assumes that this suspension will be granted in due course, in accordance with the rules.
