Fertitta Hospitality, LLC (“Opposer” or “FHLLC”), a Texas limited liability company having an address of 1510 West Loop South, Houston, Texas 77027, believes that it will be damaged by registration by Fertitta Entertainment, LLC of the mark FERTITTA GAMING in Application Serial Nos. 85/180,560 in International Classes 25, 35, 38, and 43, and hereby opposes the same.

As grounds of opposition, it is alleged that:

1. Applicant seeks to register the mark FERTITTA GAMING as a mark for the following goods and services in the following classes:

IC 025: Wearing apparel, namely, shirts, t-shirts, polo shirts, golf shirts, tank tops, vests, blouses, sweaters, parkas, turtlenecks, pullovers, skirts, shorts, jeans, slacks, pants, nightshirts and night gowns, pajamas, robes, rompers, socks, coveralls, mittens, gloves, undergarments, jerseys, leotards, hosiery, booties, slippers, scarves, belts, neckties, suspenders, headbands, hats, caps, visors, blazers, rain ponchos, jackets, wind resistant jackets, warm-up suits, jogging suits, sweatshirts, sweat pants, beach wear, namely, bathing suits, beach sandals and beach coveralls; footwear, namely, shoes, boots, sandals, sneakers and athletic shoes

IC 035: Retail store services featuring a variety of goods, namely, gaming merchandise, souvenirs, mugs, glassware, gift items, clothing, clothing accessories, consumer electronics, housewares, paper products, sporting goods, books and magazines, food and beverages

IC 038: Electronic transmission of text, graphics, and data; communication services, namely, providing online chat rooms for real-time interaction between online computer users concerning online contests and games of chance; communication services, namely, providing access to an online computer database for real-time tracking of and searching for network use and online computer users and transferring users to the online location(s) of another user or other users or other online locations; communication services, namely, providing online chat rooms for real-time interaction between online computer users for arranging and playing online contests and games of chance; instant messaging services

IC 043: Restaurant, bar and cocktail lounge services

2. The application to register the mark for such goods and services was filed on an intent-to-use basis. The application was published for opposition on January 10, 2012. The time for filing an opposition has been extended until July 8, 2012, which falls on a Sunday, making the present Notice of Opposition due on Monday, July 9.
3. Opposer and its predecessors-in-interest (collectively hereafter referred to as "Opposer") have used the name FERTITTA as a trade name or trademark, or as part of a trade name or trademark for various goods and services for many years. For example, Opposer has

used the mark FERTITTA as a trademark for olive oil products since at least as early as 2006 (Application SN 85/315,323). Additionally, Opposer has used FERTITTA as a mark for restaurant, bar, spa, and resort lodging services, including use on the Internet promoting such services, since at least as early as May 11, 2011 (Application SN 85/319,256). Still further, Opposer has featured the tagline "A FERTITTA ENTERTAINMENT COMPANY" on a restaurant menu and on a promotional brochure for the dining, entertainment, hospitality, and gaming services of a related company. (See, Exhibits A and B). Moreover, Opposer's Chairman and CEO, Tilman Fertitta, has received extensive publicity and recognition in connection with his association with Opposer, with Landry's, Inc., and with various other predecessor entities owned or controlled by Mr. Fertitta that include his surname within their name. These entities include, for example, Fertitta Hospitality, Inc. and Fertitta Holdings, LLC. Opposer has operated dining, hospitality, entertainment and gaming services under business names that include the name "Fertitta" for many years. As a result, on information and belief, Opposer has developed and enjoys significant goodwill and common law rights under the name and mark FERTITTA.

4. On information and belief, Opposer's use of "FERTITTA" as a name or mark in connection with its goods and services predates trademark use by Applicant of "FERTITTA" for any of the goods and services listed in the present application.
5. To the extent that Opposer's use of the mark FERTITTA has caused the mark to become distinctive of Opposer's goods and services, Applicant's mark, FERTITTA GAMING, when used for the goods and services identified in the application, especially restaurant,

bar and cocktail lounge services, so resembles Opposer's mark, FERTITTA, as to be likely to cause confusion, mistake, or deception.

6. The name "Fertitta" is primarily merely a surname. Applicant has not alleged or proven any use of the name Fertitta in connection with the goods and services recited in the subject application, nor any use of the designation "Fertitta Gaming." The designations "Fertitta" and "Fertitta Gaming" are not distinctive of Applicant's goods and services identified in the present application, and are not entitled to registration by Applicant in connection with such goods and services.
7. If Applicant is granted the registration herein opposed, it would thereby obtain at least a prima facie exclusive right to the use of the designation FERTITTA GAMING for the goods and services identified in its application. Such registration would be a source of damage and injury to Opposer.


Wherefore, Opposer prays that this Opposition be sustained and that the mark of Application Serial No. 85/180,560 be refused registration.

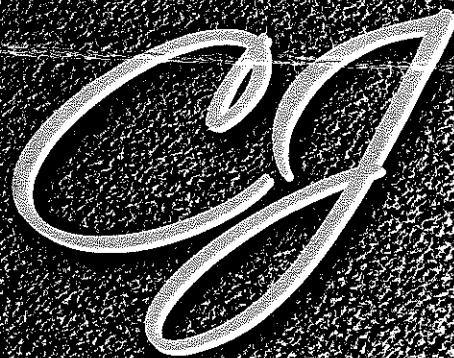
