Negotiations – Fertitta Hospitality, LLC with Fertitta Entertainment, LLC

1) When last settlement proposal was sent, by whom, and when a response is expected

The parties discussed Fertitta Entertainment LLC's settlement proposal on June 18, 2014. During that call, Fertitta Hospitality, LLC agreed to the majority of the proposed settlement terms and provided a counter-proposal for one outstanding issue. The parties agreed to proceed with drafting a formal settlement agreement, now that nearly all outstanding issues have been resolved.

2) Recitation of issues that have been resolved since the commencement of this proceeding

Counsel for Fertitta Entertainment, LLC has drafted the formal settlement agreement and accompanying documents, which the company's principles are currently reviewing.

3) List of issues that remain to be resolved

Once Fertitta Entertainment LLC approves the formal settlement documents, Fertitta Hospitality, LLC will review and provide revisions. After all outstanding issues are resolved, the parties will finalize and execute the settlement documents.

4) Timetable for resolution

The parties hope to finally resolve the issues raised by this proceeding within the next thirty (30) to sixty (60) days.
