5. adidas AG owns trademark registrations for its Three-Stripe Mark covering footwear including the following:



13. adidas AG is the owner of a federal trademark registration, Reg. No. 3,183,663, issued by the USPTO on December 12, 2006, for the Three-Stripe Mark, as depicted below, for "headwear."







No. 1,674,229, for “boots, slippers, sandals; shoes, boots and after ski boots for hiking and trekking, athletic shoes and general-purpose sports shoes.” A declaration has been filed pursuant to Sections 8 and 15 of the Lanham Act, 15 U.S.C. §§ 1058 and 1065, and this registration is incontestable. Pursuant to 37 C.F.R. 2.122(d)(1), a printout from the electronic database records of the USPTO, namely TARR and the Assignment Records, which shows the current status and title of Reg. No. 1,674,229 in the name of Opposer, adidas AG, is attached as **Exhibit 11**.

17. Since long prior to the filing date of the Application, adidas has used its Three-Stripe Mark and/or 3 Bars Logo on athletic shoes, clothing and cosmetics in United States commerce and the Three-Stripe Mark and 3 Bars Logo have come to signify the quality and reputation of adidas products, including clothing, footwear and personal care products.

18. The adidas Three-Stripe Mark and 3 Bars Logo are well-known and famous and has been for many years.

19. The Three-Stripe Mark and 3 Bars Logo are non-functional, and the public recognizes and understands that the Three-Stripe Mark and 3 Bars Logo distinguish and identify adidas merchandise.

20. Since long prior to the filing date of the Application, adidas extensively and continuously has used and promoted the Three-Stripe Mark and/or 3 Bars Logo in connection with apparel, footwear and cosmetics. In recent years, annual sales of products bearing the Three-Stripe Mark and 3 Bars Logo have totaled hundreds of millions of dollars within the United States. The Three-Stripe Mark and 3 Bars Logo have achieved fame and tremendous public recognition.

21. Since introducing the Three-Stripe Mark and 3 Bars Logo, adidas has spent millions of dollars promoting the mark and products bearing the marks. As a result of adidas' continuous and exclusive use of the Three-Stripe Mark and 3 Bars Logo in connection with adidas products, the marks enjoy wide public acceptance and association with adidas, and have come to be recognized widely and favorably by the public as an

indicator of the origin of adidas goods.

22. As a result of the extensive use and promotion of its Three-Stripe Mark and 3 Bars Logo, adidas has built up and now owns valuable goodwill that is symbolized by these marks. The purchasing public has come to associate the Three-Stripe Mark and 3 Bars Logo with adidas.

23. Based, *inter alia*, on the strength of the Three-Stripe Mark and 3 Bars Logo, the duration and extent of use of the Three-Stripe Mark and 3 Bars Logo in connection with adidas products, the duration and extent of advertising and publicity of the Three-Stripe Mark and 3 Bars Logo, the geographical extent or the trading area in which the Three-Stripe Mark and 3 Bars Logo have been used, the channels of the trade for the goods with which the Three-Stripe Mark and 3 Bars Logo are used, the degree of public recognition of the adidas Three-Stripe Mark and 3 Bars Logo, the adidas Three-Stripe Mark and 3 Bars Logo are "famous" as that term is used in Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c)).

24. Upon information and belief, the Opposed Mark as a trademark for goods identified as "cosmetics; nail polish, nail polish remover" in trademark class 3 and "clothing, namely, socks; footwear; pedicure sandals; pedicure slippers; sandals; flip flops" in trademark class 25.

25. Upon information and belief, the Applicant has not used the Opposed Mark as a trademark for the goods specified in the Application.

26. The goods specified in the Application are the same as or closely related to the goods of adidas.

27. The Opposed Mark incorporates and uses elements that are the same as

and/or highly similar to the adidas Three-Stripe Mark and/or 3 Bars Logo.

28. In view of the similarity of the respective adidas Three-Stripe Mark and/or 3 Bars Logo and the Opposed Mark and because the goods of adidas and Applicant are the same or closely related, it is alleged that the Opposed Mark so resemble the adidas Three-Stripe Mark and/or 3 Bars Logo as to be likely to cause confusion, or to cause mistake, or to deceive.

29. The Opposed Mark so resemble famous adidas Three-Stripe Mark and/or 3 Bars Logo as to be likely, when used in connection with the products of Applicant, to cause dilution of the distinctive quality of adidas Three-Stripe Mark and/or 3 Bars Logo within the meaning of Section 43(c) of the Lanham Act, 15 U.S.C. §1125(c) and thereby lessen the capacity of the adidas Three-Stripe Mark and/or 3 Bars Logo to identify and distinguish the goods of adidas and cause dilution of the distinctive quality of the registered adidas Three-Stripe Mark and/or 3 Bars Logo.

30. The use and registration of the Opposed Mark will erode the association of the Three-Stripe Mark and/or 3 Bars Logo with adidas, lessen the capacity of these trademarks to identify adidas as the source of apparel to customers and potential customers who would expect the trademarks to identify genuine and authorized products of adidas, blur the distinctive quality of said trademarks and otherwise cause dilution of the adidas Three-Stripe Mark and/or 3 Bars Logo.

31. adidas will be damaged by the registration of the Opposed Mark, among other reasons, because if Applicant is granted the registration herein opposed, it would thereby obtain at least a *prima facie* exclusive right to the use of the Opposed Mark.

32. For the foregoing reasons, Applicant is not entitled to registration of the

Opposed Mark and is not entitled to the exclusive use thereof.

WHEREFORE, Opposers, by their attorneys, respectfully request that their opposition be sustained and that the registration of application no. 85/388,668 be denied.
