NOTICE OF OPPOSITION

Honorable Sir:

1To1 Marketing S.A.R.L. is a Private Limited Liability Company organized under the laws of Luxembourg with its principal place of business at 7 Val Ste., Croix, L-1371, Luxembourg. 1To1 Marketing, LLC is a Limited Liability Company organized under the laws of the State of Connecticut and with its principal place of business at 1111 Summer Street, 5th Floor, Stamford, Connecticut 06905. 1To1 Marketing, S.A.R.L. is a wholly owned subsidiary of Peppers & Rogers Group B.V., a Private Limited Liability Company organized under the laws of the Netherlands with its principal place of business at Parklaan 32, Rotterdam, 3016 BC, Netherlands. 1To1 Marketing, LLC and Peppers & Rogers Group B.V. are affiliated entities under common control. Collectively, these entities are the “Opposers.” The above-identified Opposers believe they will be damaged by registration of the mark shown in the above-referenced application and hereby oppose the same.

As grounds for opposition, Opposers hereby allege:

1. 1To1 Marketing S.A.R.L. is the owner of the 1TO1 Federal Trademark Registrations Numbers 2,435,782 (Registration Certificate attached hereto as Opposers’ Exhibit A) and 2,401,235 (Registration Certificate attached hereto as Opposers’ Exhibit B), and the INSIDE 1TO1 Federal Trademark Registration No. 2,549,656 (Registration Certificate attached hereto as Opposers’ Exhibit C). Opposers have used the 1TO1 mark in commerce since at least as early as May 1, 1994, and are now using the mark in commerce within the United States in connection with magazines and newsletters in the fields of management consulting marketing, business/customer relationship management, marketing technology, and business development in

International Class 16, with cooperative advertising and marketing services; business management consulting in the fields of business/customer relationship management, marketing technology, and business development; and providing information via a global computer network in the field of business/customer relationship marketing in International Class 35 and with educational services, namely, conducting classes, seminars, training sessions and workshops, and classes offered via a global communications network, in the fields of effective marketing, consulting, and communication skills in International Class 41, *inter alia*, and are now using the INSIDE 1TO1 mark with publications, namely, electronic newsletters in the field of advertising and marketing, management and marketing, management consulting and executive recruiting in International Class 16, *inter alia*.

2. 1To1 Marketing S.A.R.L. is the owner of the 1TO1.COM, 1TO1MEDIA.COM and INSIDE1TO1.COM Domain Name Registrations (Whois Records attached hereto as Opposers' Exhibits D, E, and F). Opposers have used the 1TO1.COM, 1TO1MEDIA.COM and INSIDE1TO1.COM Domain Names in commerce since at least as early as May 11, 1996, June 9, 1997, and July 6, 1997, respectively, and are now using those Domain Names in commerce within the United States.

3. 1To1 Marketing, LLC is owner of the 1TO1 Trademark Registrations in Australia, Brazil, the European Union, Kuwait, Turkey, United Arab Emirates, and Venezuela; pending Trademark Applications in Saudi Arabia; and the MARKETING 1:1/PEPPERS & ROGERS GROUP and PEPPERS & ROGERS GROUP/EUROPE/MARKETING 1:1 E.U. Community Trademark Registrations.

4. 1To1 Marketing S.A.R.L. is owner of the 1TO1 Trademark Registrations in South Africa and Mexico.

5. Opposers own common law rights to the 1TO1, 1TO1 MEDIA, ONE TO ONE and INSIDE 1TO1 marks, *inter alia*, in the U.S. and Canada.

6. Opposers have expanded their use of the 1TO1, 1:1, 1TO1 MEDIA, and ONE TO ONE marks and derivative marks worldwide with magazines and newsletters in the fields of management consulting marketing, business/customer relationship management, marketing technology, and business development in International Class 16, with cooperative advertising and marketing services; business management consulting in the fields of business/customer relationship management, marketing technology, and business development; and providing information via a global computer network in the field of business/customer relationship marketing in International Class 35, and with educational services, namely, conducting classes, seminars, training sessions and workshops, and classes offered via a global communications network, in the fields of effective marketing, consulting, and communication skills in International Class 41, *inter alia*. (Screenshot from www.1to1media.com attached hereto as Opposers' Exhibit G).

7. Opposers' goods and services have been extensively and continuously offered to the public through multiple channels of trade. Opposers have also extensively advertised their services with the 1TO1, 1TO1 MEDIA, ONE TO ONE, and INSIDE 1TO1 marks throughout the United States. Opposers' use of each of the marks has been valid and continuous since the date of first use of each and none of the marks has been abandoned. Opposers' marks are symbolic of extensive goodwill and consumer recognition built up by Opposers through substantial amounts of time, effort, and monies spent in advertising and promotion. Opposers' 1TO1, 1TO1 MEDIA, ONE TO ONE, and INSIDE 1TO1 marks enjoy recognition, distinctiveness, secondary meaning and fame by virtue of their long and extensive use.

8. Upon information and belief, Applicant Un á Un is an incorporated association organized under the laws of Canada, with its principal place of business at 109 Des Grives Street, Ile-Bizard, QuebecH9C3B1, Canada.

9. Notwithstanding Opposers' prior rights in and to said marks, Applicant filed Application Serial No. 85/336247 on June 2, 2011 to register the mark UN A UN & Design for online journals, namely, blogs featuring information, news, commentary, editorials, to sensitize, raise awareness and teach the public on environmental and health issues in International Class 41.

10. The English translation of "UN A UN" in Applicant's mark is "ONE TO ONE."

11. Per the Doctrine of Foreign Equivalents, Applicant's UN A UN Design mark is confusingly similar to Opposers' marks in sound, appearance, and commercial impression.

12. Applicant's services are related to the goods and services sold and provided in connection with Opposers' marks and represent a natural zone of expansion for Opposers; and such goods and services travel in and are promoted through the same channels of trade for sale to, and use by the same class of purchasers.

13. In view of the similarity of the respective marks and the related nature of the goods and services of the respective parties, it is alleged that Applicant's mark so resembles Opposers' 1TO1 and INSIDE 1TO1 marks previously used and registered, and not abandoned; as well as Opposer's derivative marks therefrom, so as to be likely to cause confusion, or to cause mistake, or to deceive, and to dilute Opposers' marks because Opposers' marks were famous prior to the earliest date on which Applicant alleged use of its applied for mark.

14. Opposers have no control over the nature and quality of the services marketed by Applicant with its applied for mark or over the manner in which the Applicant's applied for mark

is used in advertising and marketing such services. Any defect, objection or fault found with Applicant's services marketed under its applied for mark would necessarily reflect upon and seriously injure the reputation which Opposers have established for their services offered with their marks.

15. Registration of Applicant's applied for mark would cause Opposers irreparable damage, would place a cloud on the title of Opposers' 1TO1 and INSIDE 1TO1 Registrations, and Opposer's derivative marks therefrom; and would work serious injury to the business of Opposers by leading customers of Applicant to believe that the services they receive from Applicant are those of Opposers or are sold with Opposers' consent.

16. Opposers' domain name registrations would be damaged and the value of their domain names jeopardized by the issuance of a federal registration to Applicant.

17. There is no issue as to priority. The Applicant's alleged date of priority is subsequent to the issuance date of Opposers' Registrations.

WHEREFORE, Opposers pray that Application Serial No. 85/336247 be rejected, in whole or in part, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Opposers.


