NOTICE OF OPPOSITION

In the matter of an application to register a trademark under the Trademark Act of 1946, Serial No. 85/486,475, filed December 3, 2011, in the name of Armada Health Care, LLC, published for opposition in the Trademark Official Gazette of May 15, 2012, Vol. 1378, No. 3, at page TM 321, for the mark ARMADA SPECIALTY PHARMACY SUMMIT, the Opposer, ArmadaCorp Capital, LLC, believes it will be damaged by registration of said alleged trademark and hereby opposes same. The grounds for opposition are as follows:

1. The Opposer, ArmadaCorp Capital, LLC [hereinafter "Armada"], is a limited liability company duly organized and existing under the laws of the State of Maryland and having its place of business 230 Shilling Circle, Hunt Valley, Maryland 21031. Opposer provides business, consulting, management and administration services in the fields of employee benefits, human resources, workmen's compensation, insurance casualty coverage, risk management, health care,

health and productivity, as well as related services, including the administration of pharmacy benefit plans (the “Armada Services”).

2. Since prior to the date of first use alleged in the application opposed herein, Armada has, and is now, engaged in providing services, in commerce in the United States, under and in connection with the trade name and trademark **ARMADA**, as well as other formatives of that name and mark, including ArmadaCare, ArmadaHealth, ArmadaBenefits, ArmadaAdministrators, ArmadaHR, and ArmadaCasualty (collectively, “**ARMADA** Marks”). Armada continuously has used said Opposer's **ARMADA** Marks in commerce in connection with Armada’s services, to identify and designate same, and to distinguish those services, and Opposer’s business, from those of others.

3. Opposer is the owner of, and will rely on herein, the following U.S. trademark registrations:

Said registrations are valid and subsisting, and constitute *prima facie* and/or conclusive evidence of Opposer's ownership of the **ARMADA** Marks set forth therein, and exclusive right to use same in commerce in connection with the services set forth in said registrations. Attached hereto are the printouts of information from the electronic database records of the U.S. Patent and Trademark Office showing the current status and title of the registrations.

4. Since Armada's initial use of its **ARMADA** Marks, Armada has advertised, offered, provided and sold its Armada Services under and in connection with said marks to the public, through various channels of trade, and in commerce, with the result that Armada's customers and the public in general have come to know and recognize Opposer's **ARMADA** Marks and associate same with Armada and/or the services and/or business of Opposer. Opposer thus has built up goodwill in connection with the services offered under Opposer's **ARMADA** Marks.

5. On December 3, 2011, Applicant filed an application to register the mark ARMADA SPECIALTY PHARMACY SUMMIT. Said application was accorded serial no. 85/486,475, and was published for opposition in the Official Gazette of May 15, 2012, at page TM 321, identifying the services as follows:

arranging and conducting business conferences, in Class 35; and
educational services, namely, conducting conferences in the field of
pharmaceuticals, in Class 41.

6. The ARMADA SPECIALTY PHARMACY SUMMIT mark sought to be registered by Applicant is identical to, a colorable imitation of, and so resembles, Opposer's prior and aforesaid **ARMADA** Marks as to be likely, when used in connection with the services of Applicant, to cause confusion or mistake or to deceive.

7. On information and belief, the services set forth in the application opposed herein include, and/or are similar and/or related to, the services in connection with which Armada uses Opposer's **ARMADA** Marks, and on information and belief, the services set forth in the opposed

application are and/or will be sold through the same and/or similar channels of trade, and/or to the same general class of purchasers, in and to which Armada's services are marketed and/or sold.

8. The registration and/or use of the ARMADA SPECIALTY PHARMACY SUMMIT mark, as set forth in the opposed application, is likely to cause confusion, mistake, and/or to deceive as to origin, sponsorship, and/or association of Applicant's services to be sold under the ARMADA SPECIALTY PHARMACY SUMMIT mark sought to be registered by Applicant vis-a-vis Armada and/or Opposer's **ARMADA** Marks, and/or to mislead consumers of Applicant's services and/or Armada's services, and/or the public in general, into believing that Applicant's services are sold by, emanate from, and/or in some way, directly or indirectly, are associated with Armada, and/or Opposer's **ARMADA** Marks, or services, or vice versa, to the damage and detriment of Armada.

9. By virtue of the foregoing, Opposer believes it will be damaged by the registration by Applicant of the ARMADA SPECIALTY PHARMACY SUMMIT mark, as set forth in the application therefor, serial no. 85/486,475.

10. If Applicant is granted the registration opposed herein, and Applicant obtains such rights as conferred under the Principal Register of the Trademark Act of 1946, Applicant will obtain unlawful gain and advantage to which it is not entitled under the Trademark Act of 1946, to the detriment and harm of Opposer.

WHEREFORE, this Opposer, ArmadaCorp Capital, LLC, believes and alleges that it will be damaged by registration of the ARMADA SPECIALTY PHARMACY SUMMIT mark of application serial no. 85/486,475, as aforesaid, and prays that:


- a) judgment in the present opposition be entered in favor of Opposer;


