NOTICE OF OPPOSITION

Kenneth Cole Productions (LIC), LLC (“Opposer”), a limited liability company organized and existing under the laws of Delaware, with an address of 603 West 50th Street, New York, NY 10019, believes that it will be damaged by registration of the mark REACT shown in Application Serial No. 85/211,687, applied for by Implus Footcare, LLC (“Applicant”) for “insoles for footwear” in International Class 25.

As grounds for Opposition it is alleged that:

1. Opposer is a limited liability company duly organized and existing under the laws of the State of Delaware, with an address of 603 West 50th Street, New York, NY 10019.
2. Opposer, directly and/or indirectly through its parent company, Kenneth Cole Productions, Inc., is in the business of designing, manufacturing, having manufactured, distributing, promoting, advertising, offering for sale, and selling, directly, indirectly,

and/or through licensees, a wide variety of goods, including, but not limited to, footwear, clothing, accessories, handbags, small leather goods, business cases, travel bags, backpacks, jewelry, watches, eyewear, fragrances, and other goods (“Opposer’s Goods”).

3. Opposer, directly and/or indirectly through its parent company, Kenneth Cole Productions, Inc., is in the business of providing, promoting, and advertising, directly, indirectly, and/or through licensees, retail store services for Opposer’s Goods (“Opposer’s Services,” collectively with Opposer’s Goods, “Opposer’s Goods and Services”).

4. In connection with Opposer’s Goods and Services, Opposer is the owner of a family of “REACTION” trademarks, including the marks REACTION, REACTION KENNETH COLE, and KENNETH COLE REACTION (collectively and/or individually, “Opposer’s Trademarks”). Opposer owns hundreds of registrations for Opposer’s Trademarks worldwide.

5. Opposer has used and is currently using Opposer’s Trademarks in conjunction with Opposer’s Goods and Services to identify the source of such goods and services.

6. Opposer has used Opposer’s Trademarks in interstate commerce openly, notoriously, and continuously since the date of first use.

7. Opposer has used Opposer’s Trademarks in conjunction with Opposer’s Goods since at least as early as 1995.

8. In connection with Opposer’s Trademarks, Opposer is the owner numerous United States Trademark Registrations, including the following (collectively, “Opposer’s Registrations”):

A copy of Opposer's Registrations, as well as the TARR and Assignment Records associated with the same, as printed from the U.S. Patent and Trademark Office's ("PTO's") website, are attached hereto as Exhibit A.

9. Opposer's Registrations for Opposer's Trademarks are valid and subsisting.

10. All three of Opposer's above-mentioned trademark registrations for the mark REACTION are incontestable pursuant to 15 U.S.C. § 1065.

11. Throughout the years, Opposer has expended substantial amounts of time, money, and effort in advertising, promoting and popularizing Opposer's Trademarks in conjunction with Opposer's Goods and Services.

12. By virtue of Opposer's use of Opposer's Trademarks and the advertising and promotional efforts associated therewith, Opposer has built up enormous goodwill and secondary meaning in connection with Opposer's Trademarks.

13. The trade, industry and public have throughout the years used, associated and attributed usage of Opposer's Trademarks with Opposer and Opposer alone, so that the trade in general and the purchasing public in particular have come to know and recognize

Opposer's Trademarks and that Opposer's Goods and Services originate with and belong to Opposer.

14. Opposer's Trademarks are strong trademarks, as the marks are arbitrary when used in conjunction with Opposer's Goods and Services and are inherently distinctive.

15. Opposer's Trademarks are also strong trademarks based on Opposer's long term use of the marks, as well as Opposer's sales, promotion and advertising for Opposer's Goods and Services in conjunction with Opposer's Trademarks.

16. Opposer's Trademarks are well-known and famous in the United States and throughout many countries in the world.

17. Opposer's Trademarks became well-known and famous in the United States before Applicant filed the trademark application at issue.

18. Opposer's Trademarks became well-known and famous in the United States before Applicant used the proposed mark REACT for the goods identified in the application at issue.

19. Upon information and belief and according to the U.S. Patent and Trademark Office's ("PTO") records, Applicant is a corporation, organized and existing under the laws of Delaware, with an address of 2001 T.W. Alexander Drive, Box 13925, Durham, NC 27709.

20. Upon information and belief and according to the PTO's records, on or about January 6, 2011, Applicant filed an application, assigned Serial No. 85/211,687 ("Applicant's Application"), to register the mark REACT ("Applicant's Purported Mark") for "insoles for footwear" in International Class 25 ("Applicant's Goods").

21. Upon information and belief and according to the PTO's records, Applicant's Application for Applicant's Purported Mark was filed based on Applicant's intent to use the mark.
22. Upon information and belief and according to the PTO's records, Applicant had not used Applicant's Purported Mark prior to filing Applicant's Application.
23. Opposer has been using Opposer's Trademarks REACTION and/or KENNETH COLE REACTION in interstate commerce since 1995, over fifteen years prior to the filing of Applicant's Application of January 6, 2011, and any other priority date to which Applicant might be entitled for Applicant's Purported Mark.
24. Opposer clearly has superior and paramount rights as compared to Applicant with regard to Opposer's Trademarks and Applicant's Purported Mark.
25. Opposer's Trademarks, and most particularly Opposer's mark REACTION, and Applicant's Purported Mark REACT are nearly identical in appearance, connotation and pronunciation.
26. Opposer's Trademark REACTION and Applicant's Purported Mark REACT both include the root "react" and are identical except for Applicant's addition of the suffix "tion".
27. Applicant's Purported Mark REACT is confusingly similar to Opposer's Trademarks.
28. Due to the similarity of Opposer's Trademarks and Applicant's Purported Mark in appearance, connotation and pronunciation, the contemporaneous use of the respective marks will create a likelihood confusion, mistake and/or deception among the consuming public and/or the trade.

29. Applicant's Goods identified in Applicant's Application are identical, nearly identical, and/or closely related to Opposer's Goods and Services, provided by Opposer under Opposer's Trademarks.

30. Applicant's Goods identified in Applicant's Application, namely, "insoles for footwear," are used in conjunction with Opposer's Goods, namely "footwear."

31. Applicant's Goods identified in Applicant's Application are within the natural zone of expansion of Opposer's Goods and Services contained in Opposer's Registrations.

32. Applicant's Goods are of a type provided through the same channels of trade as Opposer's Goods and Services.

33. Applicant's Goods are of a type advertised and distributed through the same channels of trade as Opposer's Goods and Services.

34. Applicant's Goods are distributed and sold to the same class of purchasers as Opposer's Goods and Services.

35. Based on the above-mentioned similarities, Applicant's Goods would reasonably be expected by the trade and purchasing public to emanate from and/or be sponsored by the same source as Opposer's Goods and Services.

36. Because of the strength of Opposer's Trademarks, the similarity of Opposer's Trademarks and Applicant's Purported Mark, and the similarity of the parties' respective goods and services, the contemporaneous use and/or registration of Opposer's Trademarks and Applicant's Purported Mark will create a likelihood of confusion, mistake and/or deception among the consuming public and/or the trade as to the origin of the respective goods and services, resulting in damage to Opposer.

37. Because of the strength of Opposer's Trademarks, the similarity of Opposer's Trademarks and Applicant's Purported Mark, and the similarity of the parties' respective goods and services, any faults or imperfections in Applicant's Goods will reflect adversely on Opposer and its established goodwill and reputation, all to the detriment of Opposer.

38. The registration of Applicant's Purported Mark to Applicant would cause further damage and injury to Opposer, to Opposer's Trademarks, and to Opposer's rights to use Opposer's Trademarks.

39. If Applicant is granted a registration for Applicant's Purported Mark, Applicant would obtain thereby at least the *prima facie* exclusive right to use such mark, and thus such registration would be a source of damage and injury to Opposer.

40. The contemporaneous registration and/or use by Applicant of Applicant's Purported Mark REACT also would dilute Opposer's rights to Opposer's Trademarks through blurring, and could eventually result in a lack of designation or indication or origin and a loss of distinctiveness and exclusivity in Opposer's Trademarks.

41. For the foregoing reasons, Applicant is not entitled to adopt, use or seek registration of Applicant's Purported Mark in connection with the goods identified in Applicant's Application.

42. For the foregoing reasons, Applicant's Purported Mark should be denied registration under Sections 2(d) and 43(a) of the Lanham Act (15 U.S.C. §§ 1052(d) and 1125(a), respectively).

WHEREFORE, Opposer respectfully requests that the Opposition be sustained and the registration of App. Serial No. 85/211,687 for the mark REACT to Applicant be refused.
