NOTICE OF OPPOSITION

Opposer Pabst Brewing Company (“**Pabst**”) believes that it will be damaged by registration of the mark shown in U.S. Application Serial No. 76/414,826 (the “**Application**”), filed by Michael Britt, Richie McDonald, and Keech Rainwater (“**Applicants**”), and hereby files this Notice of Opposition.

**I.
Background**

A. The Application

1. Applicants filed the Application on or about May 30, 2002, under Section 1(a) of the Lanham Act claiming use in commerce of the mark LONESTAR (“**Applicants’ Mark**”) in connection with “Clothing merchandise, namely t-shirts, sweatshirts, jackets and headwear,” in International Class 25.

2. Applicants subsequently amended the identification of goods to “Clothing merchandise, namely, t-shirts, sweatshirts, jackets and headwear, sold in connection with the entertainment services of a live music group” in International Class 25.

3. The Application asserts a date of first use in commerce of Applicants’ Mark at least as early as January 1, 1995.

4. The Application was suspended pending the prosecution of two Lone Star marks by Lone Star Steakhouse & Saloon, Inc. and LSFS Cactus LLC (collectively “LSS”), Serial Nos. 75883253 and 75883254, for clothing items in Class 25.

5. Pabst opposed LSS’s two applications, Opposition Serial Nos. 91161955 and 91161954. LSS expressly withdrew the applications in Opposition Serial Nos. 91161955 and 91161954 and the oppositions were dismissed without prejudice.

6. After LSS’s two Lone Star applications for clothing items in Class 25, Serial Nos. 75883253 and 75883254, were withdrawn the Application was published for opposition on June 5, 2012.

7. Pabst filed a timely Request for Extension of Time to Oppose the Application on June 12, 2012.

8. The Trademark Trial and Appeal Board granted Pabst’s Request for Extension of Time to Oppose on June 12, 2012, allowing Pabst until October 3, 2012 to file a notice of opposition to the Application.

B. Pabst’s Prior Oppositions to Applications for LONE STAR for Clothing

9. For years, Pabst has made efforts to obtain a registration for a LONE STAR mark for clothing. These efforts have included opposing conflicting third party applications.

10. In December 1999, Lone Star Steakhouse & Saloon, Inc. filed two applications for LONE STAR marks for various clothing items in International Class 25. These applications claimed first-use-in-commerce dates of October 12, 1989.

11. When the Lone Star Steakhouse & Saloon, Inc. applications published in 2004, Pabst filed two oppositions, Opposition No. 91161954 and Opposition No. 91161955, against the applications.

12. Pabst opposed the two Lone Star Steakhouse & Saloon, Inc. applications based on a likelihood of confusion with Pabst's decades-long use of the mark LONE STAR to identify beer and other goods.

13. After Pabst filed its evidence and briefs in the oppositions, Lone Star Steakhouse & Saloon, Inc. abandoned its two applications.

C. Pabst's Current Application for LONE STAR in International Class 25

14. On or about April 22, 2010, Pabst filed U.S. Application Serial No. 85/020,633 under Section 1(a) of the Lanham Act claiming use in commerce of the mark LONE STAR in connection with "Clothing, namely, shirts, t-shirts, hats, shorts, jackets, sweaters, sweatshirts, sweatpants and footwear," in International Class 25.

15. On June 11, 2010, the Trademark Examiner for Pabst's LONE STAR application advised Pabst that its application "may be refused registration under Trademark Act Section 2(d) because of a likelihood of confusion with" the Application filed by Applicants, should the Application mature into a registration.

16. The Trademark Examiner for Pabst's LONE STAR application suspended Pabst's LONE STAR application on October 5, 2010, pending the disposition of the Application.

17. The Application is the only remaining trademark application or registration cited by the Trademark Examiner as potentially blocking Pabst's LONE STAR application.

D. Pabst's Trademark Registrations for LONE STAR

18. Pabst owns numerous registrations for the mark LONE STAR, including without limitation:

- U.S. Registration No. 674,291 for LONE STAR & design for “beer” in International Class 32, registered February 17, 1959 and now incontestable (attached as **Exhibit A**);
- U.S. Registration No. 2,191,783 for LONE STAR for “alcoholic malt beverages” in International Class, registered September 29, 1998 and now incontestable (attached as **Exhibit B**);
- U.S. Registration No. 3,264,576 for LONE STAR for “beer” in International Class 32, registered July 17, 2007 and now incontestable (attached as **Exhibit C**);
- U.S. Registration No. 4,120,493 for LONE STAR & design for “beer” in International Class 32, registered April 3, 2012 (attached as **Exhibit D**).

19. For Pabst's LONE STAR registrations that are incontestable under 15 U.S.C. § 1115(b), those registrations are conclusive evidence of:

the validity of the registered mark and of the registration of the mark, of the registrant's ownership of the mark, and of the registrant's exclusive right to use the registered mark in commerce.

20. Pabst's LONE STAR mark was registered with the United States Patent and Trademark Office before Applicants filed the Application.

21. The United States Patent and Trademark Office issued U.S. Registration No. 674,291 in 1959, at least forty years before Applicants filed the Application.

22. On information and belief, Applicants were born after the United States Patent and Trademark Office issued U.S. Registration No. 674,291.

23. The United States Patent and Trademark Office issued U.S. Registration No. 2,191,783 in 1998, at least three years before Applicants filed the Application.

24. On information and belief, Pabst's LONE STAR mark was registered with the United States Patent and Trademark Office before Applicants first began using Applicants' Mark.

E. Pabst's Lengthy Use of Its LONE STAR Trademark

25. All of the registrations in Exhibit A, Exhibit B, Exhibit C, and Exhibit D are in full force and effect and are currently owned and used by Pabst.

26. Pabst, or its predecessors in interest, began using the LONE STAR mark in commerce at least as early as February 1940.

27. Pabst, or its predecessors in interest, began using the LONE STAR mark in commerce on or in connection with beer or alcoholic malt beverages at least as early as February 1940.

28. Pabst continues to use the LONE STAR mark today.

29. Pabst, or its predecessors in interest, have continuously used the LONE STAR mark since at least as early as February 1940.

30. Pabst, or its predecessors in interest, since at least as early as 1980 have used, and is now using, LONE STAR as a corporate name, trade name, trademark, and /or use analogous to trademark use in connection with the sale of a variety of goods including, but not limited to, beer, clothing, steins, and glassware.

31. Pabst has not abandoned the LONE STAR mark.

32. On information and belief, Pabst began using its LONE STAR mark in commerce at least fifty years before Applicants began using Applicants' Mark.

33. On information and belief, Applicants were born after Pabst first began using its LONE STAR mark.

F. Similarities Between Pabst's LONE STAR Mark and Applicants' Mark

34. The dominant portion of Applicants' Mark is the word LONESTAR.

35. The dominant portion Pabst's LONE STAR mark and U.S. Registration Nos. 4,120,493, 3,264,576, 2,191,783, and 674,291 is the wording LONE STAR.

36. The word LONESTAR is highly similar to the wording LONE STAR.

37. Pabst's LONE STAR mark and U.S. Registration Nos. 4,120,493, 3,264,576, 2,191,783, and 674,291 identify beer and alcoholic malt beverages.

38. Applicants' Mark and the Application identify clothing merchandise, namely, t-shirts, sweatshirts, jackets and headwear, sold in connection with the entertainment services of a live music group.

39. Beer products and clothing products often emanate from a single source.

40. Beer products are related to clothing products, and vice versa.

41. At least 450 current, live U.S. federal registrations (a list of which is attached as **Exhibit E**) identify both beer in International Class 32 and clothing items in International Class 25.

**II.
Cancellation Based on Likelihood of Confusion**

42. Applicants' Mark so resembles Pabst's LONE STAR mark as to be likely, when used on or in connection with clothing merchandise, namely, t-shirts, sweatshirts, jackets and headwear, sold in connection with the entertainment services of a live music group, to cause confusion, or to cause mistake, or to deceive.

43. Applicants' Mark so resembles Pabst's LONE STAR mark, which is registered with the United States Patent and Trademark Office as U.S. Registration Nos. 4,120,493, 3,264,576, 2,191,783, and 674,291, and which has been used as a common law mark since at

least as early as 1980, as to be likely, when used on or in connection with clothing merchandise, namely, t-shirts, sweatshirts, jackets and headwear, sold in connection with the entertainment services of a live music group, to cause confusion, or to cause mistake, or to deceive.

44. Applicants' Mark so resembles Pabst's LONE STAR mark, previously used in the United States by Pabst and not abandoned, as to be likely, when used on or in connection with clothing merchandise, namely, t-shirts, sweatshirts, jackets and headwear, sold in connection with the entertainment services of a live music group, to cause confusion, or to cause mistake, or to deceive.

45. Pabst will be damaged by the registration of Applicants' Mark.

III. Cancellation Based on Improper Ownership

46. On information and belief, Applicants are current or former members of a country music group called "Lonestar."

47. According to <http://en.wikipedia.org/wiki/Lonestar> (attached as **Exhibit F**), the original members of the Lonestar country music group included Richie McDonald, Michael Britt, Keech Rainwater, Dean Sams, and John Rich.

48. According to <http://en.wikipedia.org/wiki/Lonestar>, Cody Collins is also a past member of the Lonestar country music group.

49. The Application does not identify Dean Sams, John Rich, or Cody Collins as owners of the Application.

50. On information and belief, the Application was not filed by the rightful owners of Applicants' Mark.

51. On information and belief, the Application omits one or more rightful owners of Applicants' Mark.

52. On information and belief, one or more of Dean Sams, John Rich, and Cody Collins are rightful co-owners of Applicants' Mark.

53. On information and belief, one or more of Dean Sams, John Rich, and Cody Collins should have been identified as owners of the Application.

54. On information and belief, the Application is void *ab initio* because it omits one or more of Dean Sams, John Rich, and Cody Collins.

**IV.
Prayer**

WHEREFORE, Pabst prays that U.S. Application Serial No. 76/414,826 be refused, and that no registration be issued thereon to Applicants, and that this Notice of Opposition be sustained in favor of Pabst.

Lonestar is an American country music group consisting of Richie McDonald (lead vocals), Michael Britt (lead guitar, background vocals), Keech Rainwater (drums) and Dean Sams (keyboards, backing vocals). John Rich was also the group's bass guitarist and second lead vocalist until 1998, when he was fired from the group. He left for a solo career, before joining Big Kenny in the duo Big & Rich in 2003. Since Rich's departure, Lonestar has not had an official bass guitarist. McDonald left the band in November 2007 for a solo career before returning in 2011. During that time, Cody Collins, who had formerly been in another country group called McAlyster, replaced McDonald as the band's lead vocalist.

Lonestar first charted in late 1995. Nine of the band's singles have reached number 1 on this chart, their longest-lasting being the 8-week run for "Amazed"; this song also reached number 1 on the Billboard Hot 100, becoming the first country single to do so since Kenny Rogers and Dolly Parton's "Islands in the Stream" in 1983. The group has also recorded eight studio albums and a Greatest Hits compilation. Three of their albums have been certified gold, while three more have been certified platinum or higher. They have sold more than 6.5 million records worldwide.

Lonestar began in 1992 as a band named Texassee. This name was derived from the fact that all five members were natives of Texas, and met in Nashville, Tennessee's Opryland USA theme park.^{[1][2]} The original lineup consisted of lead singer/rhythm guitarist Richie McDonald (Lubbock), lead guitarist Michael Britt (Fort Worth), drummer Keech Rainwater (Plano), keyboardist Dean Sams (Garland), and bass guitarist/co-lead vocalist John Rich (Amarillo). Before Lonestar's foundation, Rainwater played drums in another country band called Canyon, which recorded for 16th Avenue Records charted in the country top 40 with "Hot Nights" in 1989.^[3] By 1992, Texassee changed its name to Lonestar. The band first played at a concert in Nashville in 1993 and signed to BNA Records by 1995.

Musical career

Lonestar

The band's first single for BNA Records, "Tequila Talkin'", reached a peak of number eight on the *Billboard* Hot Country Singles & Tracks chart. It was included on Lonestar's self-titled debut album.^[1] The next single, "No News" (originally the b-side to "Tequila Talkin'"), became the band's first Number One hit in April 1996.^[3] After it, "Runnin' Away with My Heart" also went to number eight, followed by "When Cowboys Didn't Dance" at number 45 and "Heartbroke Every Day" at number eighteen. The latter two songs overlapped on the charts with "Maybe He'll Notice Her Now", a duet that McDonald recorded with Mindy McCready for her debut album *Ten Thousand Angels*, which also peaked at number eighteen.^[4]

Crazy Nights

In 1997, the band released its second album, *Crazy Nights*. It was led off with the band's second Number One, "Come Cryin' to Me".^[3] The next singles were "You Walked In", "Say When" and "Everything's Changed", with respective peaks at twelve, thirteen and two on the country music charts.^[3] Written by Robert John "Mutt" Lange, "You Walked In" was the band's first entry on the *Billboard* Hot 100, where it peaked at number 93; "Everything's Changed" went to 95 on the same chart.^[3]

Shortly after the release of "Everything's Changed", Rich was fired from the band^[5] and began a solo career for BNA. He charted the singles "Pray for You" and "Forever Loving You", and later founded the duo Big & Rich with Big Kenny in 2003.

Lonely Grill

Lonely Grill, the first album not to include Rich, was released in 1999. Its first single, "Saturday Night", failed to reach Top 40. However, it was soon followed by the ballad "Amazed", which became the group's biggest crossover hit. Having spent eight weeks at Number One on the country charts, "Amazed" would later reach Number One on the *Billboard* Hot 100 as well,^[2] making Lonestar the first country act to top both the Hot Country Songs and Hot 100 charts since 1983, when Kenny Rogers and Dolly Parton accomplished the same feat with "Islands in the Stream".^[6] All of the other singles from *Lonely Grill* ("Smile", "What About Now", and "Tell Her") reached Number One as well, and the album was certified double platinum by the RIAA. *Lonely Grill* was followed in 2000 by a Christmas album called *This Christmas Time*.

I'm Already There

I'm Already There was the title of Lonestar's fourth studio album. Released in 2001, this album continued in a more country pop oriented direction. The lead-off single (which was the title track) spent six weeks at Number One, followed by "With Me" at #10, "Not a Day Goes By" at #3, and the Mark McGuinn-penned "Unusually Unusual" at #12.

From There To Here: Greatest Hits

2003 saw the release of a greatest hits compilation entitled *From There to Here: Greatest Hits*. This album reprised the greatest hits from their first four studio albums, in addition to producing two new singles in the Number One "My Front Porch Looking In" and a #8-peaking cover of Marc Cohn's "Walking in Memphis".

Let's Be Us Again

Let's Be Us Again was released in 2004. This album produced three singles, including its title track (#4 on the country charts) as well as "Mr. Mom", their final Number One. The third single, "Class Reunion (That Used to Be Us)", peaked at #16, however, and *Let's Be Us Again* did not sell as well as *I'm Already There*.

Coming Home

Coming Home followed a year later. Only two singles were released from this album: "You're Like Comin' Home" (#8 on the country charts) and "I'll Die Tryin'", both of which were previously recorded by the Canadian country band Emerson Drive on their 2004 album *What If?*. "I'll Die Tryin'" also became the group's first single since 1999's "Saturday Night" to miss the Top 40.

Mountains

Mountains, their final album for BNA, sold even more poorly than *Coming Home* did, and like *Coming Home*, it only produced two singles, including its #10 title track (co-written by Larry Boone) and the #51 "Nothing to Prove".^[7] In March 2007, Lonestar was dropped from BNA's roster. Guitarist Michael Britt attributes the group's downfall in the mid-2000s to the label's choices in singles, saying in an interview with CMT, "I think we painted ourselves into a corner... They started putting out a bunch of family-type songs. I think that really pigeonholed us. The majority of the band didn't really want to continue doing that same thing. But that's what kept getting put out."^[7]

Departure of Richie McDonald

Lead singer Richie McDonald also announced that he would be leaving the group at the end of 2007 to begin a solo career. Cody Collins, who formerly performed on MCA Nashville Records in the band McAlyster, was confirmed as his replacement.^[8] Lonestar's first compilation with Collins as lead singer was a Christmas music compilation titled *My Christmas List*, available exclusively at the restaurant and gift shop chain Cracker Barrel.^[9] Since his departure from Lonestar, McDonald has charted two solo singles of his own: "How Do I Just Stop" and "Six-Foot Teddy Bear", both of which reached #51 on the country charts. The latter was released on Stroudavarious Records.

Party Heard Around the World

The group's first single to feature Collins on lead vocals was "Let Me Love You", which was released in early 2008 on the Co5 label. The song made it to #50 on the country music charts. It is the first single from the album *Party Heard Around the World*, released on April 27, 2010. "You're the Reason Why" was released to radio on March 2, 2010.

Collins left in 2011, with McDonald rejoining the lineup. The band plans to resume touring in 2012 and record a new album to celebrate its 20th anniversary.^[10]

Television appearances

In February 2007, all four members of Lonestar competed on separate episodes of *Wheel of Fortune* during a country music-themed week, in which contestants and country music artists played together.^[11] McDonald won \$61,000 for St. Jude Children's Research Hospital, Britt won \$59,350 for Adopt-a-Platoon, while Sams and Rainwater won \$10,000 each for charities.^[12] McDonald previously competed on an identical week in 2003, where his winnings were donated to Habitat for Humanity.^[13]

The group appeared on *The Price Is Right*, serving as the house band on a June 17, 2010 episode. They performed the show's theme song, along with a sample of songs from *Party Heard Around the World*.^[14]
