**RxD MEDIA, LLC'S FIFTH MOTION

On April 3, 2014, the Board ordered that opposer RxD Media, LLC ("RxD") appoint new counsel. On July 1, 2014, the Board issued an order extending the time to do so until July 3, 2014. On July 2, 2014, RxD filed a motion for a 30-day extension of time – i.e., until August 4, 2014. On August 1, 2014, RxD filed another motion for a 30-day extension of time – i.e., until September 3, 2014.


RxD continues to work diligently to obtain new counsel and has made additional progress in those efforts. Those activities have included researching potential counsel, meeting and speaking with a variety of potential counsel, assessing the best fit for RxD, and reviewing potential fee arrangements. RxD has made progress in narrowing down the list of potential candidates. Nevertheless, RxD believes it will be unable to finalize its agreement with new

counsel on or before August 4. RxD anticipates, however, that it will be able to retain new counsel within the next 30 days.

On August 30, 2014, RxD e-mailed counsel for IP Application Development LLC, Glenn Gunderson, regarding this request. As of the time of this filing, RxD had not received a response from Mr. Gunderson.

Based on the circumstances described above, RxD respectfully requests an additional 30-day extension – i.e., until on or before October 3, 2014 – to appoint new counsel.
