From Charlottesville to Los Angeles, progressive towns and cities around the country are changing their laws to permit backyard chickens.

Our goal is to work with the Blacksburg Town Council to amend the code to allow backyard chickens.

### The Practical Reasons for Backyard Chickens

**Farm fresh eggs are "slow food".** Slow food is created with care from healthy plants and animals, it's the belief that healthy food can help to build community. Eggs are also nature's near perfect protein, 97% in the form of readily available, essential amino acids. Eggs are the standard used to measure the protein quality of other ingredients.

A happy laying hen will lay one egg per day for about 300 days a year. A small chicken coop with six hens will produce about three dozen super fresh eggs per week. That's plenty of eggs to eat and plenty of high-quality protein to give away.

**Reduce your carbon footprint.** Chickens eat just about anything, give them your leftovers instead of tossing them in the garbage. If you want omega-3 rich eggs (about \$5.00 a dozen around here) feed them some flaxseed along with their regular diet.

**Chicken compost is a natural complement to your home garden.** Chicken droppings are high in nitrogen and make excellent fertilizer for your garden. If you let them wander around your fenced back yard a few hours a day they will green your lawn.

**Chickens are an environmentally friendly insecticide.** They will hunt and peck around your yard cleaning up the bugs for as long as you let them. As they scratch around looking for grubs, cockroaches, aphids and other insects they automatically aerate your soil. If you make a chicken tractor you can put them to work anywhere in your yard.

**Kids Learn First Hand About Food Production** Young children love caring for animals; collecting eggs, feeding and cleaning the pen are things they can do. And when kids help care for chickens they see the very beginnings of where food comes from.

### How can chickens (hens) live in urban areas? Here's what other towns have done:

**No more than 6 chickens per household** (greatly reduce the chance of attracting pests and 3 chickens produce more than enough eggs for a family of 4).

**NO ROOSTERS** (Its just not neighborly or necessary, hens do not need roosters to produce eggs). Hens cluck gently, far quieter than a barking dog.

**Hens must be kept securely penned or fenced at ALL times** Fences protect your hens from vermin, predators, and diseases spread by wild birds. Chicken tractors like the one shown are a humane, safe way to keep healthy hens. It can be moved around a small yard to help with climate control and cleaning.

**Permits** (similar to that of dogs). **This fee will contribute to paying the animal control officer to enforce the regulations.**





### WHAT'S A HOKIE?

The answer leads all the way back to 1896 when Virginia Agricultural and Mechanical College changed its name to Virginia Polytechnic Institute. With the change came the necessity for writing a new cheer

and a contest for such a purpose was held by the student body.

Senior O.M. Stull won first prize for his "Hokie" yell which is still used

today. Later, when asked if "Hokie" had any special meaning, Stull explained the word was solely the product of his imagination and was used only as an attention-getter for his yell. It soon became a nickname for all Tech teams and for those people loyal to Tech athletics.

The official university school colors - Chicago Maroon and Burnt Orange - also were introduced in 1896. The colors were chosen by a committee because they made a 'unique combination' not worn elsewhere at the time.
