NOTICE OF OPPOSITION

In the matter of Application Serial No. 79/100,575, filed by Probiotec Limited (“Applicant”) on February 21, 2011, and published in the Official Gazette on May 8, 2012, Celebrity Cruises Inc. (referred to collectively with its predecessors in interest as “Opposer”), a Liberian corporation, having its principal place of business at 1050 Caribbean Way, Miami, Florida 33132, believes that it will be damaged by registration of the mark shown in that application and therefore opposes it. The time to file a Notice of Opposition has been extended to November 4, 2012.

The grounds for this opposition are:

1. Opposer is one of the world’s most well-known cruise lines.

2. Opposer operates a fleet of luxury cruise ships under the CELEBRITY brand.

3. Opposer's CELEBRITY brand is distinguished by a family of marks dominated by the term "CELEBRITY" ("Opposer's family of CELEBRITY marks"), including:

TESS database abstracts of the registrations listed above are attached to this Notice of Opposition as Exhibit A.

4. Opposer's cruise ships operating under the CELEBRITY brand and under Opposer's family of CELEBRITY marks have carried millions of passengers to destinations all over the world.

5. Opposer has invested millions of dollars to promote the worldwide recognition of its CELEBRITY brand and Opposer's family of CELEBRITY marks.

6. Opposer promotes its CELEBRITY brand and Opposer's family of CELEBRITY marks in nationwide television commercials, nationwide newspaper and magazine advertisements, internet advertisements, direct mail advertisements, and advertising brochures.

7. Opposer is renowned for the outstanding quality of the cuisine, including special, healthful dining choices, offered aboard its cruise ships operating under the CELEBRITY brand and under Opposer's family of CELEBRITY marks.

8. Passengers aboard Opposer's CELEBRITY brand cruise ships spend substantial amounts of time enjoying foods and beverages provided by Opposer, which are identical, similar, or related to the goods identified in Application Serial No. 79/100,575 ("Applicant's goods").

9. Opposer has continuously used the CELEBRITY brand and Opposer's family of CELEBRITY marks in commerce in connection with cruise ship services ("Opposer's services"), which include the provision of foods and beverages that are identical, similar, or related to Applicant's goods, from dates or constructive use dates

prior to the filing date of Application Serial No. 79/100,575, and, on information and belief, prior to any use by Applicant of the mark CELEBRITY SLIM (“Applicant’s mark”).

10. As a result of the superior quality of Opposer’s services and Opposer’s cuisine, in particular, Opposer’s CELEBRITY brand has achieved a widespread reputation for excellence and has become a household name that is synonymous with Opposer in the minds of consumers.

11. On information and belief, Applicant’s goods are likely to be sold and advertised to purchasers and prospective purchasers of Opposer’s services.

12. On information and belief, Applicant’s goods are likely to be sold and advertised in channels of trade that are the same as or similar to those in which Opposer sells and advertises its services.

13. On information and belief, consumers are likely to believe that Applicant’s goods originate from or are sponsored by, endorsed by, or connected with Opposer.

14. In view of the widespread consumer recognition of Opposer, Opposer’s CELEBRITY brand, and Opposer’s family of CELEBRITY marks, and in view of the relationship between Applicant’s goods and Opposer’s services and the similarity between the relevant consumers and channels of trade, Applicant’s use and registration of Applicant’s mark are likely to cause confusion, mistake, and deception, and are thereby likely to damage Opposer.

WHEREFORE, Opposer prays that this opposition be sustained.
