NOTICE OF OPPOSITION

Opposer IES Enterprises, Inc. (“Opposer”), a corporation existing and operating under the laws of Massachusetts, with a place of business at 300 Park Avenue, New York, New York 10022, believes that it will be damaged by registration of the mark SOFFISOF applied for in Application Serial No. 85/405,118 for all identified goods in International Classes 3 and 5 (the “Opposed Classes”) and hereby opposes same. As grounds for the opposition, Opposer, through its attorneys, Fross Zelnick Lehrman & Zissu, P.C., alleges as follows:

1. Four more than four decades Opposer and its predecessors in interest (collectively, “Opposer”) have used, and Opposer is currently using, the SOFTSOAP mark and various SOFTSOAP-inclusive marks (collectively, “Opposer’s Mark”) in connection with personal care products, including, without limitation, body and skin cleansers.

2. As a result of its reputation, use, substantial sales success, and extensive advertising, the SOFTSOAP mark has become and is exclusively identified with Opposer and Opposer’s goods and is among the most famous marks for personal care products in the United

States. As such, the SOFTSOAP Mark represents enormous goodwill and is an extremely valuable asset of Opposer.

3. Opposer owns numerous federal registrations for Opposer's Mark, including, without limitation, U.S. Reg. No. 1,457,886 for "liquid hand soap in a pump-type dispenser" in International Class 3, based on first use in November 1977, and U.S. Reg. No. 2,098,824 for "personal care products, namely, liquid skin soap" in International Class 3 based on first use in October 1975 (collectively, "Opposer's Registrations"). True and correct copies of printouts from the TSDR database of the United States Patent and Trademark Office showing the current status and title of Opposer's Registrations are attached hereto as **Exhibit A**.

4. Opposer's Registrations are valid, subsisting, in full force and effect and incontestable pursuant to Section 15 of the Lanham Act, 15 U.S.C. § 1065. Opposer's Registrations thereby serve as *conclusive* evidence of Opposer's exclusive right to use Opposer's Mark in connection with the goods identified in the subject registrations pursuant to Section 33(b) of the Lanham Act, 15 U.S.C. § 1115(b).

5. Upon information and belief, Applicant SILC S.P.A. ("Applicant") has a place of business at Strada Provinciale 35, Km. 4, Trescore Cremasco (Cremona) Italy 26017.

6. On August 23, 2011, Applicant filed Application Serial number 85/405,118 (the "Application") seeking to register the mark SOFFISOF ("Applicant's Mark") for various identified goods in the Opposed Classes, among other identified goods in other International Classes, based on its ownership of a foreign registration for the mark under Section 44(e) of the Trademark Act, 15 U.S.C. § 1126(e).

7. Upon information and belief; Applicant has not begun use of Applicant's Mark in United States commerce.

8. The filing date of the Application and Applicant's date of first use (if any) of Applicant's Mark in United States commerce are long after Opposer's first use of Opposer's Mark in United States commerce, long after the priority dates of Opposer's Registrations, and long after Opposer's Mark became distinctive and famous in the United States.

9. Applicant's Mark is highly similar to Opposer's Mark in sight, sound and commercial impression.

10. Applicant's Mark so resembles Opposer's Mark as to be likely, when applied to Applicant's goods in the Opposed Classes, to cause confusion or to cause mistake or to deceive, in violation of 15 U.S.C. § 1052(d).

11. Registration of Applicant's Mark for Applicant's goods in the Opposed Classes would be inconsistent with Opposer's exclusive right to use Opposer's Mark and would substantially damage Opposer's investment and goodwill in Opposer's Mark.

12. Applicant's use and registration of Applicant's Mark for Applicant's goods in the Opposed Classes is likely to dilute the distinctive quality of Opposer's Mark.

13. Any use or registration by Applicant of Applicant's Mark for Applicant's goods in the Opposed Classes would violate Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c).

14. By reason of the foregoing, Opposer will be injured by registration of Applicant's Mark for goods in the Opposed Classes.

WHEREFORE, Opposer respectfully prays that this opposition be sustained and that the Application be denied for goods in the Opposed Classes.


