NOTICE OF OPPOSITION

This Notice of Opposition is submitted in the matter of Application Serial No. 85/716,419 for registration by Gail A. Halim (d/b/a Gail's Tobacco & Gas Outlet) of the term TOPANGA based upon its intent to use that term in connection with "smokers articles, namely cigarettes, cigars and pipe tobacco," in International Class 34, which was published for opposition in the Official Gazette on February 5, 2013. Top Tobacco L.P., a Delaware limited partnership, having a place of business at 2301 Ravine Way, Glenview, Illinois 60025, believes that it would be damaged by the registration and therefore opposes the same.

The grounds for Opposition herein are as follows:

1. For many years, and long before the acts of Applicant alleged herein, Top Tobacco, including its predecessors and affiliates ("Top Tobacco"), has been engaged, *inter alia*, in the manufacture, distribution and sale of smokers' articles, including tobacco, cigarette rolling papers, cigarette filters, cigarette tubes, and cigarette rolling, injector and making machines, which are distributed throughout the United States through tobacco shops, drugstores, tobacco outlets, convenience and other retail stores.

2. For many years, and long prior to the acts of Applicant alleged herein, Top Tobacco has distributed and sold, and continues to distribute and sell tobacco, cigarette rolling papers, cigarette filters, cigarette tubes, and cigarette rolling, injector and making machines under and in connection with the trademark TOP.

3. Top Tobacco has devoted substantial resources, time and effort in developing, marketing and distributing such goods under its TOP mark. As a result of Top Tobacco's consistent efforts to promote and protect its TOP mark, Top Tobacco has developed considerable recognition and goodwill in the TOP mark, which is now widely recognized as signifying Top Tobacco and its goods.

4. The TOP mark is now among Top Tobacco's most valuable assets. To protect its rights in the mark, Top Tobacco has obtained the following federal registrations for the TOP, TOP and Design, and TOP-O-MATIC marks for use in connection with tobacco, cigarette rolling papers, cigarette filters, cigarette tubes, and cigarette rolling, injector and making machines, some of which are incontestable pursuant to 15 U.S.C. § 1065:

5. On August 29, 2012, long after Top Tobacco began use of its TOP mark, Applicant filed an application to register the term TOPANGA based upon its intent to use the term in connection with “smokers articles, namely cigarettes, cigars and pipe tobacco,” Serial No. 85/716,419.

6. The TOPANGA mark that Applicant seeks to register is confusingly similar to Top Tobacco’s TOP mark. As a result of the similarity of the parties’ marks, the similarity of the goods associated with the marks, and the strength of Top Tobacco’s TOP mark, Applicant’s use and registration of the TOPANGA mark is likely to cause confusion or mistake, or to deceive purchasers, in that purchasers would be likely to believe that Applicant’s goods are Top Tobacco’s goods, or are in some way legitimately connected with, sponsored by, or approved by Top Tobacco in violation of 15 U.S.C. § 1052(d). Applicant’s registration of the term TOPANGA would, therefore damage Top Tobacco, and on that basis, Top Tobacco opposes registration of the mark by Applicant.

WHEREFORE, Top Tobacco requests that the registration sought by Applicant be refused and that this Notice of Opposition be sustained.
