NOTICE OF OPPOSITION

In the matter of Trademark Application Serial No. 85/538,424 for the mark "ZIGGY BRONZE" filed February 9, 2012 and published for opposition in the Official Gazette on November 27, 2012.

ZIGI Enterprises, Inc., a New York company having a place of business at 647 Broadway, New York, New York 10012 ("Opposer"), believes that it will be damaged by the registration of the mark shown in the above-identified application for the goods in International Class 25 and hereby opposes the same. The grounds for opposition are as follows:

1. Sophia Shoen ("Applicant"), seeks to register ZIGGY BRONZE as a trademark for clothing for , athletic apparel, namely, shirts, pants, jackets, footwear, hats and caps, beach footwear; beach shoes; bustiers; camisoles; canvas shoes; capri pants; capris; cardigans; chemises; flip flops; footwear for women; jeggings, namely, pants that are partially jeans and partially leggings; knit skirts; ladies' underwear; leg warmers; leggings; lingerie; negligees; nightdresses; panties; sandals; sweaters; women's hats and hoods; women's tops, namely, camis;

woven tops; *inter alia*, in International Class 25 as evidenced by the publication of the mark in the Official Gazette on November 27, 2012.

2. The application herein opposed was filed February 9, 2012 on the basis of intent to use. Applicant claims no date earlier than February 9, 2012 for the purpose of priority.

3. Opposer is and has been engaged in the development, manufacture and sale of apparel and accessories for women and girls, including but not limited to footwear, and has built a successful business in connection therewith.

4. Since at least as early as March 27, 2006 Opposer has used ZIGI as a mark, as a trade name, and as the dominant element of other names and marks, namely ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO, for apparel and accessories for women and girls.

5. The nature and extent of Opposer's use of its ZIGI, ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks and names can be seen at its website, www.ziginny.com.

6. Opposer has taken steps to protect its ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks and has secured U.S. Trademark Registration Nos. 3,551,999; 4,247,778; 3,524,686; and 3,619,783 for such marks for apparel and accessories for girls and women as identified therein. Registrations No. 3,551,999; 4,247,778; 3,524,686; and 3,619,783 are valid and subsisting. A copy of the pertinent information about such registrations from the PTO database is attached as Exhibit A.

7. Opposer has for more than six (6) years continuously used its ZIGI marks and names in connection with its products and business, including its on-line sales of its products.

8. By virtue of Opposer's continuous use in commerce of its registered ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks, and of its ZIGI trade names, and the nature and extent of such use, such goods and business have become favorably known to the relevant trade and public under such marks and names, and identify the goods and business of Opposer.

9. Opposer's registered trademarks ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO and Opposer's ZIGI trade names are inherently distinctive as applied to Opposer's products and business, including its on-line sales of its products.

10. Use of the ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks and names by Opposer has been continuous and commercially significant.

11. As Opposer is the owner of valid, subsisting U.S. trademark registrations for ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO, priority is not in issue.

12. In the application herein opposed, there are no restrictions on trade channels, so it must be presumed that the goods identified in the application, including footwear, will travel through all trade channels appropriate for such goods.

13. Applicant's mark is confusingly similar to Opposer's registered ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO registered trademarks and trade names.

14. Applicant's ZIGGY BRONZE mark and Opposer's ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks and names are closely similar, as both employ the phonetically identical terms ZIGGY and ZIGI as their first and dominant element. The addition of the second term, "BRONZE", to Applicant's mark does not obviate the likelihood of confusion but aggravates it, as the marks ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO consist of a similar pattern of the dominant term "ZIGI" followed by only one other term.

15. The goods listed in the application which is the subject of this opposition are closely related to, and at least in part essentially identical to, the women's and girls' apparel and accessories sold by Opposer under its registered ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO marks and names and to the retail sales by Opposer through its website.

16. Apparel and accessories for women and girls, including footwear, such as are sold by Opposer and such as are identified in the application herein opposed are customarily marketed through overlapping channels of trade to overlapping classes of purchasers.

17. Applicant's ZIGGY BRONZE trademark as applied to the goods identified in the application herein opposed so resembles Opposer's registered ZIGINY, ZIGI NY, ZIGIGIRL and ZIGISOHO trademarks and trade names that it is likely to cause confusion, mistake, and/or deception as to source or sponsorship or affiliation.

18. If Applicant is permitted to register ZIGGY BRONZE as a mark for the goods set forth in the application herein opposed, confusion of the relevant trade and public is likely to result, which will damage and injure Opposer.

19. On seeing Applicant's ZIGGY BRONZE mark used in connection with Applicant's goods, such as footwear, purchasers and potential purchasers are likely to believe in error that such goods are offered by or in association with Opposer or that Opposer and Applicant are affiliated.


20. Any defect, objection to, or fault found with Applicant's goods sold under the mark ZIGGY BRONZE would reflect on and injure the reputation that Opposer has established for its goods and business.

21. If Applicant is granted a registration for the mark herein opposed for the goods in International Class 25, she would obtain thereby at least a *prima facie* exclusive right to use the mark for such goods as are identified in the registration. Such registration would be a source of damage and injury to Opposer.

WHEREFORE, ZIGI Enterprises, Inc. prays that registration of the mark of Application Serial No. 85/538,424 for the goods in International Class 25 be refused and that this opposition be sustained.
